Following up on our conversation, you requested that Ascension to consider extending public parking availability at the Prospect Medical Commons parking garage. With the understanding that Ascension Medical Group clinics do offer extended appointments and urgent/walk in care until 7pm on weeknights, Ascension is willing to make public parking available between the hours of 5:00 pm and 6:30 am Monday through Friday at the Prospect Medical Commons Parking Garage. All three parties on the phone agreed that the extension could be reevaluated if public access created safety concerns or limited the ability of patients to access the lot for patient care purposes. We appreciate that the BID offered to have it be a temporary extension and Ascension is open to discussing that further as we negotiate a formal agreement. We are hopeful that the extended hours will benefit the local businesses while supporting our patients. Ascension sincerely appreciates the acknowledgement from all parties that safety is a priority and the openness to reevaluate the hours if needed. As a good-faith effort, Ascension will request that our facilities team take the steps necessary to update the electronic sign by June 17. In the event we encounter any issues that limit our ability to make the updates, we will provide an update to both of you.

You also shared a request to relocate existing vinyl signage and increase signage for the public parking. Ascension shares your desire for a vibrant and thriving business district near the hospital. To support access to the business district, Ascension's facility team will review the following:

1. Is there an ability to move the current vinyl signage to a more visible position and

2. Additional signage options to increase awareness.

Our facilities team will provide an update by June 17, 2020.

During the call, the BID and Ascension agreed to work collaboratively towards formalizing our mutual agreements in writing because prior agreements have expired. Ascension and the BID further agreed to discuss and negotiate, as part of the terms of a final agreement, potential cost sharing methods for additional signage. The BID will take the lead on creating the first draft of the agreement which will ultimately be negotiated between legal counsel for Ascension and the BID.
