1. On 12/15/2005 at 10:50 PM, P.O. Edmond and P.A. Woods (20 yrs old), entered the Gare-Bear's Tavern located at 927 N. 27th St. Pa Woods ordered 2 Miller Genuine draft beers from the Bartender on duty. Pa Woods was served w/o the bartender asking for proof of age. The Bartender was identified as B/M DANCY, Eddie M. (10/31/1958). Bartender was cited for Sale to Underage Person. Bartender stated he did not asked for ID, because "He Looked old enough."

2. On 04/10/08 at 12:52 am, Milwaukee police conducted a tavern check at 927 N 27th Street. Officers spoke to Corre Blount who was bartending. Blount was found not to have a bartenders license and stated he was working under the direction of another bartender, Harold Jenkins, who was licensed. Officers spoke with Jenkins and found his license was expired. Blount received a citation for Class D License Required and a routine wanted check revealed Jenkins had an outstanding warrant. Jenkins was placed into custody. The licensee Gary Lieske was not scene at the time of the violation but appeared in the tavern while officers were investigating. Police advised Lieske of the violations and cited Lieske for Class B Licensee's Responsibility.

3. On 05/10/08 at 2:00 pm, Milwaukee police were dispatched to 927 N 27th Street for a Reckless Use complaint. Officers spoke to Gary Lieske who stated he had video surveillance of a subject who had discharged a handgun at 913 N 27th Street sometime after closing. Lieske advised officers that there were no problems in the tavern and that he would provide a copy of the video when he was able to download it. A report was filed.

4. On 05/28/09 at 2:55 pm, Milwaukee police were conducting Sales of Alcohol To Underage Persons and had a police aide who is under the age of 21 enter 927 N 27th Street in attempts to purchase alcohol. The bartender Joan Cross served the aide two beers without asking for any ID. The licensee Gary Lieske was issued a citation for Sale of Alcohol To Underage Person.

5. On 08/18/2013 Officers went to the business Gare-Bear's at 927 N 27th St and contacted the applicant regarding Secondhand Dealer Notification. The applicant was given a copy of MCO chapter 92 regarding Secondhand Dealers. He signed an acknowledgement.

- 6. On 03/26/2014 at 2:10am Officers responded to Gare-Bears at 927 N. 27th St for a Battery Complaint. The investigation revealed the caller, Brian PETERSON, went into the tavern after last call and got upset that he could not get served alcohol. The bartender, Coree BLOUNT, asked PETERSON to leave and was walking to the door when PETERSON struck him to the face in an unprovoked attack. A physical altercation ensued until BLOUNT and several patrons were able to get PETERSON out of the bar. The applicant was on scene and provided the video tape of the incident, which confirmed the statement of the bartender. Battery report #14-085-0015 was filed but BLOUNT did not wish to prosecute.
- 7. On 09/13/2015 Milwaukee police investigated a battery/cutting at 927 North 27th Street (Gare Bear's). Video from the business indicates the victim of this offense was involved in an argument inside the bar. The argument continued outside, where the victim attempted to punch his assailant and both parties appear to arm themselves with pieces of broken glass they pick up from the ground. The victim received lacerations on his torso which required 33 stitches to close. Milwaukee police incident report #152560020 filed.
- 8. On 10/27/2017 Milwaukee police responded to a sick/injured person at 927 North 27th Street (Gare Bear's Tavern). Investigation revealed a patron of the bar was almost falling out of his chair and his head would go from side to side and front to back. This behavior occurred after the patron returned from using the bathroom, prompting the caller to believe the patron was on drugs. The officer discovered the patrons head would go limp and wobble from side to side. When the officer asked the patron if he had taken any drugs and how much he had to drink, the patron would return a blank stare and his head would fall limply forward. The patron was conveyed by ambulance to Mt. Sinai hospital where it was discovered his blood alcohol concentration was .285. Milwaukee police incident report #163010123 filed.
- 9. On 12/15/2017 officers were dispatched to a subject with gun complaint at Gare Bears, 927 N. 27th St. The officers received an update prior to arrival the call was a false alarm and there was no problem at the bar. They interviewed the maintenance man, Coree BLOUNT, who stated he did observe two subjects, who had been in the bar, arguing outside but no gun was observed. The officers did not locate the subjects.
- 10.On 01/22/2018 officers were dispatched to a shooting at Gare Bears, 927 N. 27th St. The officers found a subject lying on the sidewalk with a gunshot wound to the chest. The officers and MFD performed lifesaving measures but the subject was pronounced dead on the scene. The video surveillance showed the suspect exit the premises to smoke a cigarette. Outside the suspect bumped into the victim and after an argument he produced a handgun and shot the victim. The suspect then fled in his auto.
- 11. On 02/12/2018 at 9:02pm officers were dispatched to a subject with gun complaint at Gare Bears, 927 N. 27th St. The bartender, Luis RIOS, stated he let a subject, Isadore JEFFERSON, sit in the bar to "warm up". He did not serve him since he already appeared intoxicated. Later a replacement bartender asked JEFFERSON to make a purchase or leave the premise. JEFFERSON then threatened to "pop" the bartender and stated he had a gun in his backpack. No gun was found on JEFFERSON.

- 12. On 02/25/2018 officers were dispatched to a battery complaint at Gare Bears, 927 N. 27th St. The victim reported she was assaulted by her ex-boyfriend who was no longer on scene. While the officers checked the area the applicant called 911 to report a subject causing a disturbance. The officers returned and spoke with the applicant who stated a different subject who had been kicked out had returned and was refusing to leave. The applicant gave the subject a pizza to leave.
- 13. On 04/23/2018 a meeting was held regarding Gare Bear's. The applicant stated he will take action in abating the problems that occurred by posting No Loitering signs, No Weapons signs, and all Persons subject to search signs. He also stated he will have security posted at the door on Fridays and Saturdays by 04/28/2018.
- 14. On 04/28/2018 an officer went to Gare Bear's, 927 N. 27TH St, to conduct a licensed premise check. The officer found security at the door wanding patrons as they can in the tavern. The bartender stated security was just hired and checks every patron for weapons.
- 15. On 09/01/2019 at 12:32am officers were dispatched to a battery complaint at N. 26th St and W. Highland Bl. The officers located a subject who had been stabbed. The victim stated he was at Gare-Bears, 927 N. 27th St, when an argument started inside over missing money. The bar told all parties to leave the location. Once outside the fight continued in the parking lot of the Family Dollar. One of the subjects produced a kitchen knife and stabbed the victim on the right side. The subject fled on foot. The officers went to Gare-Bears and spoke with the bartender, who stated he was the only one working and did not see anything. The bartender stated the applicant was the only person that could access the video system. The officer spoke with the applicant by phone and he stated he could not come to the bar that night but an officer could come in the morning to view the video.
- 16. On 09/01/2019 at 8:19pm officers were dispatched to a Trouble with Subject call at Gare-Bears, 927 N. 27th St. The officers spoke with the applicant who stated there was an unknown subject kicking his door. The applicant pointed out the subject who was standing down the street. The officers attempted to speak to the subject but found he was deaf. The subject left with his brother and was told to not return.
- 17. On 12/23/2019 at 12:22am officers were dispatched to Gare-Bears, 927 N. 27th St, for a subject with gun call. The officers spoke with the security guard, who stated a female came in and had a gun held at her side. He stated he had kicked this female out last week and she came back and threatened to kill him. The subject left in a vehicle prior to the arrival of the police.
- 18.On 03/17/2020 at 12:34am officers conducted a licensed premise check at Gare-Bears, 927 N. 27th St., regarding the recently announced emergency closure order. The staff stated they understood the rules and no violations were observed.

This report is being written by PO Justin YOUNG assigned to District 3, Late Shift.

On Sunday, September 01, 2019 at 12:32 AM Squad 3441 (PO Taylor ZUBE and I in full MPD uniform and operating a marked MPD squad) was dispatched to N. 26th St. and W. Highland Blvd., located in the City and County of Milwaukee, to investigate a battery cutting.

Victim, later identified as Pierre WARREN (b/m, 08-22-64), was located on the south side of W. Highland Blvd. approximately 75 feet west of N. 26th St. laying on a small grass covered hill south of the sidewalk. The area was lighted by City of Milwaukee street lights. The area next to where the WARREN was laying is a parking lot. I observed WARREN laying on his back holding his right side where he had been stabbed. I observed several witnesses with WARREN.

I spoke to Efrem D. SANDERS (b/m, 11-22-60) who stated he had been at Gare-Bear's, 927 N. 27th St., located in the City and County of Milwaukee, with his girlfriend, Kathy WILDER (b/f, 06-06-68). SANDERS stated WARREN and the suspect, later identified as Craig WILLIAMS (b/m, 04-24-61), were also at the bar. SANDERS stated they were sitting near the middle of the bar. SANDERS stated at one point he had to use the restroom so he got up and left the area where WILDER was sitting. SANDERS stated when he returned he discovered that while he was away WILLIAMS had accused WILDER of stealing some of his money off the bar. SANDERS stated WILLIAMS had grabbed WILDER's collar when he accused her. SANDERS stated he and WILLIAMS had a verbal argument inside the bar about what WILLIAMS had done to WILDER. SANDERS stated that WARREN became involved in the argument while inside the bar.

SANDERS stated the bar staff told them to leave the location. SANDERS stated WARREN, WILLIAMS, WILDER and he went outside the location where the argument continued. SANDERS stated WILLIAMS broke WARREN's glasses while they were outside the bar. SANDERS stated the bar staff told the group they needed to "move around" due to the incident. SANDERS stated they walked across the street to the parking lot of the Family Dollar, 930 N. 27th St. and continued with the altercation. SANDERS stated during the altercation WARREN got in between him and WILLIAMS. SANDERS stated he observed WILLIAMS pull a silver kitchen knife out of the front of his pants. SANDERS described the knife as silver, approximately 8 inches long. SANDERS stated WARREN then turned and told him that he had been stabbed.

SANDERS stated after WILLIAMS stabbed WARREN, WILLIAMS fled the area on foot N/B on N. 27th St., then turn and go E/B on W. Highland Blvd. SANDERS stated he did not see where WILLIAMS went after he turned E/B.

I made contact with the bartender working, Eddie M. DARCY (B/M, 10/31/1958). DARCY stated he was the only one working inside the bar during the time of the incident, but stated he did not see anything. I observed a camera outside the business that covers N 27th St going southbound. DARCY stated he does not have access to the surveillance systems and stated that the owner, Gary LIESKE (W/M, 07/07/1956) only had access. DARCY contacted LIESKE by phone and I spoke to LIESKE. LIESKE stated that he could not return to the business due to the fact that he had no transportation and that his vehicle was at the back of the bar. I advised LIESKE that it was imperative that he come back to the location so that I can view video regarding the Battery Cutting call for service. LIESKE advised me that he cannot return to the bar, and that he advised me that police can come back to the morning to recover video.

This ends my report.

Upon arrival, Gary L. LIESKE (w/m, 07/07/1956), owner of Garebears, stated an unknown b/m, was kicking the door of the establishment during business hours. LIESKE described the subject as a b/m, wearing blue jeans, no shirt, and a red headband. LIESKE pointed at a male that was standing near a closed location at 949 N. 27th Street, City and County of Milwaukee. LIESKE stated he had rib (side chest) pain from holding the door shut and the subject kicking at the door. No damage was noted to the door and LIESKE refused medical attention.

The subject was identified as Orlandis R. HAYWOOD (b/m, 07/06/1989) by his Wisconsin issued Identification Card. A language issue was present as HAYWOOD is deaf. HAYWOOD left the location with his brother and was told not to return.

On Monday, December 23,2019 at 12:25AM, Squad 3465, myself and PO Devin WHITFIELD were dispatched to **Gare-Bear's**, a tavern, located at 927 N 27th St in the City and County of Milwaukee, Wisconsin.

Upon our arrival we spoke with Gare-Bear's security officer, Erik L WESTBROOKS (b/m 09-19-64) who stated at approximately 12:20AM, a female entered the front door of Gare-Bear's and displayed a handgun and held it out at her side. WESTBROOKS recognized her and stated he kicked her out of the tavern a week prior and that she was still upset about it. WESTBROOKS stated the female told him she wanted to shoot him. WESTBROOKS stated he did not know the female's personal information. WESTBROOKS stated the female drove away in a white Dodge Intrepid.

WESTBROOKS described the suspect as a black female, late 30s-early 40s, 5'5", 240 lbs, heavy build, with shoulder length hair. WESTBROOKS stated the suspect was wearing a silver jacket and black pants. WESTBROOKS stated she was armed with a small, black, semi-automatic handgun.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 6/18/2020 at 1:50 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
