This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/21/2018 officers were dispatched to a battery at Lucky Sam Food Mart, 2401 N. 21st St. The applicant was the caller and stated a subject was in the store causing a disturbance and breaking things. The subject was located and issued citations for Disorderly Conduct and Vandalism.

2. On 10/17/2019 officers were dispatched to Mark Food Mart, 2401 N. 21st St, for a Property Damage. The investigation revealed a female patron was upset with a recent transaction. The female began knocking over displays causing a disturbance. The female was not on scene and could not be located.
3. On 03/20/2020 officers, along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at Lucky Sam Food Mart, 2401 N. 21st. There were two employees on scene when officers arrived. Neither employee had a Class D Operator's license and the business is licensed to sell alcohol. The officers found an open package of cigarettes behind the counter. The clerk initially denied selling single cigarettes but did admit selling singles for \$0.50. The officers also located items for sale that are used as drug paraphernalia. The applicant arrived at the location and was asked about the drug paraphernalia. He apologized for selling the items. The applicant did not have any invoices for the tobacco at the location. He admitted to buying it from someone in Illinois for under wholesale cost. The officers located beer stored in the basement, which is not listed on the

liquor license. The applicant was advised to move the beer to the licensed area of the business or add the basement as a storage location. The applicant was advised of complaints of people loitering in front of his store selling drugs. The applicant stated he does not call the police, he just asks the subjects to leave on his own.

4. On 03/23/2020 at 12:19pm officers responded to Lucky Sam's, 2401 N. 21st St. for a Drug Dealing complaint. There were multiple subjects outside when police arrived, but they immediately walked off. The officers spoke with the applicant, who stated he does not know why the officers are getting called and would contact police if he saw anything. He advised the officers they were welcome to view the cameras at any time.
5. On 03/24/2020 at 1:20pm officers, along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at Lucky Sam Food Mart, 2401 N. 21st. The Wisconsin Department of Revenue agent advised the applicant that due to him not cooperating with the investigation regarding the subject from Illinois that he purchased the tobacco from, she was confiscating all the untaxed tobacco from the store. The subject was issued the Responsible Person on Premise citation from item #2.
6. On 03/29/2020 at 5:36pm officers were dispatched to a shooting at 2513 N. 21st St. During the investigation officers went to Lucky Sam Food Mart, 2401 N. 21st St to check for video surveillance. The officers were able to view the video which did capture the incident.
7. On Monday, May 26, 2020, at approximately 11:36 PM, officers were dispatched STOIBER, was dispatched to a shooting, located at 2409 N 21st St. Upon arrival they observed a black male laying on his side against fence at 2409 N 21st St. This scene was located approximately six feet north of Lucky Sam Food Mart located at 2401 N 21st St, a premise licensed for the sale of tobacco, Class A fermented malt beverages, and food. This business was closed at the time of the shooting.

This report was written by Police Officer Dorian WHITTENBERGER, assigned to District Three Community Prosecution Unit - Early Power Shift.

On Friday, March 20, 2020, Squad 3274 (PO Melvin FINKLEY) and 3271 (myself) were wearing our department issued Milwaukee Police Department uniforms with our badges and names affixed to our outermost garments, while operating an unmarked Milwaukee Police Department squad (#803) with working red and blue lights and sirens. My partner and I were equipped with body worn cameras.

On this aforementioned date at approximately 11:35AM, PO Finkley and I assisted in a site visit with Department of Revenue Agent Georgeann KING at 2401 N 21st St (Lucky Sam Food Mart), in the City and County of Milwaukee. During this site visit the agent of the location, Sukhdev SINGH (m/w, 09/16/91), arrived on premise. The store was closed during the time of the site visit.

When first arriving to the location, several people from in front of the store dispersed upon police arrival. One person entered the location, did not buy any items, and left immediately. Employees at the location consisted of only Ranjit SINGH (m/w, 12/02/57), who was behind the cash register, and Gandha SINGH (m/w, 10/05/75), who was stocking items. R.Singh was notified that the store was to be closed and that a license premise check was going to be conducted. There was bit of a language barrier, but R.Singh stated he was going to call the owner, who was his son. At the initial time of entering the location, R.Singh and G.Singh were the only employees on scene. Neither employee has a bartender license. The store was still being operated to sell alcoholic beverages. It should be noted that the owner was made aware.

During the initial part of the site visit, R.Singh was asked multiple times if there was any weapons in the location of the cash register. R.Singh stated there was not. While KING was attempting to locate any invoices, she observed a black Smith and Wesson 45cal hand gun (Serial# NBB3548). R.Singh stated it was there for safety and was owned by his son, S.Singh (who is the owner). It was later determined that the firearm was owned and registered to S.Singh's wife, Parminder KAUR (f/w, 03/19/88).

There were cigarette boxes behind the cash register with several cigarettes missing. R.Singh initially denied single cigarette sales. Once asked again by KING, R.Singh admitted that he sells

single cigarettes at 50cents a piece. R.Singh was notified that this was illegal. When S.Singh arrived, he continued to deny any single cigarette sales.

Located in the area behind the cash register was a shelf area that had a large amount of money in rubber bands with denominations including 10s, 20s, and 100s in US Currency. Near the money in the shelving area, was a large amount of copper chore boy and 4 inch glass pipe tubes (with filters in them). These items are consistent with drug paraphernalia. When S.Singh arrived on scene, we was asked about these items. S.Singh was not able to answer questions as to why they sell the items. S.Singh stated he was aware that crack users use these items. S.Singh stated he was sorry for selling it. Also located behind the cash register was clear plastic baggies, razor blades, and boxes of grinders. These items are also consistent with illegal activity.

In one cash register on the premise, blank checks were located in the prior owner's name. The checks had the name and account number. Each check was pre-dated for April, May, June, July, and August. S.Singh stated that he did a personal finance through the old owner and pays him \$3,500 a month for his loan to own the business.

When conducting the walk-through of the location, located in the basement was stored beer cases. This was a violation due to the basement not being covered as part of the premise for the license. S.Singh was notified that he would have to either include the basement for the license or move the storage of the beer cases.

When conducting her investigation, KING is required to see invoices for tobacco and alcohol. S.Singh had no invoices on scene for his tobacco purchases. S.Singh admitted to KING that he purchases his cigars from a man from Illinois that he only knows as "Cigar man" (ph# 630-788-4114). S.Singh had contact information for "Cigar man" but no other information. S.Singh stated he went through this man because the whole sale price is over \$10 less. S.Singh was informed that he was not allowed to conduct business in this manner.

S.Singh was notified that we received complaints about illegal drug trafficking occurring at this location. S.Singh stated he was aware that drug dealers and drug users frequent the area and loiter in and around his store. S.Singh stated he doesn't call police and just asks people on his own to leave. S.Singh was notified of the issues that this is creating in the neighborhood around his store.

On Monday, March 23rd, 2020 at 12:19pm I, Squad 3130, along with Police Officer Greg Byers, responded to a Drug Dealing complaint at the Lucky Sam's located at 2401 N. 21st street, which was located within the City and County of Milwaukee. P.O. Byers and I were sent there regarding a citizen observing multiple unknown subjects standing in front of the location and dealing drugs. The caller stated that vehicles would pull up and do a drug transaction and then drive off.

Interview of SINGH:

Upon arrival P.O. Byers and I observed multiple subjects standing in front of the location. As soon as we arrived the subjects walked away from the establishment. No drugs or illegal activity was observed.

I then walked inside the establishment and spoke with the owner, **Sukhdev SINGH, I/M, 9-16-91**. SINGH stated that he does not know anything in regards to drug dealing and that he would contact police if he saw or heard anything. SINGH stated that police are always welcome to view his cameras and that he does not know why the police keep getting called to his business. This concluded the interview.

SINGH was given a contact community card and advised to contact police if any illegal activity becomes known.
