There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The victim stated he did not want the Police called. The clerk observed some blood on the victim's elbow, and observed him change his clothes outside on the side of the store. The victim then left the area. The officer spoke to the manager, who had to get the owners phone in order to watch the video. The employees were cooperative with the officers. No victim was located.

LICENSE PREMISE REPORT

Horst, Seth W 029430

This report was written by P.O. Seth HORST, assigned to District 4, Early Shift.

I was directed by Sgt Gregory HUNTER, to write this memo regarding our investigation of a possible shooting, with no known victim or suspect.

On Monday, April 6th, 2020, at approximately 4:14 p.m., Squad 4230 (P.O. Seth HORST and P.O. Ryan WEBB) responded to 3824 W Florist Av, located in the City and County of Milwaukee, Wisconsin for a Shooting Complaint. This investigation was conducted by officers in a marked squad car, wearing full duty uniform and had body worn cameras activated.

Squad 4210 (Sgt FEDERER) responded to the scene. Squad 4290 (Elizabeth STROZINSKY) and Squad 4234 (Parker POPP) assisted in the investigation by checking the area and performed a canvass. See their supplemental reports regarding.

Upon arrival, we met with the caller/employee of Home Run Foods, Nasir Y. THABATA (m/w 03-15-82) who stated that at approximately 3:50 p.m. a male subject walked into the business and stated to him that he had been robbed, shot and had a bullet in his arm. The victim also stated to THABATA that he was in trouble. THABATA asked him if he wanted to call the police and the victim stated "no" multiple times. THABATA stated that the victim then purchased a cigar from him and used cash. THABATA stated that while the victim was waiting in line, he was asking other customers for money for the purchase and received money from 2 customers. THABATA stated that he observed some blood on the victim's left elbow.

THABATA stated that after this, the victim walked to the north east corner of the store and changed his clothing, using items in his back pack and placing his previous clothing in his back pack. THABATA stated to the victim that he could not be taking his clothing in the store. THABATA stated that the victim left the business and fled westbound on W Florist Av.

THABATA described the victim as a black male, 23 years old, approximately 6'0" tall, 250 lbs, heavy build, clean shaven face, buzz cut hair style with an unknown tattoo on his left forearm. The victim was last seen wearing a black leather jacket and blue track pants. THABATA stated that the victim had his left sleeve rolled up, and had a black t-shirt wrapped around his left elbow area and had a black back pack on. THABATA stated that he observed blood on the area, but could not see the wound. THABATA stated that the victim also had blood on his face and mouth area and appeared to have been in a physical altercation.

I met with the manager at the location, Husam N. AWAWDA (m/w 11-29-79) who advised that he is currently able to access the video, but they do not have cameras of the interior and exterior of the building. AWAWDA drove down to the owner's residence in Franklin, WI to obtain his cellphone with the password for the security system. Owner, Frank A. ABDALLAH (m/w 09-15-52) and employees were all very cooperative with the investigation, though ability to playback security footage was lacking.

Officers did not observe any visible injury or blood on the victim's arms and it did not appear that the victim was frantic or moving around at all. Officers observed the victim make a purchase and then walk off camera. This was on Camera 13 at approximately 15:56:00 per the camera time.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 6/23/2020 at 3:15 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


