On Wednesday, June 12, 2019, at 9:23 p.m. sqd. 4420 (P.O. CAPELLE and I) was dispatched to assist in a shooting complaint that occurred at 9026 W. Brown Deer Rd. (BP gas station).

Squads dispatched to 9220 N 75th St for a Shooting Complaint which occurred at the gas station, 9026 W Brown Deer Rd. All VICs are in VIC VEH, stop at gas station to buy a beverage for the child (VIC 3); VIC 1 & VIC 3 remain in vehicle while VIC 2 goes into gas station. SUS 2 followed VIC 2 into the station. As he (VIC 2) returns to vehicle SUS 1 approached him holding a black pistol w/ extended magazine and stated "Give me everything you got"; obtains undetermined amount of cash. SUS 1 attempted to enter vehicle after VIC 2. VIC 2 put car in gear, drove in reverse and then drives forward, striking SUS 1. As VIC VEH is leaving SUS 1 fires into vehicle striking VIC 1 in the left foot. VIC 2 drives to his mother's residence (9220 N 75th St).

On Saturday, November 30, 2019 at 9:25 a.m. I was dispatched to 9026 West Brown Deer Road for a shoplifting complaint. Upon arrival, I spoke to the store manager who identified herself as Cheri L JORDAN (W/F, 04-5-62). JORDAN stated an unknown subject walked into the gas station on Friday, November 29, 2019 at 11:14 p.m. and intentionally stole the listed items off the shelves without consent.

JORDAN stated she was not working when the theft occurred, but she observed the incident on video. JORDAN stated she does not know the subject's name, but he does come in the gas station frequently. I observed the subject on video removing items off the shelves and putting the items inside of his jeans. The subject is described as a black male, 5'10, 150 lbs, light skinned, long dreadlocks wearing a black coat, black jeans, and black sneakers. I observed the subject on video in the store for about 15 minutes before he exited the gas station and walked westbound towards 91st Street. I advised JORDAN if the subject comes back to the gas station to call the police.

Forensic investigator Sylvia GERASCH (Squad 1722) downloaded the video and placed it on inventory.



The hearing before the Licenses Committee will take place virtually on 6/23/2020 at 9:30 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
