Dear Mr. Bauman,

I noted in the news that the alderwoman from Bay View, Marina Dimitrijevic, is proposing an ordinance requiring the wearing of face masks in public places like stores, restaurants, bars, buses, parks and trails. I also noted that the Mayor supports this.

While I agree with requiring the wearing of masks for businesses like stores and for transportation like buses, I do not agree with this for public places like parks, streets, and trails. I fail to see how making joggers, bicyclists and people taking a walk around the neighborhood or in a park without a mask is going to significantly decrease the spread of COVID. Going jogging or biking is one of the few pleasures that we are still enjoying, especially since the weather is getting hotter.

As I previously mentioned I would like the opportunity to have a conversation with you over the phone. However, I will put some of my thoughts in this email as well. I would like to start out by saying that I am pro mask. I believe it is an important way to prevent the spread of covid19 and should be worn in most indoor public places.
