There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines: Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

Dear License Committee,

I'm writing to appeal to the objection of the Food Dealer - Restaurant License and Food Peddler License application for 7330 N 76th Street, Milw, WI 53223. I never had a chance to sit down with Alderwomen Chantia Lewis face to face but made several attempts thru her assistant Debra to do so. Debra instructed me to send my business plan and goals to her via email for review immediately as I informed Debra, I was planning to have a Grand Opening for TK's Smok'N Smoke House on Saturday, February 29, 2020. I sent everything to Debra that day as requested. It wasn't until Tuesday, February 25, 2020 that I discovered the Alderman changed (at City Hall Licensing Division office when all the applications and fees were paid) as I initially had the address of 10701 W Mill Rd, Milw, WI 53225 for TK's. I had met with Alderwoman Nakiya Dodd in January asking for the support of the food trailer and Dodd welcomed the opportunity into her district. The final inspection was conducted on Friday, February 28, 2020 with Lindy Wiedmeyer at the shared premises location; so now all we needed was the approval from Alderwomen Lewis. I called and called all day and the Licensing Division said, "everything is done just waiting on the Alderwoman's approval. By this time flyers regarding the Grand Opening and social media posts were broadcasted all over the city of Milwaukee in January shortly after I met with Dodd. I was confident that all would be well. It's very unfortunate the tragedy with Tony occurred and was unexpected.

I called several more times after February 29, 2020 and talked to licensing and the approval was still needed from the Alderwoman. I returned to City Hall on March 12, 2020 and was informed by Debra it was Girls Day at City Hall that day where over 300 women attended and it was extremely busy but she was going to get everything taken care of. I never received a response. I called the Licensing Division again on April 30, 2020 and spoke to Linda Moon Siefert and she stated let me try to find out what's going on with the license. Linda called me back an hour later and informed me I need to amend the license removing Tony Taylor and adding myself as agent and 100% stockholder. I sent the document back on May 1, 2020, then the objection letter on May 5, 2020.

My intention for the food trailer is for venue purposes only. For example: Steinhafels reached out to me as they are interested in vending services to serve their employees once per week starting in June 2020. It was initially set for May of 2020 however, COVID19 has caused a delay. The vision for the trailer will be for corporate events and when hired for a venue. My purpose is never to be at the shared kitchen location trying to serve or attract customers. The shared location is for storage and prep purposes only.

I'm asking for reconsideration in supporting TK's Smok'n Smoke House, LLC as this is a dream and vision I wanted to promote in the community. The trailer has full kitchen capabilities and was designed and built to our liking. I sent pictures to Debra along with the business plan. I couldn't image having put so much time, effort and money into this trailer and not being able to utilize it. A denial means I can't receive a return on my investment or provide employment opportunities in the city of Milwaukee.

If the decision is denied after reconsideration would you please allow me time to find another shared kitchen location outside of your district which will allow me not to have to reapply for a license?

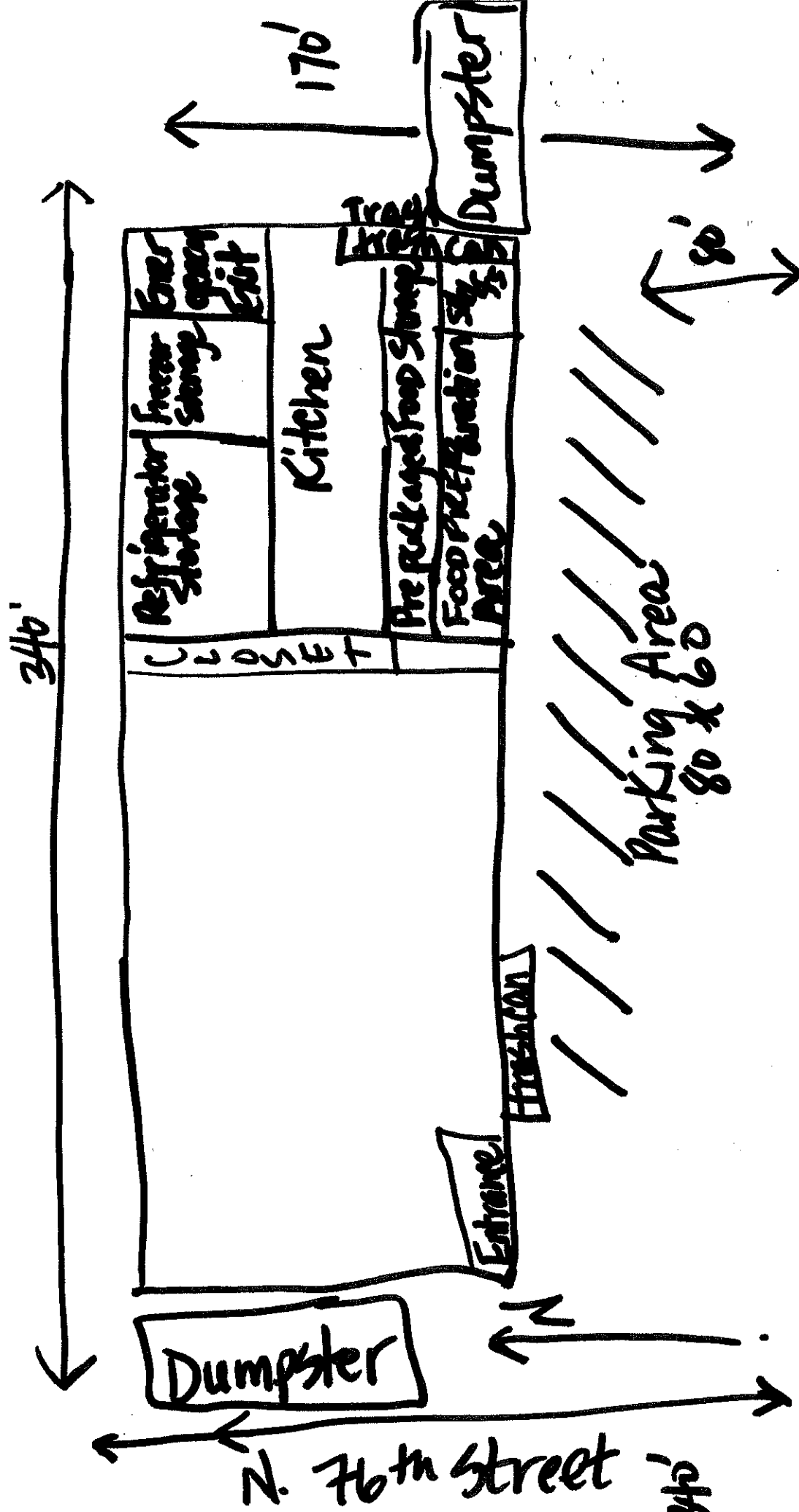
