This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/07/2015 Milwaukee police spoke to Arthur Strong, identified as security personnel, who stated there had been shots fired within the business after an altercation between patrons. Strong stated a patron struck another patron and caused a disturbance. Strong attempted to physically intervene when he overheard and unknown subject shout "Go to the car". Strong observed a subject re-enter the bar with what appeared to be a firearm with a black handle and chrome barrel. Strong observed the subject pointing the firearm at patrons. Strong discharged his own firearm into the ceiling to stop the suspect's actions. The suspect fled out the bar and fired his firearm at the bar. No patrons were struck during this altercation. Strong was ordered into the District Attorney's office were it was determined his actions were non-criminal
- 2. On 03/20/2015 Milwaukee police, along with the Wisconsin Department of Revenue, conducted a premise check at 8775 North 107th Street (Club 107). During this check, the bartender, Dannielle Klinter, was given verbal warnings regarding invoices for alcohol and for combining or refilling bottles. The bottles that had been combined or refilled were disposed of.
- 3. On 10/05/2015 Milwaukee police were dispatched to a sick/injured person at 8775 North 107th Street (bar 107). Investigation revealed a patron had fallen off a patio table. Milwaukee police incident report #152770043 filed.

- 4. On 01/09/2016 at 12:33am Milwaukee police were dispatched to a subject with a gun complaint at 8775 North 107th Street (Bar 107). Investigation revealed there was an altercation at the business when security barred a subject from entering that would not produce identification or follow other tavern policies. The subject made a gesture with his hand simulating a gun along with threatening statements "You think you bad man, I'm going to get you" and told the bar manager he was "going to shoot her". This subject fled in a black four door vehicle prior to officer's arrival. Milwaukee police incident report #160090034 filed.
- 5. On 01/09/2016 at 2:24am Milwaukee police were dispatched to a shots fired complaint at 8775 North 107th Street (Bar 107). Officers observed two windows had been shattered. Inspection revealed what appeared to be bullet holes in the shattered window. Officers also discovered a bullet casing in the street along with bullet fragments inside the business and what appeared to be bullet strikes on the ground in front of the business. One of the business's employees told officers he was taking out the garbage when he heard gunshots and observed a vehicle in front of the business. This vehicle, a black four door, matched the general description of a vehicle described in item #4. Milwaukee police incident report #160090017filed.
- 6. On 01/22/2016 Milwaukee police met with Kelly Lewis, manager for Bar 107, at the business in regards to shots being fired into the tavern. Lewis described an incident that occurred about a week before the shots fired involving a couple of customers who refused to leave and the business's security. This incident turned physical and the subjects made unknown threats prior to leaving. This incident was not previously reported to police. Kelly stated they have since hired a new security officer and are considering other changes, such as an age limit of 25 or older and changing juke box settings. She further stated they generally have a good clientele and do not have problems. She also expressed willingness to work with police.

- 7. On 09/17/2017 officers were dispatched to a fight at Bar 107, 8775 N. 107th St. Upon arrival the officer observed numerous vehicles leaving quickly. The officer interviewed security guard, Michael CRAWFORD. He stated a fight occurred between two females at closing time. He separated one female taking her off to the side. The other group of females began throwing things in their direction. CRAWFORD was struck in the head by a glass mug, causing minor injury. CRAWFORD drew his pepper spray and the females left. A group of males began approaching and CRAWFORD observed a gun in the pocket of one subject. CRAWFORD drew his firearm and the subjects left. The officers observed no violations at the business and security personnel were cooperative.
- 8. On 01/27/2018 officers were dispatched to a battery complaint at 8775 N. 107th St. The investigation revealed the victim got into an argument with a group of subject at 2:08am inside the bar. The suspect went outside and the victim confronts them again outside. The group then began hitting and kicking the victim. Security assisted in separating the individuals fighting. A check revealed there was no call for police at the time of the incident.
- 9. On 05/28/2018 officers conducted a license premises check at Bar 107, 8775 N. 107th St. The officer spoke with the applicant regarding complaints of disturbances at the business. The applicant stated he has hired additional security and is open to suggestions. The officer stated he should have security patrol the perimeter of the parking lot to discourage loitering after close. The officer also suggested resetting the card reader every day, to get an accurate count of patrons in the bar. The applicant stated he is available at anytime video needs to be viewed.

- 10. On 05/28/2018 at 1:48am officers conducted a tavern check at Bar 107, 8775 N. 107th St. The officer spoke with the applicant who stated he has hired more security and was open to the suggestion to have his security patrol the perimeter of the parking lot to prevent loitering after bar close. He was also advised that he should reset his card reader daily to help maintain a patron count to prevent going over capacity.
- 11. On 07/14/2018 at 2:17am an officer conducted a licensed premise check at Bar 107, 8775 N. 107th St. The officer observed a security guard tell a subject in a car to leave the parking lot because the tavern was closed. The discussion became heated and both parties began threatening to harm each other. The officer and other security had to separate the parties to prevent a fight. The guard did go inside and the other party left.
- 12. On 09/22/2018 officers responded to Bar 107, 8775 N. 107th St. The officers were advised that security found a subject on the ground in the bar and called for medical treatment. The subject, Garth POST, refused treatment and the officers took the POST home. On 09/28/2018 the officers were advised by POST that he had gone to the hospital for a headache and he was advised he a bleeding on the brain from the incident at Bar 107. The officers went to the bar and interviewed a security officer who stated he observed POST talking with another patron's wife. That patron asked POST to stop talking with his wife and POST got in the subjects face. That person pushed POST into another patron who became upset and punched POST. The security guard then ran up and carried POST out of the bar. The officers were unable to view video because none of the employees could operate the system. The officers filed a report regarding the unknown subject striking POST.
- 13. On 09/27/2018 officers, along with agents from the Wisconsin Department of Revenue, conducted a license premise check at Bar 107, 8775 N. 107th St. The applicant was advised his sellers permit was not visible to the public and the agents located 2 bottles of liquor that were contaminated and they were disposed of on site.
- 14. On 10/11/2018 officers conducted a licensed premise check at Bar 107, 8775 N. 107th St. The officer found no problems and security was cooperative during the check.
- 15. On 10/24/2018 officers went to Bar 107, 8775 N. 107th St, in an attempt to recover video from a prior incident on 09/28/2018. The applicant came to the business to check for the video but found the video was unavailable because the system only saved video for 14 days.
- 16. On 05/19/2019 officers were dispatched to a battery complaint at Bar 107, 8775 N. 107th St. The officers interviewed the bartender who stated a customer was upset because he came back inside after smoking a cigarette and found his food gone. The customer then started throwing condiments at the bartender. The officers did not locate the subject.

17. On 07/13/2019 at 1:32am officers were dispatched to Possible Shooting at Bar 107, 8775 N. 107th St. The officers located 20 shell casings in the parking lot and several cars hit by bullets. The officers did not locate any shooting victims. The officers spoke with security, who stated they were breaking up a fight when they heard shots fired. They did not see who did it or where they were coming from. The manager provided the video surveillance, which did capture the subject firing shots in the parking lot.

- 18.On 11/06/2019 at 8:20pm officers conducted a license premise check at Bar 107, 8775 N. 107th St. The officer spoke with security, who stated they have been slow lately and have had no problems.
- 19. On 12/29/2019 at 1:48am officers were dispatched to a Fight at Bar 107, 8775 N. 107th St. The actors in the fight were gone when the officers arrived. They spoke with security, who stated four females were fighting. Security stated they broke up the fight, kicked them out and shut down the bar for the night.
- 20. On 01/26/2020 at 1:32am officers were dispatched to a Subject with Gun at 8775 N. 107th St. The caller was a patron who stated she was kicked out with a group of friends. When they attempted to get back inside a security guard produced a handgun and waved it in the air. The officers spoke with security who stated the group was kicked. They were banging on the doors and windows to get back in. the manager and two security officers had to block the entrance of the bar to prevent the subjects from coming back inside. The security officer said he reached for his gun but never pulled it out. The officers attempted to get video of the incident but were unable to at the time.

This report is written by PO BOEHM assigned to District Four, squad 4484 along with my partner PO HERRERA.

On Saturday, 07-13-19 at 1:32am we-squad 4484(PO BOEHM/PO HERRERA) responded to a possible shooting at the Bar/Club BAR 107 at the address of 8775 N 107th St. On arrival we were advised by squad 4312(SGT JOHNSON) and squad 4431(PO WEST/PO RUMMEL) that there were multiple autos were struck in the parking lots of the establishment and at least 20 plus spent casings were located in the parking lots as well.

It was later determined that nobody was shot and no reports from hospitals having any shooting victims.

I spoke with the security staff briefly about the possible shoots fired outside in the parking lot. They stated there was a large fight inside of the venue and they were removing the actors at the time of the shots fired. They stated that they heard the shots but didn't see who or where the shots were coming from due to breaking up the fight.

I then met with the manager Varshil m. PATEL w/m 06-28-92. He advised me that he did have access to the video surveillance. The incident occurred on the north side of the building. The video showed both the north side of the building and the front side walk area of the establishment. At 1:27am you observe a dark skinned black male thin build around 20-30 years of age, wearing blue shorts and an American Flag t-shirt; come from the front sidewalk area coming into the video on the west side of the building. Following him is a heavy set black female around 20-30 years of age wearing black shorts, black half shirt exposing her stomach area carrying a bright yellow hand bag.

They then leave the video sight line for a brief second and then the black male wearing the American Flag re-enters the frame and was observed firing several shots back to the main parking lot which is on the west side of the building. The subject then flees in what appears to be a gray four door Cadillac from the north side of the parking lot heading west on Brown Deer Ln then south on N. 107th St. One of the security staff said he believed the auto was a Silver Cadillac DTS.

It appears that there was another person shooting back at the suspect in the American Flag Shirt because there was also casings in the main parking lot area where he was shooting towards. Unfortunately, the venues video does not reach the area where the other suspect was shooting from. It was possibly a black male in a gray outfit with dreadlocks because he was seen arguing with the other suspect.

INITIAL INVESTIGATION

This report is written by P.O. Jason FINLEY, assigned to District Four, Late Power Shift, Squad 4486.

On Sunday, December 29, 2019 at approximately 1:48 AM, my partner, P.O. Lee XIONG and I (in full duty uniform, marked MPD squad, and equipped with AXON 2 body cameras) were dispatched to Bar 107 (8775 N. 107th St) for a fight in progress. Subsequently other squads were dispatched, which included Squad 4420, P.O. Travis CAPELLE, Squad 4390, Jonathan MILLER, Squad 4374, P.O. Shane DOUGHTY and P.O. Brett STAGERWALD, Squad 4330, P.O. Eugene REESE and P.O. Alex EISSENS, and Squad 4440, P.O. Khalid MAJEED and P.O. Shirley THOMAS-BALDWIN.

While en-route, Squad 4330 arrived on-scene and broadcasted that the subject who were fighting were already gone, and there was no longer anyone on-scene who was involved in the fight. P.O. XIONG and I went into the bar and spoke with the head of security, identified as Christopher NEAL (m/b, 07/03/81) who stated there were four females who began fighting inside the bar. NEAL stated he did not know what the fight was about, but stated once the fight broke out, NEAL and the other security on-scene assisted in escorting the females out of the bar, and subsequently shut the bar down for the night removing the rest of the patrons in the bar.

NEAL stated once they females exited the bar, the fight continued for a very brief time in the parking lot and then everyone went to their vehicles and left the location prior to police arriving. NEAL stated there were never any weapons seen or involved and there were no other issues.

I also spoke with one of the bartenders at the bar, identified verbally as Katie M. ROBINSON (f/w, 04/29/88) who stated she has been working at the bar for the past several years. ROBINSON stated there was not a manager on-scene tonight due to the fact of them no longer having a manager, because he was fired approximately two weeks ago. ROBINSON stated she did not really see what happened with the fight due to it starting on the other side of the bar. ROBINSON stated she saw NEAL and the other security members escort the females who were fighting out of the bar and that they then began closing for the night.

Both security and employees were very cooperative with police.

This is the end of my report.

This report is being written by P.O. Scott MCLEAN assigned to District 4, Late Shift.

On Sunday, January 26th, 2019, at approximately 1:32 am, P.O. Andrew KELLER and I (squad 4320) was working in full duty uniform while equipped with an Axon Body Worn Camera were dispatched to a Subject with a Gun at 8775 N. 107th Street located in the City and County of Milwaukee.

Upon arrival to the location I observed a group of females standing outside of Bar 107 Sports Bar and Grill and security standing between the group and the business. My partner P.O. KELLER went and spoke with the Security Guard who is employed by Bar 107 Sports Bar and Grill. I then spoke with the caller who was identified as Adriana L. BELL (B/F 11/05/1987) who stated that a security guard pulled a firearm and began to waive it around in the air. I could immediately smell the odor of an intoxicant coming from BELL when I came in contact with BELL.

I then asked BELL to explain more to why they were not allowed back into the business. BELL stated that she was outside having a smoke with her friends in the designated smoking area and when they reentered into the business they were exchanging words with another group located in the VIP lounge of the business. BELL stated that both parties then began to push and shove one another. BELL then stated that's when security escorted them out of the business. BELL stated once she was escorted outside of the premises that's when the security guard drew his firearm and waived it up in the air. I asked BELL why the security guard drew his firearm and she stated that her and her friends were close to him and he may of felt threatened.

My partner P.O. KELLER then spoke with the security guard and other witnesses who stated that the security guard did not pull out his firearm and waive it in the air. See P.O. KELLER investigation below report for more detailed information.

On Sunday, 01/26/2020, at approximately 1:32 A.M. my partner, PO Scott MCLEAN, and I were dispatched to the Bar 107, which is located at 8775 N. 107th ST, for a Subject With a Gun complaint.

Upon arrival, I spoke to an employee of Bar 107, who was identified by a WI driver's license, as Michael D. CRAWFORD (B/M, 03-01-93). CRAWFORD stated he is a security guard at the establishment. CRAWFORD stated a group of females had been escorted outside of the establishment before our arrival by the manager, Terry L. EVANS (B/M, 06-16-67). CRAWFORD stated the females were upset about being

escorted outside and once outside began to become loud and rowdy. CRAWFORD stated the females began to pound on the glass of the doors and the windows outside. CRAWFORD stated EVANS stood in the doorway to prevent the females from re-entering the establishment. CRAWFORD stated he went to help EVANS keep the females outside, and when the females continued to try and push their way in, CRAWFORD stated he reached for his firearm, which was in a holster on his hip. CRAWFORD stated he did not remove the gun from his holster and did not point it at anyone.

EVANS stated he was unable to see if CRAWFORD reached for his firearm but stated he did not see a firearm pointed at anyone.

I spoke to Brandon D. SALLIS (B/M, 09-28-90), who stated he is also a security guard at the establishment. SALLIS stated he came to help CRAWFORD and EVANS with the group of females. SALLIS stated he did not see CRAWFORD point a firearm anyone.

We attempted to obtain security camera footage of the incident but were unable to do so at the time of our investigation.

I then obtained a Food Dealer - Restaurant License and the Class B Tavern License. (EFF Date: 09/22/2019 EXP Date: 09/21/2020)



This supplemental information should be incorporated into my client's most recent Plan of Operation and shall amend the current renewal application.

We have put into place a Mitigation Management Plan to deal with neighborhood complaints, control of noise, security, litter, graffiti, etc., and provide a protocol for communicating with police to resolve potential problems with loitering, noise, and other issues.

Mitigation Management Plan

We have reached out to the Milwaukee Police Department ("MPD") Community Liaison Officers Tracey Geniesse & Carrie Resnick to schedule a meeting to walk the property with them to discuss what additional actions we can take to make the neighborhood safer.

We will also schedule follow-up onsite meeting with the MPD Community Liaison Officers Tracey Geniesse & Carrie Resnick to review and advise us on our security and other measures in the future.

We have also retained Les Johns, a licensed security professional, to assess our security needs and develop a game-plan for the safety and security of the premises and to provide protection for the premises. We will only hire licensed security personal for the premises.

Cameras - We currently have 20 cameras. We have 13 cameras in the premises and 7 around the perimeter of premises. We will add additional security video cameras in and

around the perimeter of the establishment as recommended by our security consultant and/or MPD..

We will upgrade our ID Scanner so that everyone that enters will have his or her identification recorded. This will allow us to ban trouble customers and will enable us to help identify individuals for law enforcement.

We will use handheld metal detector security wands on all patrons entering the bar.

We are willing to install additional light fixtures designed to minimize the impact on the residence while providing adequate lighting levels to assure security and discourage loitering.

We will stop serving alcohol 30 minutes before bar close.

We will stop playing music 30 minutes before bar close to promote a calmer departure.

We will have monthly employee meetings to continue to go over these policies and procedures.

Customers will be discouraged from loitering outside the property and in the surrounding neighborhoods. We will have our security make hourly sweeps of the surrounding community to ensure that no one is loitering.

We have posted signs that police will be called for loitering, littering, and loud noise. Any customer who violates these rules and regulations will be placed on a list and banned from our premises.

We will notify MPD in advance of any significant events taking place.

Litter Control – We shall control and inspect the litter emanating from our site three times per day, in the morning, mid-day, and an hour before close.

We have already invested over \$[?] in making improvements to the building, and as our profits increase, we intend to continue to invest in the building.

We are also open to suggestions from the MPD, Alderwoman Lewis, and the Neighbors on how we can effectively address any issues and concerns that may arise.
