My name is Vyacheslav Strogolov and I am a resident of the Milwaukee county. The consideration of mandating face masks for everyone is very disturbing to me and I urge you all to reconsider going forward with this decision.

Mandating face masks for everyone does not have solid scientific support. For example, statement that the Lancet journal states that "masks in multiple ways are highly protective in health care and community setting" as was stated by Dr. Holger Schunemann an epidemiologist and physician at McMaster University in Ontario, is missing a very important part from that statement "We have low certainty in that" was also stated by Dr. Schunemann in the same publication. This means that the authors cannot be strongly confident in the benefit. The standard scientific studies were never performed such as randomized, double-blinded controlled trials. Dr. Schunemann also cautioned that the studies collected in the Lanced were observational, not randomized trials. WHO still states that cloth facemasks have very low incidence of protection from COVID-19. Hand washing is the best way to prevent viral transmission. Even the CDC states that even though they recommend wearing a cloth mask, the cloth mask WILL NOT prevent you from breathing in or out respiratory droplets which carry a virus, like COVID-19. A psychological comfort is the only potential thing that cloth masks do. Similar results were presented by Harvard medical school, and Stanford University showing that cloths masks are ineffective in preventing viral infections, this includes factory made N95 masks. New designs that Stanford is doing is having oxygen pumped into the mask to make them more breathable with a tight seal. This level of insanity is profoundly disturbing.

In addition, when we consider the pore size on any breathable mask material, it is at least 10,000 times greater than any virus particles we are trying to filter; rendering them useless for viral protection.

The studies also do not settle on the question of whether the protective benefit of a face mask derives from the barrier it creates or from behavior changes it may prompt. Currently the suggestion to force face masks on community is based on fear, emotion as well as improperly understood and reported scientific studies.

Wearing of the cloth masks is also flawed. I served in the US Army as a combat medic (MOS 91W) for 8 years. I am very well trained in the chemical and biological warfare. Any mask you are forcing people to wear does not provide any protection for me from them, or to them against me. The unfiltered air still gets in and out from the front, sides, or any other opening on the mask, to include the fabric's pores. If you can breathe through the mask, it does not protect you nor prevent viral spread. We still transmit viral particles whether we like it or not. People still breathe the same air outside, in their cars, in their homes. Not one store, home or organization uses positive pressure HEPA filtered air in their establishments. This is the only way to ensure that the air breathed is truly sterile. We are ignoring the fact that we live in a single atmospheric bubble and share everything that comes in or comes out. Breathing out causes microdroplets to remain in the air for hours and travel for miles. They end up on your close, hair, skin, gloves, mask, absolutely everything. Only one viral particle is necessary to infect. This must be remembered before making any mandates for mask wearing.

Wearing a mask will restrict breathing, which can be problematic for some people. People are not always aware of the signs of low oxygen, so if you are going to encourage the use, a disclaimer must be made on every mask that masks can restrict breathing and can result in less oxygen. Listing signs/symptoms to look for that may indicate low oxygen levels is imperative. My US ARMY field medic training always stated to keep the airway open. This is doing the opposite, restricting oxygen to the brain and other vital organs. This is especially important in children whose brains are still developing. Female brain development is until the age of 24 and males are until age of 26.

Wearing of masks is very unhealthy. First, you are rebreathing your moist air and germs. The moist, dirty air gets in the pores of the skin, thus starting to rot it and create breakouts of inflammation.

Additionally, the reduction of oxygen breathed in can cause carbon dioxide narcosis as well as brain asphyxiation, especially in children. Thus, by suggesting wearing of a face mask, you are harming their health, something that I believe

government policy and schools have no intention of doing. Young people are the future of our society and the masks are hurting them, specifically children who you are forcing to put a mask on. Children build their immunity by being exposed to the environment. Our innate and acquired immunity is the best defense that we have against viral challenges.

If people are locked in a bubble, and at some point, come out, they will get seriously sick with a potentially fatal outcome. Every time I see a person remove the mask, wipe their face, and put the mask back on, renders mask wearing practices useless.

The masks are also causing unintended psychological damage. We as humans are social and emotional creatures that take many cues from facial expressions and emotions. Forcing the human to cover their face is inhumane and insulting. Preventing our children from learning the body language and facial expressions, will rob them of social defenses and understandings of our society in the future. Additionally, teachers will not be able to understand when something is wrong with the child when the face is not fully seen. Same is for children. If children will only see a teacher in a mask, then its exceedingly difficult to connect with someone who does not fully have any human facial expressions. All you see is a mask and muffled sounds.

When take all viruses (our virome) and bacteria (our microbiome) live on our bodies and put them in a pile, they will weigh about 4lbs. My heart, my kidney, my lung, my liver all weight approximately 4lbs each. This tells me that viruses and bacteria present on my body are just as important as one of my organs. Wearing a mask, robs me and all people wearing masks of their acquired immunity. Additionally, it creates so much biohazard waste that litters parks, beaches, playgrounds, all our wonderful urban and suburban environments.

Mask wearing is not enforceable. We are humans. We cannot be policing each other on whether we are wearing a mask, touching our face, or standing closer than allowed to each other. Trying to do so will create more despair and distrust as well as more adverse consequences than benefits.

This mask wearing consideration for everyone is a bad idea. Please do not even consider making this mandatory.
