Description of work Reface existing 48" diam circular sign per attached images and description.

We are refacing the existing double faced flag sign on the front, North Elevation of building. The style and construction of the new faces will be consistent with the style and construction of the existing faces we are removing.

This sign is a 48" circular flag sign. Faces will be routed aluminum with a clear Acrylic push through "Sailor" logo, backed with a white Acrylic. The push through logo will be finished with a first surface, Gold translucent vinyl. The opaque background and the existing sign structure will be painted Dark Blue. The faces are bordered with (2) Two rings of neon on the outer edge of face. The larger neon ring will be Clear Gold while the smaller inner ring will be White neon.
