This report is written by P.O. Angel MUNOZ, assigned to District 2, Late Shift, Squad 2322.

On 02/24/2020 at 12:25 a.m., my partner P.O. Kevin OCHOA and I, were flagged down at 1619 S. 1st St. (Point Views bar) reference a Weapon Violation.

I made contact with the bar owner, Marcos RAMOS-GARCIA who stated that his employees were down in the basement on 02/23/2020 at approximately 9:41 p.m., when they heard what sounded like a gun shot coming from the outside. When his staff got back upstairs they noticed that the front window had a bullet hole through it. They notified RAMOS-GARCIA of the incident. RAMOS-GARCIA viewed the cameras and noticed that a male discharged a firearm into the front door. RAMOS-GARCIA stated that the room which the bullet went into was empty and business was closed during the incident. RAMOS-GARCIA stated that a casing was recovered by his staff outside the front door of the location. RAMOS-GARCIA did not recognize that male suspect.

I reviewed the closed circuit cameras and observed a male emerge from the alley of the north side of the street between S. 1st St. and S. 2nd St. The male walks across W. Lapham St. The male continues to ~~walk into an open field next to 1619 S. 1st St. and stands next to the building for a few seconds looking~~ around the area. The male who was dressed in a black sweater and black pants then walks in front of the bar door and you can see a muzzle flash on the video and runs around the building through the Scrub a Dub parking lot, cuts through a yard onto S. 2nd St. RAMOS-GARCIA handed the casing to P.O. OCHOA, the casing was a brass PMC 9MM Luger. I inventoried the casing into MPD Inventory #20006692. RAMOS-GARCIA was provided with a PV-17 and case number.

On 02/25/2020 at approximately 5:30 a.m. I met with MARCOS RAMOS-GARCIA at points View Bar who provided me with copy of the video surveillance. RAMOS-GARCIA also stated that after watching the interior video footage one of his employees were in the bar area when the shot was fired into the bar but not in the direct path. The video surveillance DVD was placed into MPD Inventory#200550008. Squad 2326, P.O. GREER took photos of the window damage.
