This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/27/2014 at the Days Inn at 1840 N. 6th St, four unknown actors, all armed with firearms, forced their way into the victim's hotel room by pushing past the victim after knocking. The suspects obtained property and fled the scene. The applicant was informed of this incident and was very cooperative with officer.
- 2. On 01/04/2015 at 12:21am officers responded to the Days Inn at 1840 N. 6th St for a Shooting. The investigation revealed the victim had rented a room for a party. There was alcohol and gambling at the party. During the party, unknown black male subjects, armed with guns arrived and attempted to rob the party patrons. The victim was shot through the door of the room. The officers on scene were unable to access or copy the security footage due to the applicant being out of the country and the employees not having access to the system.

3. On 03/18/17, applicant was cited for Building Code Violations at 2424 N Fratney Street.

- 4. On 11/02/17 at 6:15pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Strong Armed Robbery complaint. Investigation revealed that the victim was in the parking lot of the Hotel where she was battered and robbed of money and a cellular phone. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (173060004).
- 5. On 11/14/17 at 1:45pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a shots fired complaint. Employees were cooperative during the investigation and assisted officers with video surveillance footage. Officers located 13 spent casings near the vehicle. A police report was filed (173180105).
- 6. On 01/02/18 at 8:14pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Strong Armed Robbery complaint that occurred on 12/29/17. Investigation revealed that the victim and suspect were staying in a room at the hotel, when the suspect stuck the victim in the head with a liquor bottle and took \$1,800.00 from the victim. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (180020035).
- 7. On 03/27/18 at 8:53am, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Fraud Complaint. Investigation revealed that an unknown actor paid a bill at the hotel with counterfeit money. The fraud occurred between the dates of 03/17/18 and 03/19/18 and hotel staff cooperated with the investigation.
- 8. On 04/03/18 at 12:35pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a theft complaint. Investigation revealed that two victims were at the tavern located inside the hotel lobby when their purses were stolen by an unknown actor. Hotel staff assisted officers with the investigation. A police report was filed (180930068).
- 9. On 06/13/18, members of the Milwaukee Joint Human Trafficking Task Force, conducted surveillance at the address of 1840 N. 6th Street (Days Inn) because of various tips regarding criminal activity (drug dealing, soliciting, and trafficking). Officers were stationed for an hour and observed the following; A gentleman exit the front lobby and conduct a hand to hand exchange, females being dropped off by vehicles and enter the hotel without belongings or small bags, males and females exiting the hotel together, multiple people loitering in front of the hotel, and staff members walking around with females in skimpy clothing.

- 10. On 07/10/18 the agent of 1840 N. 6th Street (Hotel of the Arts LLC) was contacted by Milwaukee Police by telephone and told that he would be cited everyday he operated his hotel without a license. The agent was advised that officers will come to the hotel on 07/18/18 and enforce the closing of the hotel operations. The agent understood and stated that it gave him time to get his affairs in order.
- 11. On 07/10/18 at 10:00am, Milwaukee Police Officers, of the License Investigation Unit, conducted a license premise check at 1840 N. 6th Street (Days Inn) because of a complaint received about the hotel operating with an expired license. Officers observed the expired license posted and was able to interview the agent about the issue. The agent stated that he submitted an application, with payment, in April and had a completed inspection by the DNS in May; therefore, he thought his license was valid. The agent was advised to gather any evidence of payment and go to the License Division to straighten things out.
- 12. On 07/25/18 at 1:48pm, Milwaukee Police performed a license premise check at 1840 N. 6th Street (Day's Inn) because the business was operating without a valid motel/hotel license. When officers told the front door manager about the expired license, he told them that since he paid for the license, he could operate the hotel. When informed that he was wrong and that he would be fined everyday he operated, the door manager said that he has 19 people in the hotel now and 29 checking in tonight, so he will not be closing.
- 13. On 09/18/18 at 2:20pm, a meeting was held at District Five with the management of the Day's Inn (1840 N. 6th Street). Present at the meeting was the General Manager of the Day's Inn, representatives from Safe and Sound, City Attorney's Office, District Attorney's Office, Sensitive Crimes, District 5 CPU, and the Captain of the Fifth District. The General Manager stated that they have taken steps to combat crime on their property. These steps include; Security patrol in parking lot, background checks on hotel employees, entrance door is locked during the overnight hours, monitor phone numbers given by patrons on "back page", patrons must be 21 years of age and above, smoking patio only accessible from the inside, and an open door policy with the police. The following recommendations were made to the manager; conduct a CPTED survey with the District Five, Human Trafficking training for all employees, and no rooms to be rented after 10pm without a reservation. The manager was advised that they would be issued one citation for each week they are determined to have operated without a license.
- 14. On 11/30/18 at 8:53pm, Milwaukee Police conducted a license premise check at 1840 N. 6th Street (Day's Inn). The business had a valid license.
- 15. On 12/07/18 at 2:15am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
- 16. On 12/13/18 at 11:11pm, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a subject with gun complaint. Upon arrival, officer's interviewed the caller/employee who stated the subject he called about had left and he did not see a gun. The area was checked and but the subject was never located.

- 17. On 12/17/18 at 9:17am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a subject with weapon complaint. Officer's interviewed the caller/patron of the hotel who stated that her ex-boyfriend sent her a video, holding a gun, and that she was afraid he was outside. The caller was told that there was nobody outside and she was conveyed, by police, to the Greyhound Station.
- 18. On 01/10/19 at 9:37am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an Armed Robbery complaint. Investigation revealed that a patron of the hotel was walking to his vehicle, in the parking lot, when his vehicle was taken at gun point. There was surveillance footage of the incident and the management was cooperative with the investigation.
- 19. On 01/20/19 at 11:13am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a trouble with subject complaint. Investigation revealed that a patron was in her room and refused to pay for it. The patron eventually agreed to pay for the room and no report was filed.
- 20. On 02/01/19 at 6:17am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) to meet Milwaukee Fire Department for a combative patient. Officers were able to escort medical personnel, with the patient who was intoxicated and injured his leg, to the hospital and the staff at the hotel was cooperative.
- 21. On 03/20/19 at 7:01am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
- 22. On 05/02/19 at 11:55pm, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an Injured/Sick Person. Investigation revealed that security of the hotel observed a female in the lobby, unconscious, with white foam coming from her mouth. With help from other patrons, security laid the female on the ground, called 911, and the patrons started performing CPR. Milwaukee Fire Department arrived and administered 2 doses of Narcan and conveyed the female to the hospital. A check of the females' hotel room revealed a male subject sleeping on the bed, drugs, and narcotic paraphernalia inside. The male was arrested and a report was filed.
- 23. On 10/16/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6th Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.

- 24. On 10/17/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6th Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.
- 25. On 11/13/19 at 2:56pm, Milwaukee Police were dispatched to 1840 N. 6th Street for a subject with a gun complaint. Upon arrival officers interviewed the victim/caller who stated that a subject had been beating her for the past two days and was armed with a firearm. Officers went to check for the subject, found him, and a fight ensued while taking him into

- custody. After taking him into custody the subject was found to be in possession of a firearm and drugs. The agent was cooperative with all aspects of the investigation.
- 26. On 11/22/19 at 4:44am, Milwaukee Police were dispatched to 1840 N. 6th Street for check the welfare of a citizen complaint. Investigation revealed that two juveniles, who ran away from a group home, were sexually assaulted and being trafficked. The suspects were arrested and the staff of the hotel helped with the investigation.
- 27. On 03/05/20 at 4:04am, Milwaukee Police were dispatched to 1840 N. 6th Street for a battery complaint. Investigation revealed that a domestic violence battery occurred in one of the rooms at the hotel and the suspect was arrested.

Investigation revealed that a subject was doing prescription drugs with another subject, inside her hotel room, when she overdosed. The police and firefighters administered NARCAN, she became conscious, and she was sent to the hospital.

CHERONE's DV report). EICHELBERGER was less than cooperative with police regrading the battery portion of this incident. The listed business agent was cooperative with all aspects of the investigation.

This report was written by P.O. Damon WILCOX, assigned to District 5 Early Power shift. On Wednesday November 13, 2019 at approximately 3:03PM, Squad's 5250 (P.O. CHERONE and I), 5270 (P.O. AMBORN and P.O. MCINNES), and 5218 (Sgt. CAYA) responded to a Subject with a Gun at 1840 N. 6th St.

This location is the Days Inn Motel. P.O. CHERONE and I were in full Milwaukee Police uniform with our names and badges affixed to our outermost garments. Both CHERONE and I were wearing our issued Body Worn Cameras (BWC), which were activated during our entire involvement in this incident. We were also operating a fully marked Milwaukee Police Ford Explorer with 360 degree red and blue emergency lights and audible siren. P.O. CHERONE parked this squad in front of the location on N. 6th St.

The caller, who was identified as Shaunda ROY, had stated that her niece (GORINS' girlfriend), identified as Daijhonna EICHELBERGER, was being beaten at the location by a subject, who was later identified as Eric L. GORINS (B/M, 12-8-93). She stated that she did not know his name but he had an open warrant, and was armed with a firearm. The only description she was able to provide of the actor was a black male approximately 22yrs-24yrs of age, dreadlocks, and thin build. (Please refer to P.O. CHERONE's report for a more detailed interview of the caller and girlfriend).

Upon our arrival to the location, P.O. CHERONE and I made contact with the front desk employees at The Day's Inn. The employees were able to give a better description of GORINS (See P.O. CHERONE's report regarding the description given). P.O. CHERONE and I were advised by staff members, who were watching security cameras that GORINS and EICHELBERGER were on the fourth floor of the motel waiting for the elevator in the hallway. P.O. CHERONE and I then entered the elevator and took it to the fourth floor. P.O. AMBORN and P.O. MCINNIS took the stairs and stated that they would meet us on the fourth floor.

Upon the elevators arrival to the fourth floor, the elevator door opened. When the elevator doors opened, a subject matching GORINS description immediately stepped into the elevator. As GORINS entered the elevator, I observed him with his left hand in his pocket. I asked GORINS if he had any weapons and took control of his right wrist. GORINS stated "No". Fearing that GORINS was armed, I instructed him to take his left hand from his pocket. GORINS refused to take his hand from his pocket. I then attempted to gain control of his left hand to conduct a pat down for a possible weapon. GORINS then twisted his body to the left and began to attempt to bring his right hand in towards his body. GORINS actively continued to twist his body away from me in an attempt to break my control of his right wrist and flee into the hotel hallway. In order to achieve and maintain control of his active resistance I lowered my center and moved my outside leg in an arc and directed GORINS to the ground outside of the elevator.

GORINS was then placed on his side and I conducted a search of his person. GORINS was assisted to his feet and medical assistance was requested to the location to check him.

A search incident to the arrest of GORINS revealed the following items on his person that were seized, secured, and transported to District 5 and placed on Department Inventory:

- #1 Semi Automatic 9mm handgun loaded with seven 9mm cartridges located in GORINS left inner jacket pocket.
- #2 Large zip lock bag containing green plant material (tested positive for THC and weighing 15.61 grams) located in GORINS left inner jacket pocket.
- #3 87 multiple different color pills (tested positive for MDMA and weighing 15.69 grams) located in GORINS left inner jacket pocket.
- #4 White powdery substance in a plastic bag (tested positive for cocaine base and weighing 7.69 grams) located in GORINS right front pocket.
- #5 White powdery substance in a small plastic bag contained within a larger plastic bag (tested positive for cocaine base and weighing 1.86 grams) located in GORINS left inner jacket pocket.
- #6 Green plant material in a small bag (tested positive for THC and weighing 5.70 grams) located in GORINS right front pocket.
- #7 Off white substance in small plastic bag (tested positive for Fentanyl and weighing 2.11 grams) located in GORINS right front pocket.

- P.O. MCINNIS and I escorted GORINS to the first floor lobby of the location. P.O. MCINNIS and I waited in the lobby with GORINS for medical attention. BELL 426 responded to the location and began to assess GORINS, who was complaining to pain to his left shoulder. P.O. MCINNIS and I rode in the rear of BELL 426 with GROINS, who was transported to St. Mary's Hospital for medical treatment. GROINS was treated at St. Mary's Hospital in ER room #41 for a separated left shoulder. He was admitted at 4:20PM and treated by Dr. Christopher FORD. He was medically cleared and then transported by Squad 4338 (P.O. GOLD and P.O. RUTH) to District 5 for processing.

While at the hospital GORINS refused to give us his real name and stated to us and medical staff that he was "Erik M. BROWN". I afforded him multiple opportunities to give his real name and explained to him

that I knew he was not BROWN. GORINS even singed medical forms consenting to treatment under BROWN. He later did sign the medical forms with his real name.

While at St. Mary's, GORINS stated that he had looked out the fourth floor window of the Days Inn and observed our fully marked squad park in front of the location and knew police were at the location prior to his arrest.

After GORINS was arrested PO CHERONE spoke to EICHELBERGER, who stated she did pass a note to the cashier at the Papa John restaurant. She stated she GORINS had been beating her over the past 2 days, and she feared it would get worse. I did observe that EICHELBERGER had a swollen upper lip, and that she had fresh scratches on her face and neck. Another report was filed regarding the assault on EICHELBERGER under IR 19-317-0103.

My partner and I were in full duty uniform, in a marked MPD squad car, and equipped with Axon body worn cameras that were activated throughout this investigation.

While investigating the battery complaint in the lobby of the hotel, P.O. ROMO was flagged down by a female (suspect) who was later identified as Amber M NELSON (w/f, 10-10-1981).

INITIAL OBSERVATIONS

NELSON was crying and I observed a laceration on her left index finger. NELSON stated she had just been battered by her boyfriend (victim) who was later identified as *Cory J CASHMORE (w/m, 07-02-1985)*. I observed CASHMORE attempt to leave the hotel while we were interviewing NELSON.

I observed swelling and minor lacerations to the left side of CASHMORES face. CASHMORE was also wearing glasses that appeared to be damaged. CASHMORE was detained and placed into the back of our squad car during the investigation.

HISTORY OF PARTIES INVOLVED

NELSON and CASHMORE are currently in an intimate relationship. They do not have any children in common nor do they live together. Both NELSON and CASHOMORE stated they lived together in the past for approximately five months (August 2019- January 2020). They both stated their is a history of domestic violence. They have been boyfriend/ girlfriend for approximately 6 months.

INTERVIEW OF NELSON (SUSPECT)

NELSON was interviewed in the lobby of the hotel room. NELSON stated she was sharing a room (203) with her boyfriend CASHMORE. NELSON stated CASHMORE was upset and accused NELSON of cheating on him. NELSON stated it was a verbal altercation but it eventually became physical. NELSON stated CASHMORE shoved her into a wall and also choked her. CASHMORE stated she never struck NELSON. NELSON said she was unable to call police from her room so she ran downstairs into the lobby. NELSON stated she had used drugs earlier in the evening.

Initially NELSON stated she has never resided with CASHMORE in the past but later stated she has.

NELSON stated no witness were on scene during the incident but later stated CASHMORE brother and his girlfriend witnessed the event. They were not identified.

It should be noted, NELSON was very inconsistent with her story throughout the investigation.

INTERVIEW OF CASHMORE (VICTIM)

CASHMORE stated he rented a room for himself and NELSON as a late valentines day gift to her. CASHMORE stated he was in bed sleeping while NELSON was in the bathroom picking at her face all night. NELSON stated at around 4:00 a.m., he told NELSON to stop picking at her face and come lay down. CASHMORE that triggered NELSON and she became angry. CASHMORE stated NELSON was angry over the fact that his brother and his girlfriend were in their room. CASHMORE stated NELSON physically

CASHMORE stated NELSON is bi-polar when she is sober and not on drugs.

P.O. MENDOZA took 4 photos at 5:10 a.m. depicting the victims injuries.

P.O. MENDOZA called the DV hotline at 5:33 a.m. and spoke to "Jaime".

CASHMORE completed the 11 lethality assessment questions and screened in according to protocol.

CASHMORE was issued a pv-17.

CASHMORE was ordered in to the District Attorneys office for March 5, 2020. CASHMORE stated that was the day that worked best for him if he was to be present, however stated he does not want to press charges and does not plan on attending.

NELSON was taken into custody and conveyed to District Five for processing.

When we arrived the victim had a faint pulse and was not responsive to are voices. My partner PO ROSEN administered one 4 ml dose of narcan we had on person. Milwaukee Fire Department Med 7 showed up on scene and administered two more does of narcan to the victim. The victim became responsive and started asking question for Milwaukee fire Department. The victim was conveyed by bell 406 to St Mary's Hospital to get examined. My partner and I followed Bell 406 to St. Mary's Hospital so we could speak with the victim regarding the incident. Victim was interviewed by PO ROSEN, she stated that she took 3 of her oxycodone pills instead of the proscribed two. Victim stated that she was in severe pain from her hip replacement surgery she just had.

Victim gave consent for us to look in her room at the Days Inn, upon entering her room we noticed a white powder on top of the dresser with a rolled up piece of paper next to it. We found the victim's prescription pill bottle for her oxycodone. Her prescription was filled on March 26, 2020 and by the time we made contact with her that night all 42 pills were missing.

Victim stated that she had a white male with her that she met at the hospital a year ago. The victim stated that he brought her cigarettes and then he rolled her outside to smoke a cigarette with her. Then next thing she knows is she woke up with police and fire around her. victim does not know the name of the male.
