2. On 08/12/2019 officers conducted a license premise check at Jay's Food's, 440 W. Center St. The officer was escorted behind the counter, where the license was posted. No violations

were observed.

3. On 09/18/2019 at 1:00pm officers were in the area of 4500 W. Center St when they heard shots being fired east of their location. The officers arrived at 4402 W. Center St and observed two subjects holding firearms and a subject on the ground with gunshot wounds. The officers arrested the subjects with the guns and provided medical attention to the subject on the ground, who was pronounced dead on scene. The investigation revealed the applicant and two store employees where in the parking lot when a subject approached them. The subject got into an argument with one of the employees and produced a firearm. The applicant and

another employee produced guns and fired at the subject, striking him several times. The applicant and employees were taken into custody.

The licensed premise check was conducted during a "Neighborhood wellness walk" that was planned (by District 7 CLO/CPU at the request of Captain Willie MURPHY) and attended by multiple organizations that work to bring resources to neighborhoods in District 7.

During the licensed premise check, I was escorted behind the (elevated) counter of "Jay's Foods" where I observed their "Food Dealer" license and WI. DOR seller's permit posted on the north wall.

On Wednesday September 18, 2019 at 1:00pm, Squad 3245 PO Michael BRAUNREITER and Jamar LUCKY were on patrol and approaching the area of 4500 W Center St. PO BRAUNREITER and LUCKY heard several gun shots coming from the east. As PO BRAUNREITER and LUCKY stopped in the area of 4402 W Center St they observed a B/M holding an AK-47 style weapon (later identified as Michael D GRAY, B/M,11/16/77) and a B/M holding hand guns in both hands (later identified as Jason M RANDOLPH, B/M, 05/08/1986). They were standing in the parking lot of JAY'S FOODS at 4402 W Center St. PO BRAUNREITER and LUCKY ordered both subjects to drop the weapons and lay on the ground. Both GRAY and RANDOLPH followed commands. Responding officers arrived on scene and observed a B/M (later identified as Larrez N TAYLOR, 08/25/1975) laying on the ground with numerous gun shot wounds; medical attention was given to TAYLOR who was pronounced dead on scene.

The investigation revealed a video showing GRAY, RANDOLPH, and Deon A BILLINGSLEA (B/M, 09/11/1990) standing outside of the licensed premise, JAY'S FOODS, in the parking lot. TAYLOR arrived and an argument ensued between TAYLOR and BILLINGSLEA. TAYLOR removed a revolver from his right pants pocket. TAYLOR hit BILLINGSLEA with the revolver to the head and pointed the revolver at BILLINGSLEA. GRAY had a semi auto handgun holstered, and removed the handgun and shot once at TAYLOR. TAYLOR started shooting back at GRAY who ran into JAY'S FOODS. RANDOLPH had a semi auto handgun and a revolver and fired at TAYLOR. GRAY exitedJAY'S FOODS with the AK-47 style rifle and started shooting at TAYLOR striking TAYLOR numerous times.

During the investigation RANDOLPH admitted to being the owner and license holder of **JAY'S FOODS**. GRAY and BILLINGSLEA are employees of **JAY'S FOODS**. BILLINGSLEA, GRAY, and RANDOLPH, were taken into custody and homicide investigation is on going.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 9/8/2020 at 2:40 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
