The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/04/18 a youth working in conjunction with Milwaukee Police entered Wright & Save Foods located at 2478 N. 38<sup>th</sup> St., and purchased a Swisher Sweet cigar from the clerk, who was later identified as the agent: Adli A. DAHADHA. DAHADHA stated he was distracted due to a personal problem and did not recall the sale. DAHADHA did enroll in the MARTS Program, however, failed a secret shopper. Therefore, a citation for the initial violation was issued.

2. On 09/25/2019 at 10:44am officers conducted a license premise check at Wright & Save, 2478 N. 38<sup>th</sup> St. The officers observed expired perishable food inside the refrigerated section. The applicant was advised to throw the expired items away.
  3. On 10/14/2019 an officer observed a subject exit Wright & Save, 2478 N. 38<sup>th</sup> St with a handful of loose cigarettes. The officer went inside the store and spoke with the clerk who admitted to selling single cigarettes for \$0.50 each.

4. On 10/15/2019 officers, along with agents from the Wisconsin Department of Revenue, conducted a licensed premise check at Wright & Save, 2478 N. 38<sup>th</sup> St. The agent confiscated a large amount of tobacco purchased from an untaxed source. The health department responded to confirm the store was within the order ceasing the sale of non-perishable food for 60 days. The applicant was advised to stop selling ice cream. The officer also located baby formula that was labeled for sale at Kroger stores. The applicant first denied the sale of single cigarettes but did admit to selling single cigarettes. He was advised to stop this practice and agreed.
5. On 10/30/2019 at 9:10pm an officer performed a traffic stop at 2479 N. 38<sup>th</sup> St. The occupant was holding 4 single cigarettes in her hand, which she stated she just purchased at 2478 N. 38<sup>th</sup> St. The clerk, Mohammad HUSSEIN, denied selling the cigarettes. He then attempted to hide a pack of cigarettes behind the counter. The clerk then admitted to selling singles and stated he would not do it again.
6. On 11/17/2019 officers were dispatched to a drug dealing at 2478 N. 38<sup>th</sup> St. Upon arrival the officers got into a foot chase with a subject that matched the description from the call. The officers went to the store and talked to the clerk about viewing the video surveillance. They were advised the cameras were not functional.

This report is typed by P.O. Heather Schweitzer assigned to District 3, Day Shift. My squad partner is PO Lafayette EMMONS and we are assigned to squad #3278. PO EMMONS and I are in full police uniform, driving a marked squad car, wearing Axon Body cameras.

On Monday, October 14, 2019, at approx. 6:54p.m. P.O. Emmons and I (Sqd 3278) observed a tan Cadillac WI-AFG8693; parked on the north side of Wright and Save Foods, 2478 N. 38th St., parked facing west, left of the center lane, unoccupied. A b/f, Darnesha C.U. Banks (b/f, 09/11/96) exited the store with a handful of loose cigarettes attempting to enter the vehicle at which time P.O. Emmons asked Banks if the vehicle was hers to which she stated no but she was going to move it. Banks sat in the driver's seat of the listed vehicle. P.O. Emmons then asked Banks if she had a driver's license or ID to which she stated no. P.O. Emmons then asked Banks her name to which she identified herself. P.O. Emmons then asked Banks for her address and telephone to which she stated she did not have one as she entered the vehicle stating she could speed off on us as she was putting the keys in the ignition.

P.O. Emmons ordered Banks out of the vehicle. Banks got out of the vehicle but a few seconds later Banks sat back in the driver's seat of the listed vehicle. P.O. Emmons grabbed Banks left hand and advised Banks she was under arrest at which time she held onto the steering wheel while pulling away from P.O. Emmons. Banks continued to pull, twist away from officers and refused to exit the vehicle and put her hands behind her back while yelling obscenities at officers. At some point we were able to get Banks out of the vehicle but she was still actively resisting arrest. After being handcuffed Banks remained uncooperative with officers, twist and turning her arms and body and pulling away from officers.

BANKS was struggling, making it difficult to get her inside the back of the squad car. Once Banks was inside my squad car she refused to put her legs in the marked police squad causing officers to call for the patrol wagon. Banks finally put her legs in the vehicle. A dot/wanted check revealed the vehicle belonged to Banks. The vehicle was towed for obstructing traffic and issued a parking citation. She was also cited for operating vehicle center of left lane and operating vehicle with no insurance. Banks was conveyed to District 3 for booking and processing. She was issued a future court date and released.

While on scene I entered Wright and Save foods at 2178 N. 38th Street and spoke to the cashier who identified himself as Mohammad HUSSEIN (W/M, 03-

03-01). I questioned HUSSEIN regarding the loose cigarettes that BANKS left their store with. HUSSEIN stated he doesn't remember selling BANKS any cigarettes because he has lots of customers but he did admit to selling single cigarettes. HUSSEIN stated he sells the single cigarettes for fifty cent each. HUSSEIN stated he usually keeps the cigarettes in a box on the counter but when he saw me (a police officer in full police uniform) come in he put the open box of cigarettes in his pocket. I told HUSSEIN to let me see it and HUSSEIN pulled out an open box of New Port cigarettes, containing two cigarettes inside the box from his jacket pocket.

Early Shift, Community Prosecution Unit.

On October 15, 2019, Squad 3272 (PO Michael JONES) and 3271 (myself) were wearing our department issued Milwaukee Police Department uniforms with our badges and names affixed to our outermost garments, while operating an unmarked Milwaukee Police Department squad (#803) with working red and blue lights and sirens. My partner and I were equipped with body worn cameras.

On this aforementioned date at approximately 1:48PPM, PO JONES and I assisted in a site visit with Alcohol Tobacco Special Agent Georgeann KING and Department of Neighborhood Services Special Enforcement Inspector Lorie GALLUP at 2478 N 38th St (Wright & Save Foods), in the City and County of Milwaukee. During this site visit the agent of the location, Adli A. DAHADHA (m/w, 03/24/76), was on premise. The store was closed during the time of the site visit.

During the site visit, Special Agent KING confiscated a large amount of tobacco products because they were purchased from an unauthorized source/untaxed. DAHADHA stated that he purchased these items from "Mohammad". Special Agent KING immediately instructed DAHADHA to no longer purchase items from "Mohammad".

A firearm was located on the premise behind the counter. This firearm was secured by Special Agent KING during the inspection.

During the investigation, the City of Milwaukee Health Department was notified and requested on scene. An inspector came to the location to confirm DAHADHA was within the limits of his order to cease sell of non-perishable foods from 60 days. It was determined that DAHADHA was still selling milk products (frozen), as in ice cream. DAHADHA was instructed by the inspector from the Health Department to discontinue this sale immediately. DAHADHA stated that would comply, but was told several times in the past to comply.

Located behind the counter of the register was a large amount of Gerber Formula. On the formula was a sticker stating "Not for resale". Also on the sticker was a phone number to contact if it was being resold. I contacted the phone number, which was Kroger. Kroger was notified of the Gerber Formula and stated I would receive a call back if an investigator needed more information. This lead to a conversation between Kroger Loss Prevention Investigator Terry YOUNG.

DAHADHA was asked about single sale cigarettes. DAHADHA started to deny any accusations, but once given more information about previous investigations, DAHADHA stated they did sell single cigarettes. DAHADHA was instructed to no longer sell single cigarettes, due to it against the law. DAHADHA agreed to this. This instruction was not followed long, due to investigations of single sale cigarettes after this date.

DAHADHA was notified of the issues concerning his store and the criminal activity around it. DAHADHA was cooperative for the investigation, but did not always provide accurate and forthcoming information during the investigation. DAHADHA stated that he currently had no further information.

On Wednesday 10-30-19 at about 9:10pm Squad 3277(P.O. SEELOW, WHITFIELD ) conducted a traffic stop at 2479 N 38th ST. While conducting the traffic stop I observed the front passenger identified as Kevina C THOMAS b/f 07-20-1999 of 4124 W Fond Du Lac ave. not wearing her seat belt. I conducted a field inter view with the subject. I also observed that she was holding 4 single cigarettes in her right hand. The cigarettes where identified as Newports. I then asked where she had bought the cigarettes like that (single). I then asked her if she had bought them at that store and pointed at 2478 N 38th st. She then stated "YES".

I then ended the traffic stop and entered the location of 2478 N 38th ST WRIGHT and SAVE LLC. I spoke to the cashier identified as Mohammad HUSSEIN w/m 03-03-2001 of 110 E Fieldstone CIR Oak Creek WI 53154. HUSSEIN stated that he did not sell the single cigarettes. I then stated that I spoke to the subject from the traffic stop had stated that she bought the single cigarettes from you. As I was talking to HUSSEIN I observed him remove a open pack of Newport Cigarettes from his front pocket and hide them behind the counter. He tried to do this in a manner that I would not see him hide the cigarettes. I then asked if HUSSEIN if he smoked cigarettes and he stated that he did not. HUSSEIN then stated that he did indeed sell the single cigarettes and would not do it again.

I then spoke to the licensed owner of the location via phone and he was identified as Adli DAHADHA w/m 414-722-5296. He stated that he does not allow this and would make sure this does not happen again and would make sure Mohammad pays the tickets if issued.

On Sunday November 17, 2019, my partner P.O. Alexander VERREAULT and I, assigned as squad 3250 in a marked MPD squad car and equipped with axon body worn cameras were dispatched to 2478 N 38th Street (Wright and Save LLC ) for a drug dealing call for service.

An anonymous caller stated to the operator that they saw and observed 4 black males inside the corner store doing hand to hand drug transactions. The anonymous caller gave descriptions of the actors inside of the store doing hand to hand transactions, one of them being a black male, with a black jacket with fur on the hood.

Upon our arrival, we observed a black male walking away from the Wright and Save LLC walking northbound on N 38th Street from Wright Street with a black jacket and fur on the hood. We approached the male, who later was identified as Louis D MOORE. (B/M, 04/02/1975). P.O. VERREAULT and I informed MOORE that we had been called to the store for illegal drug activity and that he matched the description of one of the actors. MOORE then fled from police on foot and ensued a foot pursuit with P.O. VERREAULT and I. MOORE was taken into custody. MOORE did not have illegal narcotics on his person however is under supervision through the department of corrections and a hold was placed on MOORE for a probation violation.

P.O. VERREAULT and I, changed locations back to the Wright and Save LLC to speak with the store employees. We spoke to Muhammed HUSSAIN, (W/M, 03/01/1996) and asked to see the video surveillance of the cameras inside the store. HUSSAIN stated the cameras were not functional.
