#### LICENSE PREMIS REPORT

This report is written by P.O. Joshua HEDER, assigned to District Three, Early Shift.

On Saturday September 28, 2019 at approximately 7:58 PM Squad 3240 (P.O. CARSTEDT and I) were dispatched to an Armed Robbery complaint call for service at the Clark Gas Station located at 905 W Center St, which is located in the City and County of Milwaukee, Wisconsin.

Upon arrival I spoke to the victim; who is the clerk of the store, identified as Sukhwinder SINGH (w/m 09/05/94). SINGH stated that on September 28, 2019 at approximately 2:45 PM three subjects came to the location. SINGH stated two subjects entered the store and removed property while the third waited in the car. SINGH stated when he ran after the subjects the third subject fired a firearm in his direction and fled the location in a vehicle.

SINGH stated he was working as the on duty clerk at the store since approximately 2:00 PM. SINGH at approximately 3:00 PM three subjects came to the location in a black Nissan Altima with tinted windows and alloy wheels. SINGH stated he is very familiar with two of the individuals.

The first subject was a black male approximately 20-30 years old, 6'00" tall weighing 250-270 lbs. The subject had black hair with a shaved head and a small amount of facial hair on his chin. The subject was wearing a white t-shirt with the word "NIKE" and the Nike swoosh symbol. The subject also had a gold chain on his neck. The subject was also wearing black jeans and black and white Jordan tennis shoes. For the remainder of this report this subject will be referred to as SUBJECT 1.

The second subject was a black male approximately 20-25 years old, 5'08" tall weighing 150 lbs. The

subject had black hair in a deadlock style placed in a bun on the top of his head. The subject was wearing a red hooded sweatshirt, black pants with rips down the front, and white flip flops with black socks. For the remainder of this report this subject will be referred to as SUBJECT 2.

The third subject has no description but was operating the black Nissan Altima. For the remainder of this report this subject will be referred to as SUBJECT 3.

SINGH stated the subjects pulled into the gas station lot and SUBJECT 3 parked the vehicle at gas pump 6 facing south which is the gas pump farthest to the east. SINGH stated SUBJECT 1 and SUBJECT 2 enter the store and begin looking at beverages for sale in the store.

SINGH stated he is familiar with both SUBJECT 1 and SUBJECT 2. SINGH stated both subjects are known to steal and convey disrespect to himself. SINGH stated SUBJECT 2 is not allowed to purchase any merchandise from the store so SUBJECT 2 usually needs someone to buy things for him. SINGH stated he believed today SUBJECT 1 was the person to buy items for SUBJECT 2. SINGH stated he believes SUBJECT 1 and SUBJECT 2 live northwest of the gas station location "blocks" away.

SINGH stated SUBJECT 1 bought beverages from the location paying in United States currency. SINGH stated SUBJECT 1 then asked to borrow a lighter as he did not have enough money to purchase one. SINGH stated he did not allow SUBJECT 1 to borrow a lighter because he is known to steal. SINGH stated SUBJECT 1 then stated he would bring the lighter back later in the day. SINGH stated he again refused. SINGH stated SUBJECT one stated he was then going to take the box of lighters that are on the counter in front of the clerk. SINGH stated he thought SUBJECT 1 was joking at first but then SUBJECT 1 grabbed the box and fled out the door along with SUBJECT 2.

SINGH stated he ran out the door after SUBJECT 1 and SUBJECT 2 but did not catch up to them. SINGH stated he then turned his attention to the black Nissan still parked at pump 6. SINGH stated with a metal pole in hand he walked towards the Nissan. SINGH stated he threw the pole towards the Nissan striking the Nissan. SINGH stated he then turned around and walked towards the door to the location. SINGH stated he then heard one loud pop and believed he had been shot at by the driver of the Nissan.

SINGH stated he immediately began checking his person to see if he was struck by the gunfire. SINGH stated he then returned to the area behind the counter and took a moment to comprehend what had just occurred. SINGH stated he then began attempting to call his boss Varinder SINGH (w/m 01/28/89). SINGH stated he was unable to get in contact with his boss until approximately 7:30 PM. SINGH stated his boss then informed him that he should have called for police services.

SINGH stated he approximated the fifty lighters to value \$100.00. SINGH stated this incident was captured on surveillance camera. I then viewed the video.

Upon viewing the video the time stamp on the system states 02:44:00. Shortly after the video begins a black Nissan altima pulls into pump 6 and parks. SUBJECT 2 exits the vehicle from the front passenger seat. SUBJECT 1 exits the vehicle from the rear passenger seat behind the driver seat. The driver of the vehicle never exits the vehicle.

Both SUBJECT 1 and SUBJECT 2 enter the store and begin looking at the items for sale, glancing toward

SINGH several times. SUBJECT 1 grabs a water from the cooler along the south wall of the store as SUBJECT 2 grabs a soda. SUBJECT 2 hands the soda to SUBJECT 1 as the two continue to look at merchandise. SUBJECT 1 then purchases the two drinks as SUBJECT 2 walks to the entry door of the store and holds it open.

SUBJECT 1 appears to then have a lengthy conversation with SINGH. SUBJECT 1 walks away from the counter but then turns back and continues to have a conversation with SINGH. SUBJECT 1 then walks up to the counter and grabs a box full of lighters. SUBJECT 1 has several more words with SINGH and then begins running out the store northbound across W Center St as SUBJECT 2 who held the door for SUBJECT 1 begins running east then southbound down N 9th St.

SINGH ran out of the store after SUBJECT 1 with a white metal pole in hand. SINGH got several steps outside the store but discontinued his pursuit of SUBJECT 1 as SUBJECT 1 had already ran across W Center St. SINGH then returned just inside the store as the black Nissan began to slowly pull away from the pump.

SINGH then re-exited the store and began running towards the Nissan with the pole in hand. The Nissan then begins to pull away at a high rate of speed at which point SINGH threw the metal pole towards the Nissan striking the Nissan in the passenger side rear quarter panel.

SINGH then turns around and begins walking back towards the store entrance. The Nissan then comes to an abrupt stop and rolls down the front passenger tinted window. I then observed what appeared to be a flash or smoke come from inside the Nissan. Immediately after observing the flash SINGH appears to be startled and quickly moves his body. Other subjects who were in the lot at the time also appear to have a reaction after the flash. SINGH then walks inside the store and returns to the clerk position.

I observed damage to the entry door of the location. A hole approximately three feet off the ground was in the center of the plexiglass door. SINGH stated the damage was not on the door before the incident and believed the damage was caused by the fired round.

Squad 1824 (Forensic Investigator ULATOWSKI) arrived on scene and conducted CST duties. F.I. ULATOWSKI took digital photos of the scene and recovered the video surveillance. P.O. CARSTEDT inventoried the recovered surveillance and placed it on Milwaukee Police Department inventory number 19032850.

We also conducted a canvass which produced the following results.

912 W Center St- Mission Of Christ Lutheran Church. Location was closed and secured. There is an exterior camera on the south side of the building.

832 W Center St-Location is a vacant store front no exterior cameras observed.

2670 N 9th St- Vacant boarded up residence.

2666 N 9th St- No answer at door.

The hearing before the Licenses Committee will take place virtually on 9/8/2020 at 11:05 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
