

On Sunday May 17, 2020 at approximately 4:00p.m. My basement located at 3615 S. 83rd Street Milwaukee, WI began to flood. The sewage water that flooded the basement did not recede back down the basement sewer drain till approximately 5:30 to 5:45p.m. We received 5 inches of sewage backup water in the basement. The sewage water covered the entire basement floor. Multiple items were ruined including my water heater and dehumidifier. Gene A. Wagner Plumbing CO., INC can verify that this was due to flooding in the basement. There were also multiple other items which were damaged. Please refer to the enclosed itemized items that were damaged for further examination. I am 100 percent positive this was a result of the City of Milwaukee's sewer line backing up. There are multiple neighbors in the area who also had their basement flooded. Our neighbor who lives across the street at 3616 S. 83rd Street called the city around the time the flooding started and was put on hold for approximately 40 minutes. After she made the phone call the city came out to the North West corner of 83rd and Warnimont which should be on file and put out barricades. Shortly after they were in the area the sewage water in the basement started to recede at approximately 5:30 to 5:45p.m. I have enclosed a list of all the addresses that also got flooded since they are my neighbors and we all talked about the events of Sunday May 17, 2020. I have also enclosed pictures of all the items that were damaged as well as receipts.
