- 3. On 02/19/19 at 1:21am, Milwaukee Police were dispatched to 2008 W. Center Street for a Subject with Weapon Complaint. Investigation revealed that the cashier and a security guard for the establishment got into a physical altercation. During the fight, the cashier wielded a box cutter and the security guard had a stun gun. The security guard was arrested and the cashier was given a municipal citation.
- 4. On 05/13/19 at 9:48am, Milwaukee Police were dispatched to 2008 W. Center Street for an accident complaint. Investigation revealed that a vehicle was backing up to one of the gas pumps, accelerated to fast, and struck the establishment.

- 5. On 12/11/19 at 10:39pm, Milwaukee Police were dispatched to 2008 W. Center St for a subject with weapon complaint. Investigation revealed that the suspect got into an altercation with security personal of the gas station, and had to be physically removed. The suspect left the gas station but returned driving his vehicle in a reckless manner. The suspect caused damage to two vehicles, belonging to the gas station clerk and the security officer. The suspect also struck both subjects while they were outside. The suspect was later arrested by Milwaukee Police.
- 6. On 06/02/20 at 4:29am, Milwaukee Police were dispatched to 2008 W. Center St for a shooting complaint. The shooting occurred in the parking lot of the location with 3 total victims. One of the victims was a security guard for the gas station was pronounced dead by Milwaukee Fire Department at the scene. The other victims were conveyed to the hospital for medical treatment. The agent stated the gas station closed down around 11pm due to the current emergency order. He stated the security guard was in his car monitoring the parking lot. The agent slept inside the gas station. The agent was cooperative with the investigation, providing security footage regarding the incident.
- 7. On 06/02/20 at 9:13pm, Milwaukee Police were dispatched to 2008 W. Center St for a shot spotter complaint. Officers attributed the shots being fired, to a shooting that took place earlier in the morning, at the same location. Officers arrived on scene and observed subjects still firing their guns, the subjects even fired shots in the direction of responding officers. Officers were able to take 4 subjects in custody, regarding the incident. The 4 subjects taken in custody all were armed with firearms.

On Tuesday June 2, 2020 at approximately 4:38 AM responded to 2008 W Center St, located in the City and County of Milwaukee, WI as a backing squad regarding a shooting.

The shooting occurred in the parking lot of the gas station with 3 total victims. One of the victim's was pronounced dead by MFD. The deceased victim was a security guard working for the gas station Jeffrey DABNEY (B/M 8-25-84.)

I spoke to Sukhwinder S RANDHAWA (A/M 7-1-57) who is the business agent for RS LLC (SR Petroluem). RANDHAWA states that he closed his gas station around 11 PM on Monday 6-1-20, due to the current emergency curfew set by the mayor. RANDHAWA states that around 11 PM he turned off the lights and locked the doors to the gas station. RANDHAWA states that DABNEY is a security guard for the gas station, and that DABNEY was in his vehicle monitoring the parking lot. RANDHAWA states he slept inside the gas station as DABNEY sat in his vehicle in the parking lot.

RANDHAWA was cooperative on scene, and was able to provide security camera footage regarding the incident.

On 06-02-20 at 4:29 a.m., there was a report of a shooting, at the location of 2008 W. Center St., RS, LLC, which is a licensed gas station at this location, in which the caller stated in the CAD, that someone has

been shot. The caller reported that they had heard 12 gunshots and that someone came inside of the store, stating that someone was shot outside on the floor. Upon arrival, officers located male shot to the left leg. An update came in, informing officers that there was a second victim, possibly PNB, with multiple gunshot wounds. As the investigation continued, officers found that there was a third gunshot victim with a gunshot wound to the right leg, with a graze wound to the head. Two of the victims were immediately taken to Froedtert Hospital, while the third was still at the scene, being treated by the Milwaukee Fire Department.

Upon finding out who the victims were and there official injuries, the first victim had gunshot wounds to both legs, the second with multiple gunshot wounds to the right side of the torso and right forearm. The second victim was armed with a black semi automatic handgun. This person was the one who was PNB when officers arrived at the scene. The third victim had a gunshot wound to the face and upper right thigh.

It should be noted that officers were also dispatched to two shotspotter alerts, one with nine rounds fired and another shotspotter with four rounds fired at SR Petro, located at 2008 W. Center St. Officers were able to review the cameras of the gas station, were it was found that there were two suspects that shot all three victims. The suspects fled the scene and evidence of this incident was located at the rear of 2723 N. 20th St.

CIB responded and took over the investigation.

At this time this is all the information that I was able to gather, due this being a homicide investigation.

INITIAL INVESTIGATION

Below is the report written by P.O. Ryan Hepting regarding the incident that occurred at the licensed premise.

This report is written by PO HEPTING, assigned to District Five, Late Power Shift.

On December 11th, 2019, at approximately 10:39 PM squad 5436 (PO SEELOW and I) in full duty uniform, and operating a marked MPD squad car, was dispatched to a report of a Subject with Weapon at 2008 W Center Street, which is in the City and County of Milwaukee.

Officers were wearing full duty uniform with operational body worn cameras.

OBSERVATIONS/SCENE

2008 W Center Street is a Citgo gas station at the northwest corner of N 20th Street and W Center St. Upon arrival, there were two damaged vehicles parked facing each other about 8 feet apart in front of the entrance to the gas station. Engine 30 was already on scene treating victim Corey J. KIRKWOOD (m/b 11/28/1985) and victim Jeffrey D. DABNEY (m/b 08/25/1984) for their injuries inside of the gas station. Also Squad 3250 (PO Gutowski and PO Verreault) was on scene with our suspect Lavelle D. SMITH-CURRIN (M/B 02/18/1984) in the back of their vehicle.

INTERVIEW OF VICTIM

Once on scene, I spoke to the victim KIRKWOOD who stated that on 12/11/2019 at about 10:20 PM the suspect SMITH-CURRIN had come to the CITGO at 2008 W Center St. and recognized KIRKWOOD who was working as a security guard. KIRKWOOD stated that on an unknown previous date KIRKWOOD approached SMITH-CURRIN while he was with female friends and make conversation about how SMITH-CURRIN had worked for him in the past and did a good job which SMITH-CURRIN took offense to.

KIRKWOOD stated that on 12/11/2019 at about 10:20 PM, SMITH-CURRIN entered the Citgo and got in his face calling him a "Bitch ass nigga" and threatened to beat him up. KIRKWOOD stated that he along with people inside of the Citgo helped remove SMITH-CURRIN from the inside of the Citgo.

KIRKWOOD stated SMITH-CURRIN returned to the Citgo at about 10:22 PM. KIRKWOOD stated that he saw SMITH-CURRIN pull up and was able to stop SMITH-CURRIN from entering the building by blocking the door. KIRKWOOD stated that SMITH-CURRIN then pounded on the glass outside of the store before leaving again.

KIRKWOOD stated that SMITH-CURRIN returned a 3rd time to the Citgo. KIRKWOOD stated that this time SMITH-CURRIN intentionally and without consent crashed a Nissan Murano into KIRKWOOD's 2002

Nissan Maxima (WI-PC AGZ3174) causing damage. KIRKWOOD stated that SMITH-CURRIN then jumped on KIRKWOOD's car stomping on the windshield damaging it. KIRKWOOD stated that after damaging the vehicle, SMITH-CURRIN got into the Nissan Murano he was driving and struck DABNEY and KIRKWOOD causing pain and injury. SMITH-CURRIN also damaged two vehicles when he struck DABNEY and KIRKWOOD. A 2002 green GMC Yukon (WI-PC AFF-1307) that was driven by DABNEY and a 2005 Chrysler Pacifica (WI-PC 137YSK) that was driven to the Citgo by the gas station attendant Justin M. CASEY (w/m 12/22/1990).

KIRKWOOD stated that SMITH-CURRIN left the scene running north on N 20th St. before returning and attempting to drive away in the damaged Nissan Murano which he could not get to drive. KIRKWOOD stated SMITH-CURRIN then ran away again from the scene in an unknown direction.

SURVEILANCE FOOTAGE

There was footage recovered from the gas station and was inventoried into evidence (IN#19041821)

This is a summary of what is on the video.

The video is located at the southeast corner of the Citgo facing the parking lot. The video is time stamped at 12/11/2019 at 10:28:57 PM. The video shows SMITH-CURRINS running around the parking lot yelling at DABNEY and a large group of unknown black males before leaving in his vehicle which is off scene to the east.

At approximately 10:30 PM, SMITH-CURRINS returns and crashed his vehicle into the front of KIRKWOOD's Maxima before getting down as an unknown black male shoots a gun in the air. After getting down from the vehicle, SMITH-CURRINS gets back into the Nissan Murano and intentionally hits KIRKWOOD and DABNEY with the vehicle while running out of the video. The video shows the same unknown black male shooting two shots at SMITH-CURRINS after he strikes KIRKWOOD and SMITH-CURRINS. See IR#193460020 for the unknown male shooting at SMITH-CURRINS.

At approximately 10: 32 PM the unknown male who was shooting at SMITH CURRINS leaves in a blue Chrysler Pacifica (unknown plate).

At approximately 10:33 PM SMITH-CURRINS returns and attempts to remove the Nissan Murano from the scene but was unable to move it.

At approximately 10:34 PM the gas station attendant moved the GMC Yukon which causes the Nissan Murano to crash into the west fence. An unknown male in a blue Chrysler Pacifica gets out of the passenger seat and gets into the Nissan Murano and drives away. The unknown black male is wearing a black puffy jacket and black jeans.

SUSPECT

The Suspect per our victim is Lavelle D. CURRIN-SMITH (b/m 02/18/1984). He is described as about 5' 6" feet tall with a slim build, wearing a white t-shirt and blue jeans. CURRIN-SMITH described as having short brown hair and a dark skin complexion.

MISCELLANEOUS

SMITH-CURRINS WAS transported by squad 5460 (PO HERMANN and PO YANG) to District 5 for the booking process.

SMITH-CURRINS was read his Miranda Rights and did not want to answer any questions.

DABNEY was transported to Columbia St. Mary's Hospital in Medacare Ambulance 425 for his injuries.

Milwaukee Fire Engine 30 responded to the scene with Captain ERDMANN supervising (red shift).

An incident notification was complete by PO HEPTING and Lieutenant BERKEN was made aware of the situation.

KIRKWOOD was given a PR-3, PV-17, and a contact card.

20 photos were taken by P.O SEELOW at about 11:18 PM of the scene.

KIRKWOOD was ordered into the D.A.'s office on December 13th, 2019 at 1:30 PM. 1:30 PM was requested by KIRKWOOD instead of 08:30 AM.

IR#193460020 was filed for the unknown male shooting at SMITH-CURRINS.

CASE IS CLEARED WITH AN ARREST OF SMITH-CURRINS.

shotspotter, located at RS, LLC a licensed gas station, located at 2008 W. Center St. for a report of a shotspotter.

As the officers approached the gas station, the officers believed that the gunfire may have been a tribute to the homicide that occurred at the gas station, earlier in the morning, at 4:25 a.m. Officers approached the gas station parking lot, when they observed the subjects still firing off their guns, shooting in the direction of the officers. One of the officers returned gunfire and as he did, all the subjects fled from the gas station lot.

Officers were able to take 4 subjects into custody. All 4 were armed at the time of arrest.

It should be noted there was a shotspotter at 2008 W. Center St. at 9:15 p.m., for 12 rounds south side of the building.

There was another shotspotter at 2008 W. Center St., at 9:16 p.m. for 10 rounds east of the building on N. 20th St.

Another shotspotter was at 9:17 p.m., at 2008 W. Center St. for 9 rounds in between the buildings.

At this time, this is all the information that I have regarding this incident.

Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a, Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
