A pat down by officers revealed this patron was concealing a pair of brass knuckles and a glass tube containing copper scrub at both ends. This patron was arrested. other patrons. The subjects started arguing with the victim inside and continued outside. The victim stated she was hit in the head with a pistol by one of the subjects. The battery occurred in the alley outside of camera view. The applicant was on scene and cooperative. The officers

were unable to obtain a copy of the video. MPD report filed.

- 4. On 06/21/2019 at 2:08am officers were dispatched to a shooting call at 3202 S 13th St. the officers located blood splatter in front of Buckshot's Bar, 3219 S 13th St. The officers interviewed the applicant who initially stated there were subjects kick out of the bar for being disorderly. He then stated the bar was closed and there was a fight outside which he witnessed but it was unrelated to the bar. Another employee, Viviana SEDA, stated she did not know anything about the incident outside, then stated she heard something about someone grabbing another patron, which caused a problem between patrons of the bar. The officers located two shell casings in the street across from the bar.
- 5. On 06/24/2019 at 4:05pm officers were dispatched to a Trouble with Subject at Buckshot's Bar, 3219 S 13th St. The officers spoke with the caller who is a US Postal carrier. She stated that as she was delivering mail to Buckshot's a subject, who appeared to be intoxicated, came up to her and took the mail. The subject then asked her to kiss him and when she refused he grabbed her hand. The officers were able to identify the subject based upon information obtained from other patrons and issued the subject a Disorderly Conduct citation.
- 6. On 08/18/2019 at 2:20am officers were dispatched to a fight at 3228 S 13th St. When the officers arrived they found an accident at the location and a subject in front of Buckshots, 3219 S 13th St. bleeding from the mouth. The victim stated he was at Buckshots and got into a verbal altercation with another patron. As he was leaving he was assaulted and the assault continued outside. The victim then attempted to drive off and struck a parked car. The officer contacted the applicant on a later date and obtained the video of the incident.
- 7. On 09/16/2019 an officer conducted follow up from a call on 09/07/2019 regarding a fight at Buckshots, 3219 S 13th St. The officer spoke with a neighbor who stated there was a large group of people fighting outside of Buckshots that night. She stated she has called the Police in the past for similar incidents. The officer spoke to another neighbor who stated she was awaken by the large fight and she called the police. She said the subjects left just prior to the arrival of the police. She stated she observed the owner of the bar standing outside watching the fight but he did nothing to stop the fight. He then drove off with the subjects just prior to the arrival of the police.
- 8. On 10/06/2019 at 1:01am officers were flagged down at Buckshots, 3219 S 13th St. by the applicant regarding a Trouble with Subject. The applicant pointed out a subject walking away that had been involved in a fight inside the tavern. The subject stopped and talked with police. The applicant stated the other party had already left and he did not want to prosecute. The subject was allowed to leave in a cab.
- 9. On 10/13/2019 at 2:20am officers were dispatched to Shots fired at 3224 S 13th St. The officer determined this to be related the patrons leaving Buckshots, 3219 S 13th St. The officer interviewed the applicant who stated he was closing the bar at 2:10am and had to escort out 30-40 people. He observed a fight outside and he went to break it up. When he was back inside he heard several shots fired outside. The applicant provide video to the officers. While on scene a shooting victim arrived at St Lukes hospital. This subject stated he was at the bar for about 1 hour before the fight started. The victim went outside and joined in the fight. After the applicant broke up the fight the victim was walking off when someone fired shots, striking him in the leg. The victim was 20 years old and the applicant was cited for Allow Underage on Premise.

10. On 10/18/2019 at 10:12pm officers conducted underage tavern enforcement in District 6. An underage Police Aide able to gain entry to Buckshots, 3219 S 13th St. At the bar the Police Aide ordered a beer from the applicant. The applicant asked for ID and when the Police Aide could not show ID the applicant kicked him out.

- 11. On 11/07/2019 a meeting was held at District 6 regarding Buckshots, 3219 S 13th St. The applicant stated he has been in business for many years at this location and he has noticed as other bars close, his cliental gets younger. The applicant stated he has raised his drink prices and has noticed a decrease in sales but hopes the problems will decrease. The applicant provided a letter stating changes he would make including: ID every patron after 10pm; having a bouncer at the door scanning for weapons and maintaining capacity; closing 30 minutes early to disperse crowds and calling the police to report any problems. The applicant also stated he would have the bouncer prevent large crowds from forming outside. The applicant was cooperative and was willing to work to keep peace in the neighborhood.
- 12. On 02/22/2020 at 7:59pm officers were dispatched to a fight in the area of S 13th St and W. Euclid Av. When the officers arrived they observed multiple intoxicated subjects in front of Buckshots, 3219 S 13th St. The officer spoke with one bartender who stated he did not see anything. The officer spoke with the manager who stated there was a birthday party that day and there was a group that started to argue. When the subjects started fighting they were pushed outside. The manager stated she was one of the people that called the police. The officers could not locate any of the subjects injured or admitting to be in the fight.

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

On Sunday, August 18, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. James DAUER. At approximately 2:24am we responded along with Squad 6320, P.O. Juan GARCIA and Squad 6390, Nash DATHE to a Fight complaint. The dispatched location was 3228 S. 13th St. in the City of Milwaukee and the CAD call also referred to Buckshots Bar (3219 S. 13th St. in the City of Milwaukee).

Upon arrival to the location the fight was no longer in progress and there was one subject identified as Kalid M. ABDULAHI (M/B 01-01-97) sitting on the curb at the location bleeding from the mouth. There was also a second subject identified as Aaron C. BURTON (M/B 01-12-88) standing near. The two subjects were near the opening of Buckshots bar and across the street at the dispatched location was a two vehicle accident PDO.

ABDULAHI stated that he was assaulted in the tavern and as he attempted to leave the assault continued. ABDULAHI was observed to have swelling to the left side and right side of his face. There was also blood coming from his month from a bit lip and he was crying, upset and hard to understand at times speaking in a different language.

At the time of our arrival the tavern was closed, P.O. GARCIA will be filing an assault and battery report regarding this incident. I would file the License premise report and conduct follow up to review the video with the owner at a later time.

I did meet with the tavern agent David NUNEZ-CRUZ (M/W 03-06-61) at the tavern on a later date where he allowed me to view video regarding this incident. In the video ABDULAHI is observed in the tavern for approximately an hour drinking and conversing with others. There is then a time in the video were ABDULAHI is involved in some type of verbal altercation with a subject in the tavern. He is then asked to leave the tavern in which he does in a slow manner. He does not walk straight to car but lingers around out front. The subject he was involved with eventually exits the tavern and confronts ABDULAHI again. The subject then hits ABDULAHI with a closed fist to the face and three others add in punches thrown at him. ABDULAHI then runs to his vehicle and attempts to drive off, then striking a parked vehicle.

The subjects involved in this assault are unknown but the main subject involved was identified as a black male with shoulder length dread locks and a white t-shirt. A copy of the video was

On Monday, September 16, 2019 I was assigned to Squad 6468, the License Premise Unit. During my course of duty I conducted follow-up on a previous call for service that was related to a bar named BUCKSHOTS Bar located at 3219 S. 13th St. in the City of Milwaukee. The original call for service is detailed under Cad# 192500241 (Callers state there is a big fight in front of the bar. People are out of their vehicles. Everyone is in the middle of the street.).

Interview of PACACIOS

During the follow up of this call for service I spoke with one of the callers identified as Gacriela PACACIOUS (F/W 03-15-92). PACACIOUS stated that she lives at 3214 S. 13th St. in the City of Milwaukee which is located right across the street from BUCKSHOTS Bar. PACACIOUS stated that on 09-07-19 she was woken up to people yelling and screaming coming from outside. She then looked out her living room window and observed a large crowd of people outside the bar with several groups of people fighting each other. She stated she called the police believing that the incident would get dangerous. PACACIOS stated that while she was on the phone with the dispatcher the crowd started to disperse. She witnessed most of the vehicles drive off northbound on S. 13th St. towards W. Oklahoma Av.

PACACIOUS stated that she has seen two of the vehicles on numerous times at the location. There was a silver boxy shaped vehicle with tinted windows and a white vehicle believed to be a Chrysler 300. She stated that she's called the police a few times regarding the bar and its patrons because events like she described are happening every other week. When I asked her about the involvement of the bartender and owner she stated that they would just get everyone out the bar and close the door. PACACIOUS had no further information regarding.

Interview of FONSECA

I then spoke with the other caller Mariela FONSECA (F/W 05-07-93) that stated she lives at 3224 S. 13th St, in the City of Milwaukee. FONSECA stated that she called because she was woken up by the sound of music and people being loud. She stated that every other weekend she is woken or disturbed by the people leaving at bar close. She stated on 09-07-19 she looked out her window and observed approximately 25 people in the street and outside the bar. FONSECA stated they were playing music from their vehicles with females hanging in and out the sunroof. Two males were fighting while others tried to involve themselves in the fight. She stated after placing a call to police the subjects left 2 minutes later, right before police arrived. When I asked her about the involvement of the bartender and the owner she stated they were standing outside watching and didn't do anything to stop the subjects. When the subjects starting driving off then they got in their vehicles and also left. FONSECA last stated that events like this mostly take place on Saturday night after bar close.

It should be noted that the above listed information is based off statements from the callers of the original call for service.

No further information regarding at this time.

This report is written by P.O. Mark SHEREMETA, assigned to District 6, Late Shift.

On Sunday, October 06, 2019, at 1:01AM, Squad 6367 (myself, in full duty uniform, equipped with BWC, and operating a marked MPD squad) was flagged down at 3219 S 13th Street (Buckshots Bar) by the bar owner David N. NUNEZ CRUZ (W/M, 03-06-61) for a Trouble With Subject complaint.

Upon stopping, I observed NUNEZ CRUZ pointing at a B/M subject with no shirt on, saying "I told yu I was gonna call the police." The B/M subject, later identified as Kionte R. PERKINS (B/M, 12-19-91) began walking southbound on S. 13th Street (away from my squad). I called for an additional squad to assist, and told PERKINS to stop walking, which he eventually did. PERKINS came back to me, and proceeded to tell me that he was in a fight outside the bar with an individual who is probably no longer there. PERKINS was highly intoxicated and very sensitive to whatever was being said to him. PERKINS was also bleeding slightly from his nose.

After talking to NUNEZ CRUZ about what had occurred, it appeared that PERKINS had started the incident by grabbing a second individual's shirt and getting physical with them. NUNEZ CRUZ also stated that the other individual had left. NUNEZ CRUZ also stated that both individuals involved had been patrons of the bar prior to the incident, and that PERKINS was asked to leave the bar prior t o the incident as well.

After confirming that PERKINS did not appear to want to have tickets issued in this matter, I informed him and his friend/brother "Nicholas" that they could go in a cab that "Nicholas" had called for them.

It should be noted that as "Nicholas and PERKINS were walking to the cab, they both became agitated, and were yelling at the people standing outside the bar's front door. At this point I gave both "Nicholas" and PERKINS a very loud and stern final warning to leave. They both complied.

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MDVR ability.

On Sunday, October 13, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. Shawn SWITZER. At approximately 2:20am squads responded to multiple calls for Shots Fired at 3224 S. 13th St. in the City and County of Milwaukee. During the investigation it was determined by officers that this incident stemmed from occupants leaving a nearby bar. The bar related to this incident is identified as Buck Shots at 3219 S. 13th St. in the City of Milwaukee. We were able to respond to this call and were tasked with filing a license premise report. As we began to gather information regarding this incident from officers on scene and citizens we were pre-empted to handle other primary pending calls for service.

This license premise report is based on officers filed reports.

Regarding the call for service there were approximately 4 different callers reporting 3 to 4 shots fired in the 3200 block of S. 13th St. Squads that responded and assisted in this call are listed below:

Det. ANDERSON conducted an interview with the bar owner David NUNEZ-CRUZ (M/W 03-06-61). NUNEZ-CRUZ stated that he began the process of closing the bar down at approximately 2:10am. He stated that there were approximately 30 to 40 people that he had to be escorted out the bar. As the crowd vacated the bar he then observed a fight taking place involving some of the patrons. NUNEZ-CRUZ stated that there were 10 to 12 people beating on one male across the street from the bar. He then stated that he and his bartender that night Viviana M. SEDA (F/W 02-24-82) went across the street to break up the fight. After the subjects were separated they began to walk their separate ways, NUNEZ-CRUZ and SEDA returned inside the bar. Minutes later he heard several shots being fired nearby. He stated that he did not know who started the fight or who was shooting. NUNEZ-CRUZ did work with officers and detectives by making a statement and providing video surveillance. SEDA was also interviewed by Det. ANDERSON and gave similar statements.

While squads investigated the shots fired call there was a related call for service at St. Lukes Hospital 2900 W. Oklahoma Av. in the City of Milwaukee for a shooting victim. Sgt. BENITEZ responded and was able to identify the victim as Zachary WAITE (M/B 4-15-99). WAITE was seen in room #4 at the hospital and had one gunshot wound to his sheen on his left leg. Through an interview with WAITE it was determined that he was a victim of the shooting that took place at 3224 S. 13th St. It should be noted that WAITE multiple times denied being involved in the incident. Per Det. MARTIN speaking with Sgt. PIERCE the video surveillance showed him in the bar and also being involved in the fight. NUNEZ-CRUZ also confirmed with Sgt. PIERCE, WAITE's involvement in this incident. WAITE was arrested for obstructing and was later interrogated for the charge by Detective Mark HARMS. WAITE stated that he was in the bar for approximately an hour. At approximately 2:00am a fight broke out outside and he involved himself, fighting with a Hispanic male. WAITE stated he did not know who the guy was he was fighting but stated he has seen him before at the bar. He then stated that the owner broke up the fight and as he walked away he heard two shots and was shot in the leg. He stated he did not see who did the shooting. He was conveyed to St. Lukes hospital by his play cousin later identified as Marilena CASTILLO (W/F 09-07-96), who he was at the bar with.

This incident is still currently being investigated for suspects and additional follow-up.

It should be noted that this is the 3rd call of shots fired related to this bar within a month and a half. Also this bar is currently being processed to be tagged as a nuisance property due to the type and number of calls associated.

Regarding this call I am also currently conducting follow up due to the age of the shooting victim (20). A citation is pending for city ordinance 90-19-1, Presence of Minor at License Premises and possibly ordinance 90-18-1-a-1, Sale of alcohol to Underage Person.

**** Supplemental Report ****

This supplemental report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

After following up on reports written by Officers and Detectives regarding a Shot Fired call for service, there was an identified subject struck by a round. The victim involved in this Recklessly Endangering Safety incident was a Zachary M. WAITE (M/W 04-15-99). Within reports filed there were statements made by both WAITE and the owner/agent David NUNEZ CRUZ (M/W 03-06-61).

WAITE admitted to being in the tavern from 1:00am to close and being involved in a fight that carried outside. After he was separated from the person he was fighting with he heard several shots being fired. Momentarily WAITE realized he had been shot once to the left leg and left the scene arriving at St. Lukes Hospital for medical attention.

NUNEZ CRUZ stated that WAITE had been at the tavern a few times in the past and recognized him by the nick name "Sack". NUNEZ CRUZ did provide video surveillance to investigating squads that showed WAITE within the tavern also.

On Wednesday, October 23, 2019 I conducted follow up regarding the age of victim and the fact he was in the tavern. At approximately 11:35pm P.O. DEL MORAL and I went to the tavern location of 3219 S. 13th St. and spoke with NUNEZ CRUZ. NUNEZ CRUZ stated that WAITE who he knows as "Sack" first came into the tavern a few months ago. He stated that he remembers WAITE showed him a Wisconsin ID card that read he was over 25 years old. I notified NUNEZ CRUZ that WAITE was 20 years old and issued him a citation for "Allow underage on premise" cit#J980W3KD9V.

WAITE was also issued a citation for "Presence of Minor/Underage-1st" cit#J980W3KD9W.

On Thursday, November 07th, 2019 at 3:00pm, at 3006 S. 27th St. (District 6), we conducted a meeting with the Owner of Buckshots Bar.

In attendance was Captain Kristin RIESTRA, Sgt. Christopher McBride, Sgt. Chad RADEN, Police Officer Fabian GARCIA, David N. NUNEZ-CRUZ, Brenda J. RADKE (F/W, 08-22-1964), and myself. Alderman Tony Zielinski was scheduled to attend but cancelled at the last minute.

The meeting was held in the assembly room of District 6.

All parties sat down and discussed the issues at and around 3219 S. 13th St., Buckshots Bar. NUNEZ-CRUZ stated he has been in business for many years at the location. NUNEZ-CRUZ stated as bars in the area close, it creates a new clientele for his bar. NUNEZ-CRUZ stated he has observed a younger crowd in his bar more often.

NUNEZ-CRUZ stated they changed their cost for shots from 1 dollar to two dollars and raised the price of their drinks. NUNEZ-CRUZ stated he has noticed a decline in business but hopes this will keep the trouble away.

NUNEZ-CRUZ submitted a Letter of Intent regarding improvements to the business. Collectively we discussed the letter and encouraged NUNEZ-CRUZ to follow through with his intent. NUNEZ-CRUZ was advised that District 6 would come out to Buckshots and discuss further security plans per his request.

Letter of Intent from NUNEZ-CRUZ read:

Being more aware of what is happening inside the business

By maintaining capacity, turning people away especially if they caused problems in the past.

Checking identification of every customer after 10pm. (NUNEZ-CRUZ was advised to check during all hours of business)

Actively using metal detector to ensure weapons are not being brought onto the property. Calling our local police to report if any weapons are found. (NUNEZ-CRUZ was advised to have signage referencing No Firearm and Metal Detection policy)

Having a bouncer/security person at the door to help maintain crowds from congregating loudly outside business after 10pm. (NUNEZ-CRUZ was advised to make sure security was identifiable, i.e. security shirts)

Immediately calling the local police to report any issues inside that escalate to more outside.

Closing the business 30 mins to an hour earlier to disperse crowds.

Knowing we are responsible for what is happening outside the business

On Saturday February 22, 2020 at approximately 7:59 PM the following squads: 6269(ALMAS, H/LAFOND, R), 6250 (JOHNSON, B) and 6468 (BUNKELMAN, J/YANG, J) were initially dispatched to the area of S. 13th St and W. Euclid Ave to investigate a fight complaint,

Upon arrival I observed multiple intoxicated subjects in front to Buckshot's Bar. Patrons indicated the alleged actor ran W/B on the alleys towards S. 14th St, some patrons indicated the actor's ran N/B in the alley between S. 13th St and S. 14th St. I quickly searched the area for possible actor's and did not locate any actors who were involved in the physical fight. The CAD indicated that there were more than 10 subjects fighting in the street in front of Buckshot's bar. I along with P.O.'s LAFOND and JOHNSON went into the bar to make sure there were no injured persons inside the bar. I had determined that any possible actors had left the establishment. I then made contact with a heavy set H/m who was tending bar who is identified as Rafael A CAJIGAS (H/M 10-26-62). I asked CAJIGAS what had occurred inside the bar. CAJIGAS stated "I didn't see anything". I stated to CAJIGAS, you are working behind the bar when this incident occurred and you didn't see anything. CAJIGAS then became uncooperative and refused to answer any more questions. I then spoke to the manager who is identified as Lisa M MOORE (F/W 7-12-77). MOORE indicated that there was a 50th Birthday party inside the bar. MOORE stated there was a group of males and females who began to argue. MOORE stated that the argument turned physical. MOORE stated that when the physical altercation began the physical fight was pushed outside the bar onto the City streets. I then asked MOORE for licensing information regarding Buckshot's bar. - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
