At about 9:15PM Thursday night, I drove down to house in the valley to drop off some of her medicines I picked up for her from Walgreens at her house. I told her husband Paul that I was hearing weird loud sounds coming from 35th Street almost loud cars and music which is I am used to traffic noise but tonight was different. I just felt like something was brewing up here. This was before this homicide happened at the gas station. I was on Facebook on a site call USFir which lets you know when police or fire are called out to a scene and then I came the shooting at the gas station on the corner of 35th and Park Hill Avenue. If anyone went onto that USFir page on Facebook they will see people posting comments and there was one woman who was filming it and putting it live on Facebook. What that woman did was so disrespectful speaking as a human being but also as a funeral director who takes care of families who lose their loved ones in this manner. I then went outside to see the pictures you are seeing that I have attached. The fact

that there were so many people treating this like a regular occurrence and that they had the right to come to this neighborhood and be rude and disorderly. I gave the operator the description of the vehicle, along with the license plate number and asked if she could ask the one of the police officers at the scene to clear out at least my driveway. As I was waiting at three to four thugs at the point decided they needed to question if I called the Police which I didn't answer. They proceeded to verbally attack me by calling me a bitch which I don't take lightly. I will not tolerate this kind of garbage in my neighborhood and in my opinion should still get a ticket since the plate number was given to operator and I got called names and harassed because I had to pick up someone who died from a nursing home.

I know in the last couple of weeks I have voiced my concerns to your assistant Alderman Murphy about what I have been seeing happening at the gas station. I am out at all hours day and night from being a caregiver for my mom since my dad just died on August 19 plus due to my job. I know that this gas station falls under Alderman Bauman's district but the owner of the gas station owner named Mandeep also owns the big building on my corner at 3504 West Park Hill Avenue along with the duplex immediately to the east of me at 3516-3518 West Park Hill Avenue. The gas station is a nuisance and should not be able to operate 24 hours a day. I have been at that gas station to fill my tire with air on another location only to see women dance on hoods of cars and car top in way children shouldn't see. And no one who works at the gas station came outside to stop it though the owner has a security person there plus he has cameras that he can see what is happening at different angles. I know for a fact that someone overdosed in a véhicle while at the gas station a few years ago and died right there in the parking lot because when I as on my way home from work I saw one of the medical examiner investigators I knew from my job while I was sitting at the stoplight to come home doing their investigation. I strongly believe but more so know that this gas station has added more people coming onto my little block for drug deals which has been on the rise for the last year and a half at least. It is easy on and easy off of the freeway. The deals at been going on in front of 3530 West Park Hill the longest. And now I have noticed them all the way back to 3504 West Park Hill which is his property. I have gone as far as asking Mandeep to put additional lighting on his properties because they are so dark,


I know that Mandeep wants to put some type of restaurant or take out place at 3504 West Park Hill Avenue and I am completely against that. He can not safely manage what he currently owns. I believe there is drug activity and possible gang activity with his upper duplex at 3518 which I have told him about which he does nothing about. He has gone as far as asking me if the property owner at 3530 West Park Hill is around that he wants to meet her to buy that property since it has been vacant for so long which is another whole story. Mandeep also told me that if I ever decide to sell my house to let him know because he would buy my house.


So with everything said, I am getting closer from leaving this Merrill Park home that my grandparents purchased in 1949 even before the freeway was put in front of the house. My grandparents raised their 8 children here and both of my grandparents died in this home. My dad who just died grew up literally around the block at North 36th Street and his mother (my grandmother) couldn't take care of the big duplex. My parents both attended St. Rose grade school, were married there 50 years ago this year and buried their 5 year old son from there. The rich history of this Merrill Park neighborhood has a special place in my and my family's heart and that is why I chose to purchase this home after my grandpa died in 1998.


By the way if you are a Facebook user please take a look at what was posted on the USFir site and look for the user name Antoinette Jeanes. She posted onto that site from someone's personal page what they were seeing while they were standing right in the street in front of the gas station. No regards to police trying to their job or the dignity of the person who died whose family perhaps was not yet notified when they it media-worthy to post the dead body on the ground at station. As a funeral director may that person never be the one who loses someone due to a homicide. I have sat across from numerous families who have lost someone from due homicide and it is one of the most senseless deaths there is and nothing I can do console them. When I saw the crime scene plastered on social media, my first thought is that I hope all those individuals have nothing better to do with their lives and I hope to God this does not ever happen to them.





2. On 09/10/19 Milwaukee Police Officers were dispatched to the location 200 N. 35th St, regarding a strong arm robbery complaint. The complainant stated to officers that two suspect took \$700.00 dollars in cash from him outside of the location. Subsequently the complaint admitted to the officers that he was at the location in an attempt to purchase marijuana, from the suspects.

- 3. On 04/01/20 Milwaukee Police officers were at the location 200 N. 35th St., regarding a reckless use of weapon complaint. Officers interviewed the gas station security officer, who observed two subjects starting to fight with in the station lot. One subject left the area on foot while the other subject chased the subject with in a vehicle. Officers asked to review the video cameras but the manger was not scene. The gas station clerk was cooperative with officers by providing officers the cell number of the manager.
- 4. On 09/17/20 Milwaukee Police Officers were dispatched to a shooting at 200 N. 35th St. Upon arrival officers located the victim, who suffered multiple gunshot wounds, in the parking lot of the location. Milwaukee Fire Department was at the location and gave medical attention to the victim. The victim was later pronounced deceased at the scene. The investigation revealed that the suspect was legally armed with a fire arm at the time of the incident. Also the victim was the brother of the security guard, who was at the location visiting. The suspect was approached by several males including the victim. One of the subjects attempted to disarm the suspect, and the victim pointed his fire arm at the suspect. The suspect was able to produce his firearm and fired several gun shots, striking the victim. The suspect then fled the location on foot. The owner arrived at the location and assisted officers with surveillance video of the incident.

This report is being written by Police Officer Rachel BRUMAGE, Assigned District 3, Early Shift.

On Tuesday, September 10, 2019, at approximately 6:57pm, while on patrol, Squad 3251, Police Officer LaCarlin DAVIS and I were dispatched to 200 N 35th St, in the City and County of Milwaukee, WI to investigate a strong arm robbery.

Upon arrival, I interviewed the subject identified as Richard A BARNES (B/M DOB 10/18/1975) who stated that he had been robbed at the above listed location and that the suspect(s) took \$700 from his vehicle. BARNES stated that the suspects' vehicle was parked at pump two and the vehicle is described as a grey Monte Carlo 2 door. BARNES described suspect number one as a B/M 5'9 180, pounds, medium built light skinned, wearing a black baseball cap, black t-shirt and black shorts. Suspect number two is described as a B/M 6'0 170-180 pounds, medium built, dark skinned, wearing a white t-shirt, and light blue jeans. BARNES stated that at approximately he arrived at the above listed location to purchase cigarettes. BARNES stated that suspect one approached his driver side window and stated "what's good playa, what's with all this cash"? BARNES stated that there was \$700 in unknown denominations sitting on top of his dash board. BARNES stated that he had just cashed his pay check, and that is where he placed the cash. BARNES stated that he jumped out of his vehicle to chase suspect one in attempt to get his cash back. BARNES stated that as he was walking behind suspect one and suspect one swung at BARNES with his right closed fist striking BARNES in the right side of his face. BARNES stated that a fight ensued with suspect one and BARNES, which is when suspect two came behind BARNES and put BARNES in a head lock. BARNES stated that he was able to pry suspect's two hands from around his neck. BARNES stated that suspect one got into the driver's seat and drove off. BARNES stated that he got a hold of suspect two shirt to prevent him from not going anywhere, eventually BARNES let go of suspect two's shirt. BARNES stated that he went home to let his wife inside the house. BARNES then went back to the above listed location to see if he could find the two suspects. BARNES stated that he went down the alley located north of the gas station. BARNES stated that he went down the alley three times was unable to located the suspects.

During the investigation, BARNES stated that he was at the above listed location to meet the suspects to purchase marijuana.

It should be noted there has been numerous drug arrest at the above listed location.

On Wednesday, April 1st, 2020 at 8:36 PM, Squad 3465, P.O. Larry LEIBSLE and I, responded to 200 N 35th St, The Hometown Gas Station, to assist Squad 3490, P.O. Taylor ZUBE and P.O. Nashata NORWOOD, with reckless use of weapon complaint.

During the course of the investigation I spoke to security at Hometown Gas, Alexander R MANNAN (M/B 11/9/99) who stated that he works for the gas station as security and he noticed two subjects start fighting in the parking lot of the station. MANNAN stated that he noticed it first when the male subject threw something at the female subject. MANNAN stated that he did not see if it hit or not but believed it was a shoe. MANNAN stated that the female then tried to throw gasoline on the male at which point the male threw some other objects at the female. MANNAN stated that the female then got into the vehicle and started to chase the male subject out of the parking lot and down the street. MANNAN stated that he did not call but he had the attendant call.

I asked if either subject had access to the surveillance system but they both stated that the manager is the only one and gave me a number of 1-262-617-8911 but I did not receive an answer upon calling multiple times. A message was left regarding.

Both subject regarding this incident were located down the street at approximately 250 N 35th St in an open lot. The male subject was identified as Ricky L SHELTON (M/B 1/15/67) and the female subject was identified as Latasha N GORDON (F/B 10/18/76). SHELTON stated that after an argument over him being on the phone with another female she tried to run him over with her car and chased him into the open lot where she drove in circles trying to hit him. GORDON stated that the argument started over SHELTON not getting out to pump the gas and that he had hit her during the argument so she tried to chase him down.

GORDON was arrested for 2nd degree Reckless Endangering Safety.

This report was written by P.O. Karlee CABRAL, assigned to District Three, Early Shift.

On Tuesday, September 17, 2020 at approximately 10:21 PM, P.O. Max CZISKE and I were dispatched to a Shooting at Hometown Gas Station, located at 200 N 35th St in the City and County of Milwaukee.

Upon arrival, officers located a subject, who suffered multiple gunshot wounds, on the ground in the business parking lot. Several officers performed lifesaving measures until the Milwaukee Fire Department responded. They then performed additional lifesaving measures, but the subject was later determined to be deceased.

Through an investigation, it was determined that the homicide suspect was the brother of the security guard and was visiting him at work. At the time of the incident, the suspect was legally armed with a firearm. While at the location, the suspect was approached by several males, one being the homicide victim. One of the males attempted to disarm the suspect, and the victim pointed a firearm at the suspect. The suspect then was able to produce his firearm and fired several shots at the victim. The victim was struck several times by the gun fire, and the suspect fled the location on foot.

The employee of the business was cooperative with officers and contacted the owner/licensee to show officers video surveillance of the incident. The owner/licensee later arrived on scene, was cooperative with officers and was able to assist with the surveillance video.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
