Proposed Settlement of claims against the City of Milwaukee and a police officer in the lawsuit, *Estate of Sylville K. Smith, et al. v. City of Milwaukee, et al.*, Case No. 17-CV-862-LA

Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary and Legislation with the below recommendation. A companion resolution to authorize contingent borrowing to fund the proposed settlement will be filed separately and should be referred to the Finance and Personnel Committee.

The incident at the basis of this lawsuit occurred on the afternoon of August 16, 2016. Officer Heaggan-Brown, along with two other officers, was on an overtime detail near Sherman Park. During the course of his duties and during his attempt to arrest Mr. Smith, Officer Heaggan-Brown shot and killed Mr. Smith. Mr. Smith's Estate, as well as his mother and father, individually, brought a lawsuit in federal court claiming that, now, former Officer Heaggan-Brown used excessive force in violation of the Fourth Amendment. Further, the Complaint asserts several state law claims relating to the shooting.

After unsuccessfully moving for summary judgment on the basis of qualified immunity, the parties agreed to undertake mediation in an effort to resolve this matter short of trial. On the advice of the mediator and with the risks of trial in mind, the parties engaged in settlement discussions and Plaintiffs agreed to settle the entire case for a total of \$4,000,000.00, which includes attorneys' fees and costs.
