Also, I am attaching some photos at other sites installed by Sunvest Solar.

Does this mean there will be 335 units lined up along 33rd Street? This is the solar array size electrically and 848 panels will be mounted on steel structure approximately 7'-0" height at a 25 degree angle. Please see attached photos attached above.

Will they be the same as the units installed across State Street to the north? Yes, it is the same panel and steel structure mount.
