Brian stated that there has been concerns with the landscaping around the parking lot, but no other issues that he knows of. He stated that he wanted to reach out to the police department to see how his company could be proactive and work with the police on keeping the area safe.

A survey of the area is described as, a flat lot on the south-east corner of Old World Third and W. Juneau Ave. There is a fence approximately Three feet high that encloses the north and west ends of the lot with and access point on the west end. The east side of the lot is open and abuts the river walk. There is a curb cutout and entrance on the Old World Third Street side which is shared with the neighboring building. There is a pay station at the entrance.

Brian Stated that there is an onsite attendant Monday through Friday 7:00AM to 1:00PM. A Parking enforcement person monitors that lot and three others within the area, weekdays 8:00AM to Midnight, and weekends until midnight or 1:00AM.

Brian plans on installing cameras to monitor the lot. We discuss the placement of the cameras, but at this time he is not certain where the cameras could be placed. I asked him to affix the lot's address to a lamp pole at the entrance of the lot and at the pay station. Also he was advised to place the Police non emergency and 911 numbers on the pay station.

The hearing before the Licenses Committee will take place virtually on 12/1/2020 at 2:35 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
