RE: DISCIPLINARY ACTION

Core Value 3.00 – Integrity, referencing Guiding Principle 3.01: Behaving in such a way that discredit could be brought upon the department.

Core Value 3.00 – Integrity, referencing Guiding Principle 3.05: Failure to obey local ordinances and state laws.

Core Value 5.00 – Respect, referencing Guiding Principle 5.01: Failure to be courteous and professional.

The charges having been substantiated, he is found guilty as charged and the penalty adjudged appropriate by the Chief of Police is as follows:

Behaving in such a way that discredit was brought upon the department.

Fifteen (15) day suspension without pay.

Failure to obey local ordinances and state laws.

Fifteen (15) day suspension without pay.

Failure to be courteous and professional.

Fifteen (15) day suspension without pay and retraining in Professional Communications.

It is hereby ordered that POLICE OFFICER MATTHEW M. WILLMANN receive retraining in Professional Communications relative to the above charge. It is further hereby ordered that POLICE OFFICER MATTHEW M. WILLMANN be suspended for a total of forty-five (45) working days without pay. If not appealed, said suspension is to be served during the following periods: January 17, 2021 through January 30, 2021; February 14, 2021 through February 27, 2021; March 14, 2021 through March 27, 2021; April 11, 2021 through April 24, 2021; and May 9, 2021 through May 14, 2021.
