- 1. On 11/01/2019 officers were dispatched to an Overdose at 5505 W. Lisbon Av. The officers located a subject who had overdosed on Heroin. The subject was medically cleared and arrested for Possession of Controlled substance.
- 2. On 07/14/2020 at 1:25am a subject walked into District 3 station to report a battery that just occurred at the Clark gas station at 5505 W. Lisbon Av. The victim stated he was intentionally struck in the face with an unknown object. The victim suffered multiple facial fractures. Officers went to the location and located where in the building the incident occurred. The officers were informed the video system does not work.
- 3. On 09/14/2020 at 8:44pm officers were dispatched to Clark Gas Station, 5505 W. Lisbon Av, for an Armed Robbery call. The victim stated he was inside the store when an armed subject approached his wife, who was sitting in their vehicle which was parked by the gas pumps. The suspect took the victims auto and fled the scene. The applicant was on scene and provided video of the incident.

St in the city and county of Milwaukee. At approximately 1:25 AM, Reginald A. PRYOR walked into the District 3 front lobby. PRYOR stated an unknown subject intentionally and without consent struck him multiple times in the face, with an unknown object at the Clark Gas Station located at 5505 W. Lisbon Av on 07-14-20 at approximately 1:20AM, in the city and county of Milwaukee. PRYOR was conveyed to Mount Sinai Hospital by Curtis Ambulance 313 for treatment, where he was admitted at 1:58 AM and treated by Dr. Robert DEAN.

At approximately 5:00AM, I was informed by a nurse at Mount Sinai Hospital that PRYOR suffered multiple facial fractures and will be conveyed to Froedtert Hospital for further evaluation.

Squad 3390 (P.O. Brian MADDOX and Matthew SCHLAX) went to the incident location to check for a scene and possible video. They found the scene, which was located in the southeast corner of the building. However, they did not locate any evidence (blood and weapon) regarding the substantial battery. They were also informed that the on-duty clerk was not able to operate the video surveillance system.

Squad 3193 (CSO NASH) conducted follow up and was informed by the dayshift clerk that PRYOR does not work at the gas station and the business lets him hang out there. NASH was also informed that the video surveillance system for the incident location does not work.

City and County of Milwaukee, to investigate an armed robbery call for service.

Upon arrival, I spoke with the gas station clerk, who was identified as Ish DHAWAN (W/M, 06/13/79), who was cooperative and provided me with video footage of the incident. Footage showed an armed suspect approached a parked car at the gas pumps. The suspect robbed the passenger and took the vehicle.

I spoke to the owner of the vehicle, who was identified as Channing A. ADAMS (B/M, 10/07/89), who stated he was inside of the gas stations purchasing some items when the incident occurred. ADAMS stated he went inside the gas station and left his wife in the vehicle alone. ADAMS stated he parked at pump five facing north bound towards W. Lisbon Avenue and his wife was sitting in the front passenger seat.

ADAMS stated he witnessed his vehicle which he identified as a Grey Audi A5 with WI auto plate AEV-6609 flee from the scene at a high rate of speed heading east bound on W. Lisbon Avenue. ADAMS stated he did not see the suspect at all.

ADAMS stated he went inside the gas station to purchase a bottle of minute made soda and a bottle of cranberry juice. ADAMS stated he also paid for gas and gave the clerk \$15.00 in U.S. currency.

The hearing before the Licenses Committee will take place virtually on 1/5/2021 at 10:10 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
