This report is written by PO Corianna Cavazos, assigned to district 3 modified early shift. On Friday, January 31st 2020, while assigned to squad 3264, myself, Officer Michael Jones (Squad 3272) and Officer Randall Perez (Sqd 3270) responded to the Citgo gas station located at 5758 W Appleton Ave for a "Subject with Weapon Call".

PO Jones and I arrived on scene at 18:11. Upon arrival, we spoke with the store manager, Riaz A BUTT (WM, 04/12/62) who stated that a panhandler had come into the store earlier in the day and was trying to steal items from the store as he had done in the past. RIAZ stated that the store employees locked the door so that the subject could not leave with the items. RIAZ stated that when the subject put the items down, they unlocked the door to let him out of the store. RIAZ stated that the subject returned to the store a little bit later armed with a baseball bat and threatening the store employees because he was mad about the earlier incident. The subject then fled the scene prior to police arrival.

RIAZ stated that he did not know the subject's full name but was familiar with him because he was a chronic problem at the location. RIAZ was helpful with the investigation and willing to cooperate with police. RIAZ stated that he would be willing to pursue a restraining order if he can get the actor's contact information. RIAZ was also able to pull up video of the incident to show officers on scene.

This case was given a C3 by the primary investigating officer, Officer PEREZ.

The following is a copy of the incident report:

"This report is written by Police Officer Ethan SCHLAX, assigned to District 3, Early Shift.

On Sunday, March 22, 2020, at approximately 7:06 PM, squad 3220 (PO Samuel RODRIGUEZ and I) was dispatched to a robbery call for service at 5758 W. Appleton Ave, which is located in the City and County of Milwaukee, Wisconsin. Squad 3240 (PO Karlee CABRAL and PO Zachary Szalacinski), squad 3281 (PO Jeffrey JOPP and PO Alexander VERREAULT), squad 3284 (PO Joshua KRANZ), and squad 3217 (PO Guadalupe VELASQUEZ), also responded to assist with the investigation and saturation for suspects. Through investigation, it was determined that this was not a robbery and would only be a property damage complaint.

Interview of Kamran WADOOD (a/m, 04-23-92):

Upon our arrival, I spoke with one of the witness, Kamran WADOOD (a/m, 04-23-92), who stated that he witnessed the incident. WADOOD is an employee at the gas station and works as a cashier. WADOOD stated that at approximately 7:00 PM, he observed 2 males enter the gas station and go to the 2 gaming machines that are right by the door along the west wall of the gas station. WADOD described one subject as a black male, 20-25yoa, 6ft 2in, wearing a black jacket, black pants, a mask covering half of his face, and armed with a sledge hammer. WADOOD described the second subject as a black male, 20-25yoa, 6ft 2in, wearing a black jacket, black pants, and a mask covering half of his face. Both subjects had their hoods up and were wearing gloves.

WADOOD stated that the subject with the sledge hammer began to swing the hammer at the machines, causing damage and putting holes in them. WADOOD stated that they broke both machines. The subjects then tried to reached in to the machine and grabbed 2 black plastic boxes. WADOOD stated that these boxes typically have money in them, but they were empty. WADOOD stated that the subjects dropped the boxes and left the store walking northbound towards W. Center St.

Interview of Signh GURDIP (a/m, 05-10-59):

GURDIP stated that he is also an employee and was working as a cashier during this incident. GRUDIP stated that all he knew was that 2 males entered the gas station and began to smash holes in 2 gaming machines. GURDIP could not provide any more information than this.

Review of video surveillance footage:

We were able to view surveillance video of this incident from inside and outside of the gas station. This video shows three subjects approach the gas station walking from the intersection of N. 58th St. and W. Center St. at 7:00 PM and enter the store. The description of the subjects are as follows:


