The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/10/09 at 5:31am, officers were dispatched to 3033 W. Lisbon Ave. (Lisbon Gas & Food) for a subject with a weapon. When officers arrived the suspect surrendered and told the officers where the knife was that he used to threaten the clerk. That knife was found in his back pocket and another knife was found in his coat pocket. The clerk stated to officers that he recognized the suspect as a person who shoplifted at the store a few days earlier, so when he observed the suspect pick up some items today he locked the door. The suspect did attempt to leave the store without paying and when he couldn't, he reached into his pants pocket and pulled out a knife pointing it at the clerk.

5. On 08/21/13 officers investigated a Stabbing that occurred at 1:15am in the parking lot of Lisbon Gas and Food at 3033 W. Lisbon Ave. Officers spoke to the on duty security guard regarding the incident. The security guard stated the stabbing did occur at this location. He further stated he already cleaned up the blood and no one called the police because the victim drove away.

The officer spoke to the on duty clerk who stated he did observe an altercation inside of the location, but once the subjects left the store he didn't see or hear anything else until his security told him what happened outside. The clerk stated he told the security guard to clean up the blood.

A detective did view the surveillance video, which captured the incident. An altercation began inside the store and spilled outside where the stabbing occurred. The detective also spoke with the security guard who stated he did observed the stabbing.

- 7. On 10/18/17 a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a property damage complaint. Officer's interviewed an employee who said that the employee on another shift called in the complaint and that employee stated that a black male and black female entered the parking lot of the establishment in a white four door sedan. The female entered the store and attempted to take an item without paying. The employee locked the front door of the establishment so the female was unable to leave the store with the merchandise. The black male then rammed the front door of the establishment with his vehicle causing the door frame to bend and allow the female to escape. The employee was unable to retrieve a registration plate number and could not operate the surveillance system. No suspects were taken into custody and an Incident Report was filed (172910170).
- 8. On 01/13/18 at 12:53am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, the subject left the location and no incident report was filed.
- 9. On 01/21/18 at 12:42am, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler) Upon Squad's arrival, the subject left the location and no incident report was filed.
- 10. On 01/31/18 at 2:00pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandler). Upon Squad's arrival, they interviewed the employee/caller who said that a black female entered the store begging for money. The subject left the location before squad arrival and no incident report was filed.
- 11. On 02/16/18 at 10:03pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject (panhandlers) complaint. Upon Squad's arrival, the subject left the location and no incident report was filed.
- 12. On 03/04/18 at 5:37pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for a trouble with subject complaint. Upon Squad's arrival, the officer's interviewed the employee/caller who stated that a black male was loitering on the property, doing drugs, and refusing to leave. The subject left the location before squad arrival and no incident report was filed.
- 13. On 03/06/18 at 5:15pm, a Milwaukee Police Squad was dispatched to 3033 W. Lisbon Avenue (Lisbon Gas and Food) for an injured/sick person call. Upon Squad's arrival, the officer's found a subject, outside the establishment trembling and shaking. The subject was unable to comprehend the officer's questions, so one of the officers entered the establishment and talked with the clerk who said he has observed the subject before and has seen his body shake in the past. While one officer was talking with the store employee the subject told the other officer that he was feeling suicidal and wanted to go to a Milwaukee County Mental Health Facility. Officer's conveyed the subject to the facility but while waiting to enter, the subject's health worsened and one of the officers called for medical attention. Wauwatosa Fire Department arrived on scene and conveyed the subject to Froedtert Hospital.

14. On 05/04/19 a 16-year-old working in conjunction with Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars at 3033 W.

Lisbon Av. The sales clerk admitted to selling the item. A citation of Sale of Cigarettes to minor/underage was issued.

15. On 07/27/19 officers were flagged down by citizens regarding a fight complaint outside the location of 3033 W. Lisbon Av. Officers stopped the juveniles who were then transported to their homes.

- 16. On 12/07/19 at 2:44am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a theft complaint. Investigation revealed that a subject entered the store and took product without paying for them. Officers were given a description, checked the area, and found the subject still in possession of the product. The subject was issued a citation and the product was returned.
- 17. On 06/13/20 at 5:21am, Milwaukee Police were dispatched to 3303 W. Lisbon Avenue for a ShotSpotter complaint. Investigation revealed that a group of about 15 people were in the lot when there was an argument between two of them. One of the persons had a handgun and was sitting in his vehicle when he fired one shot at the person he was arguing with. Everyone fled the scene and on casing and one fired bullet was recovered. The employee was able to provide video surveillance.
- 18. On 07/01/20 at 12:53am, Milwaukee Police conducted a license premise check at 3033 W. Lisbon Avenue. When officers entered the lot, they observed large numbers of vehicles and groups of people "hanging out". While officers were walking up the group entered their vehicles and left the premise. Officers interviewed the employee who stated that this is an ongoing problem with people in the lot and building. Officers left the premise to assist another officer just north of the location and when they returned, there was another large group of people and vehicles gathered inside the lot. Officers then entered the lot with their squad vehicles and, again, the vehicles and people left. The employee said this is an ongoing problem but he never calls police.
- 19. On 07/03/20 at 12:27am, Milwaukee Police conducted two license premise checks at 3033 W. Lisbon Avenue. The reason for the checks was because of the large amount of vehicles/people in the lot loitering throughout the nights. The first check lasted about twenty minutes and there were no problems observed or reported. During the second premise check there was a firework lit off in the parking lot and about 18 vehicles with 15 people loitering on the premise. The filling station employees have been advised numerous times to call the police when there are people loitering on the property but there were no calls for service from that location.
- 20. On 07/04/20 at 3:22am, Milwaukee Police, while on patrol, observed the filling station located at 3033 W. Lisbon Avenue had no lights on and about 20-25 vehicles in the lot with about 20 people loitering. Officers entered the lot and parked causing the vehicles/ loiterers to leave and the lights to the establishment came back on. There were no calls from the establishment for people and vehicles loitering.

21. On 09/25/20 at 2:41am, Milwaukee Police were dispatched to 3033 W. Lisbon Avenue for a Shot Spotter complaint. Investigation revealed that a subject was standing next to pump number 5 pulled out a firearm and fired shots toward a black sedan located next to pump number 8.

This report is written by P.O. Andrew DUDLEY, assigned to District 3, Late Shift.

On Saturday December 7, 2019 at 3:04 AM Squad 3321, P.O. Nathaniel PETERSEN and I, responded to a theft complaint at Express Convenience Gas Station located at 3033 W Lisbon Ave in the City and County of Milwaukee, State of Wisconsin.

Upon arrival we met with Akt CHODRI (w/m, 05/15/95), an employee at the store, who stated that a subject had intentionally and without consent taken a 12 pack of garbage bags past the last point of sale without paying for them. The subject had grabbed the product off of the shelf, quickly left the store and then fled the area. CHODRI placed the total value of the products taken at \$24.

CHODRI showed us the store's video surveillance of the incident which matched his description of the event.

As we were checking the surrounding area I observed a subject matching the person in the store's video, identified as Michael HAMBERLIN JR (b/m. 07/01/93). In the vicinity of HAMBERLIN I observed a plastic shopping bag overflowing with boxes of garbage bags that matched the ones sold at the store. When asked about the items HAMBERLIN stated that they were his but he did not have a receipt for them.

HAMBERLIN admitted to being at the Express station earlier in the night and that he frequently cleaned up garbage in their parking lot. He said that the store frequently paid him for the work with product from the store.

HAMBERLIN was issued a citation for retail theft.

10 of the 12 boxes of garbage bags taken we recovered and returned to CHODRI at the store.

This report is written by Police Officer Thomas WRIGHT, assigned to District 3, Late Shift.

On Saturday, June 13, 2020, at approximately 5:27am, Squad 3390, myself and P.O. Brian MADDOX, was dispatched to 3033 W. Lisbon Ave for a Shotspotter alert of 1 shot fired at 5:22am. Upon arrival a 9mm casing and fired bullet was recovered. Video surveillance of the incident revealed a black male subject, armed with a concealed semi automatic handgun, approaching several of the gas pumps and talking with people. The video shows him moving his car next to another patron at a different pump. The video then shows what appears to be an altercation between the other patron and the armed subject. As the other patron appears to be trying to enter the subject's vehicle or take something from him. The subject opens his car door and, while unseen, a gun shot is fired from his car, as the combative patron flees and all other patrons in the lot either duck or flee. Eventually both the combative patron and the subject with the gun flee the gas station at different times, both going west on W. Lisbon Ave. There are approximately 15 people at the gas station at the time of this incident.

I spoke with the clerk in the store, Varinder SINGH (m/a, 12/31/96), who stated he did not witness the incident. SINGH granted access to the camera system for the investigation.

This report is written by P.O. Taylor ZUBE assigned to District 3, Late Power Shift.

On Wednesday, July 1, 2020 at 12:50AM P.O. Andrew KEMPEN and I (Squad 3465) were instructed by District 3 Acting Lt. Sgt. BATTLES to conduct a check at the Lisbon gas station located at 3033 W. Lisbon due to a large number of cars in the lot and groups of people just hanging out. Upon arrival we were meet by Sgt. KINGSTON (Squad 3412) and P.O.'s Robert DAVIS and Jonathan STEINBERG (Squad 3441) to assist with getting cars out. As we all approached people entered their cars and exited the business. P.O. KEMPEN and I went into the store to make contact with the employee inside. P.O. KEMPEN spoke to Varinder SINGH (A/m, 12-31-96) who stated this is an on going problem and there are always people in the lot and around the building. As we left the location more cars started to come. We assisted Squad 3441 with a shotspotter that was just north of the location in the area of N. 30th and W. Brown St. which we thought was possibly related to the large number of cars in the area. After helping them P.O. KEMPEN and I along with Sgt. KINGSTON went back to the gas station at which time we observed there to be about 20 cars in the lot and about 30 people hanging around. We positioned our squad in the gas station parking lot in a manor which we could keep an eye on everyone and as soon as we did that people began exiting again leaving about 2 cars and 3 people in the lot. The employee had also locked the store door and was not allowing customers in. We stayed monitoring the crowd and cars coming and going until approximately 1:45AM with no further issues. It also should be noted that SINGH stated this is an ongoing problem with a large number of cars and people loitering however the gas station never calls in about loitering.

Between Friday, July 2, 2020 and Saturday, July 3, 2020 P.O. Lamar DENTON and I (Squad 3465) did 2 business checks at Express Convenience Gas Station located at 3033 W. Lisbon Ave. due to the amount of cars and people loitering through out the night. The first check we conducted at 10:38PM on July 2, 2020. While monitoring the gas station at this time there seemed to be just a regular amount of people coming and going from the gas station and nothing concerning. We monitored the gas station for approximately another 25 minutes with no problems.

With this location the most problems around midnight or just after. As we were driving eastbound on W. Lisbon Ave. at 12:27AM on July 3, 2020 a firework was lit off in the parking lot of the gas station and there were about 18 cars in the lot with about 15 people hanging out in the lot loitering. We parked across the street on W. Lisbon Ave. for approximately 10 minutes to start to have the crowd clear out. We then pulled into the gas station lot and monitored the crowd for another 30 minutes. It should be noted that there are no calls for service at this location regarding loitering or fireworks during the entire time we monitored the gas station. The gas station has been advised numerous times to call us when there were too many people in the lot or they are having issues with loitering, however the last few times we have checked the business there has been no other calls for service.

We did have the squad camera recording in vehicle 544 while conducting both of these checks that shows the amount of people coming and going and loitering in the lot.

On Friday, September 25th, 2020 at 2:44 AM, Squad 3330 (PO Lauren MAROWSKY and I) were dispatched to a Shotspotter call for service at 3033 W Lisbon Ave, which is in the city and county of Milwaukee. PO MAROWSKY and I arrived on scene at 2:49 AM, where we checked the area for casings. I located a casing on the northern part of the parking lot in between pump 5 and pump 8. I listened to the Shotspotter audio and heard about 5 shots being discharged. PO MAROWSKY and I continued to search the parking lot of the gas station for any additional casings but could not locate anymore.

PO MAROWSKY spoke to the gas station clerk. Varinder SINGH (M/A, 12/31/1996) who allowed us to view surveillance footage regarding the Shotspotter incident. PO MAROWSKY reviewed the video and passed along the information regarding the incident to CIB who took over the investigation.

The video showed a black male wear a gray zip hooded sweatshirt with a black shirt underneath, black jeans, white shoes with a full beard armed with a black semi auto handgun standing next to pump 5 and a silver sedan. The black male subject at about 2:39 AM pulls out a firearm and fires toward pump 8 at a black sedan that pulled in from the east side of the parking lot. The black male continues to discharge a firearm at the black vehicle until it pulls away heading eastbound on W Lisbon Ave.
