Please accept this letter and resume as my application for the Commissioner of Health. After spending the last ten years of my career as a county health official, and 2018-2019 as a Robert Wood Johnson Foundation Health Policy Fellow, I am eager for the opportunity to use my expertise in public health to serve the City of Milwaukee. I am passionate about public health, maternal and child health, violence prevention and health equity. As the Commissioner of Health, I would harness my passion and leadership skills to address the institutionalized and structural inequities that have led to Milwaukee to have the greatest health disparities in Wisconsin. I have listed what I have to offer below:

- Public Health Emergency Response: I am currently leading the response in both Washington and
 Ozaukee Counties. My decisive actions to prevent the spread of coronavirus in long-term care facilities
 was recognized nationally. We have led the state in contact tracing, transparent public information and
 guidance for businesses, schools and organizations.
- Standards and Strategic Leadership: I understand the broader organizational infrastructure and roles that support the public health system in a jurisdiction. I am an ethical, transparent and motivating leader who has transitioned an organization through difficult change while fostering teamwork.
