

INITIAL INVESTIGATION

This report was typed by P.O Jordon KUNYA, District 3, Early Shift. On Friday, November 8, 2019, at 4:13pm, while assigned to Squad 3220, P.O Jonathan CRUZ and I responded to a battery cutting, which turned into a child abuse incident, at 4737 W. Center St., also known as Hinnawi Meat & Deli, which is located in the City and County of Milwaukee.

Contact with SUSPECT (Erica MCDANIELS (F/B, 07-18-74))

On scene, I spoke with Erica MCDANIELS (F/B, 07-18-74). I explained to her who I was and asked her to explain the situation to me. While speaking with MCDANIELS, I observed a small bleeding wound approximately 1 1/2 inches long on her left eyelid. MCDANIELS stated that on today's date, at the above location, she got into an altercation with her niece, Avirria MOORE (F/B, 09-04-07). MCDANIELS stated that MOORE was upset because MOORE is a "problem child" and MCDANIELS refused to buy MOORE anything in the store. MCDANIELS admitted to open handed slapping MOORE, climbing on top of her when MOORE was on the floor, and restraining her in the store because she was "out of control.". MCDANIELS stated that during the altercation, MOORE used a mechanical pencil to stab MCDANIELS in the eyelid. MCDANIELS stated that she stayed away from MOORE and asked someone to call 911.

FOOTAGE

The business was equipped with surveillance footage which captured the incident. I observed as follows:

The time on the video during the incident is stamped at 17:05 (5:05pm). It should be noted that the surveillance cameras are one hour ahead of standard time. During the incident, I observe both MCDANIELS and MOORE, who are near the cash register of the business, and they appear to be in a verbal argument. During the argument, MOORE turns her back on MCDANIELS, and MCDANIELS responds by close fist punching MOORE in the back of the head. MCDANIELS then continues to slap and punch MOORE in the face, and MOORE begins to swing and punch MCDANIELS. I observe the mechanical pencil used to stab MCDANIELS in her hand during this entire encounter. During the fight, MOORE falls to the ground, and MCDANIELS stands over her, yelling at her. MOORE is able to stand up, and goes into the corner of the store. As MCDANIELS approaches her, MOORE brings the mechanical pencil downwards in a stabbing motion, stabbing MCDANIELS in the left eyelid. MOORE then runs to the back of the store, and MCDANIELS walks to the entrance. End of footage.

With the information provided on scene, MCDANIELS was taken into custody for Child

Abuse. MCDANIELS was transported to St. Joseph's Hospital for the injury to her eye. St. Joseph's medical staff stated that the wound needed cleaning and skin glue to heal.

It should be noted that while at the hospital, MCDANIELS made several outbursts, stating "I pushed her on the ground and I'm standing over her. I could've beat her ass in that motherfucker. I did hit her because I'm allowed to discipline her. I take care of her." MCDANIELS was informed several times. that she was being recorded and we were not asking her questions regarding the case because she had not been read her Miranda rights. MCDANIELS continued to make the outbursts to us. Using my Axon Body Worn Camera, I time stamped some of the outbursts when MCDANIELS made them.

MCDANIELS was then conveyed to District 3 for processing. MOORE was released to her mother, Andranell ROBINSON (F/B, 03-07-84).





You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


