This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/20/2014 the applicant was cited at 714 North 27th Street in the city of Milwaukee for Sale of Cigarettes to Minor/Underage.

2. On 02/21/2015 officers investigated an incident at 4950 W. Lisbon Ave. The investigation revealed that at about 9:19pm, two employees, Rajpal SINGH and Vishal VISHAL, confronted a shoplifter, Dominic SMITH. When the SMITH refused to leave SINGH armed himself with a bat and VISHAL armed himself with a wooden stick. SINGH struck SMITH in the arm with the bat and chased him from the store. SMITH throws a garbage can at the store and SINGH chased SMITH from the property. SMITH then returns and takes the bat from SINGH and attacks both employees striking them in the head. Both were conveyed to the hospital. SINGH had a skull fracture and bleeding on the brain and VISHAL had several lacerations to the head. SMITH was arrested. Milwaukee Police Department report #15-052-0103 filed.

3. On 10/01/2016 a 17 year old, working in conjunction with Milwaukee police, was able to purchase a two pack of Swisher Sweet cigars from the cashier at 4950 West Lisbon Avenue (Clark Gas Station). The cashier was told a M.A.R.T.S. enrollment letter would be mailed to the applicant.

- 4. On 02/20/17 at 7:22 pm, Milwaukee police were dispatched to a shots fired at 4950 W Lisbon Avenue. Investigation revealed the victim was parked next to a fuel pump on the premise and the suspect vehicle had parked in front of the victim's auto when 2 suspects exited the auto armed with hand guns, pointing them in the victim's direction. The victim attempted to flee by driving backwards and proceeded to strike another vehicle while on the premises lot. The suspect auto then followed the victim and the victim fled on foot as approximately 10 shots were fired at the victim while he fled. Neither victim nor the victim's auto was struck. A portion of the incident was capture on surveillance.
- 5. On 10/01/2016 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars from the clerk at 4950 W. Lisbon Av. The clerk was Amrik SINGH and he admitted to the sale. The applicant enrolled in the MARTS program but failed 2 checks and was issued a citation.

- 6. On 01/17/2017 DPR officers called 4950 W. Lisbon Av regarding a pending call. Nirmal SINGH stated there were 5-6 panhandlers inside and outside. It is an ongoing problem and they were no longer on scene.
- 7. On 01/23/2017 at 1:23pm officers were dispatched to 4950 W. Lisbon Av for a trouble with subject call. The call was for panhandlers. The officer did not observe and subjects and the clerk stated they left prior to the arrival of the police.
- 8. On 01/23/2017 at 8:06pm officers were dispatched to 4950 W. Lisbon Av for a trouble with subject call. The caller, Hemane GUSTTAN, stated there was a female pandhandle that was there every day and would not leave when asked. The officers did not observe the described subject.
- 9. On 02/08/2017 officers were dispatched to 4950 W. Lisbon Av for a trouble with subject panhandling. The subject was gone when the officer arrived.
- 10. On 02/20/2017 officers were dispatched to 4950 W. Lisbon Av to investigate a shooting. The officer spoke with the victim, Terrell BALL, who stated he pulled in the gas station to get fuel. He got out and saw a familiar car with a known subject hanging out the window with a gun. BALL got back in his car in an attempt to flee but struck another car in the lot. BALL then fled on foot as the subject fired shots at him. MPD report filed.
- 11. On 02/20/2017 officers were in the gas station parking lot at 4950 W. Lisbon Av. They observed a female strike another female to the face several times. The subject was arrested and issued a citation.

- 12. On 02/28/2017 a meeting was held at District 3 regarding incidents of violence at 4950 W. Lisbon Av. The applicant was at the meeting where security, cleanliness and calls for service where addressed. On 03/19/2017 the officer followed up at the station and observed litter and garbage in the lot, a pan handler outside the front door and the interior in disarray. On 03/20/2017 the officer spoke with the applicant regarding his observations from 03/19. The officer asked about hiring security. The applicant stated he has hired a subject from the neighborhood to provide security from 6pm-1am and he needs to buy the subject a uniform. The officer advised the applicant he needs to do more to rectify the current problems.
- 13. On 03/23/2017 officers observed a suspected drug transaction in the parking lot at 4950 W. Lisbon Av. The suspect vehicle took off upon seeing officers. The subjects on foot where stopped and found to be in possession of cocaine base. The subject was arrested.
- 14. On 01/04/2018 officers were dispatched to Mobil gas, 4950 W. Lisbon Av for a panhandling complaint. Upon arrival the officers were advised the subject had left.

- 15. On 01/11/2018 officers were dispatched to Mobil Gas, 4950 W. Lisbon Av, for a Loitering complaint. Upon arrival the officers located one of the subjects, who was issued a citation.
- 16.On 02/12/2018 officers were dispatched to Mobil Gas, 4950 W. Lisbon Av for a theft complaint. The officers interviewed the clerk, who stated two subjects came into the station and stole two boxes of candy. The subjects then fled on foot.
- 17.On 03/15/2018 officers investigated an armed robbery complaint. They went to the gas station at 4950 W. Lisbon Av to view video surveillance. The store was cooperative with the investigation.\

18. On 07/11/20 at 2:45am, Milwaukee Police were dispatched to 4950 W. Lisbon Avenue for a Shot Spotter complaint. Investigation revealed that three different subjects fired their handguns inside the parking lot and one of the subjects dropped his cellular phone. 21 shell casings were recovered from the scene and while police were investigating the incident, one of the subjects who were firing shots, came back to the scene and asked for his cellular phone. The subject was arrested.

This report is written by PO Tyler HEANEY, assigned to District 3, Late Shift.

On Saturday July 11, 2020 at 2:47 AM, P.O. Z. FITZPATRICK and I (squad 3369) were dispatched to a Shots Fired / Shotspotter at 4950 W. Lisbon Ave (Clark Gas Station) in the City and County of Milwaukee. We were dispatched to assist squad 3231 (PO CRUZ and PO GIFFORD) who heard the shots fired from the District 3 police station at 2333 N. 49th st.

Upon our arrival we were made aware of the multiple different casings that were recovered from the incident. The casings were as follow:

5 - spent Brass 5.7x28 FNB .22 hollow point

10 - spent Brass GFL 9mm Luger

6 - spent Brass .45 Federal Auto

There was also a black iphone cell phone that was face up on the ground in the middle of the parking lot. It was directly placed in the middle of the 4 gas pumps in the gas station lot.

It should be noted that we arrived to an empty parking lot. All parties fled the scene after the shots were fired.

We checked the surrounding buildings, and employee vehicles (parked on Northeast corner of parking lot) for anything that may have been struck by the gunfire, however we were unable to locate anything.

I spoke with the gas station clerk who was present during the incident. He identified himself as GURPREET SINGH (02/06/89). SINGH stated that he heard the shots and got down. SINGH stated that he did not know who was doing the shooting, however stated that I was able to access the video surveillance that the gas station had.

I then checked the Gas station video surveillance. I observed a large crowd which was gathered just north of pump 1 on the east side of the lot. It appeared that there were a couple different arguments happening based on the body language of the individuals. Multiple vehicles were involved, however it is difficult to tell make and model of the vehicles due to the distance from the camera.

I observed an unknown dark colored sedan vehicle that was parked in the far east part of the lot near the gas station car wash. At approximately 3:04 AM, an unknown individual was observed entering the drivers side of the listed vehicle. The vehicle is seen reversing from the parking lot, and slowly exiting out of the east exit. While slowly exiting, there are multiple muzzle flashes that come from the passenger side of the vehicle towards the crowd that was gathered at pump 1.

Then as the dark colored vehicle was exiting the gas station lot, I observed a black male wearing a blue

polo style short sleeve shirt, dark colored jeans, and blue and white shoes fire rounds in the direction of the unknown vehicle, who was simultaneously firing rounds in an unknown direction. The subject in the blue shirt was seen running westbound in the parking lot while firing shots. While doing so, I observed a cell phone drop out of the listed subjects pocket and fall directly in between all 4 pumps, which was recovered at the scene. There was also another black male subject wearing a black t-shirt, white pants, and dark colored shoes, who was also seen firing rounds from a handgun in an unknown direction.

LANDSCHEET CHARTER TO STREET COLLECTOR

While investigating the shotspotter complaint, a black male subject who was later identified as Brandon CRAWFORD (b/m, 10/31/93) approached officers on scene stating that he had left his cell phone at the gas station. CRAWFORD stated that he dropped to the ground when he heard gunshots and he dropped his cell phone. It should be noted that CRAWFORD matched the description of the shooter seen in surveillance video, who also dropped a cell phone while firing the rounds. CRAWFORD was still wearing a . blue polo style shirt, dark colored jeans and blue and white shoes when asking officers on scene for his phone. CRAWFORD was arrested and transported to District 3 for further processing.

CRAWFORD stated that he did not wish to make a statement regarding this incident.

The casings were placed on inventory as evidence regarding this incident. (MPD Inv #20024069) It should be noted that CRAWFORD's cell phone that was left on scene was photographed as evidence #16, but was subsequently released to CRAWFORD upon his release from District 3.

This case is pending DA review.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
