There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/26/04, applicant was charged with Misappropriation of Property by Whitewater Police.

- 2. On 05/03/2014 a 20 year old Milwaukee police aide, in conjunction with Milwaukee police, attempted to enter Rouge's Gallery (134 East Juneau Street) but was denied entry when she could not produce identification proving she had attained the legal drinking age of 21.
- 3. On 06/21/2014 Milwaukee police were flagged down by the door man at Rogues Gallery (134 East Juneau Street). The door man told the officer he had confiscated a fake ID from a female that had been denied entry to the business and was no longer on scene.

- 4. On 02/19/2015 Milwaukee police conducted at tavern check at 134 East Juneau Avenue (Rouges Gallery) and provided the applicant with a packet of tavern related ordinances.
- 5. On 02/26/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Rogue's (134 East Juneau Avenue) but was denied when she could not provide proof she had attained the legal drinking age of 21.
- 6. On 05/30/2015 Milwaukee police were flagged down for a property damage complaint at Rogues Gallery (134 East Juneau Avenue). Investigation revealed the applicant refused to continue serving a patron who appeared to be very intoxicated. This patron refused to leave the business voluntarily, and grabbed a door hinge when security attempted to eject him. The hinge broke when the patron pulled down on it. This patron was arrested. Milwaukee police incident report #151500151 filed.
- 7. On 06/23/2015 Milwaukee police observed several bouncers escorting a patron from the business at 134 East Juneau Street (Rogues). This patron refused officers orders to leave and was ultimately cited and given a ride home.
- 8. On 08/07/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Rouges Gallery (134 East Juneau Avenue) but was denied when she could not provide proof she had attained the legal drinking age of 21.

9. On 04/08/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Rogue's Gallery, 134 E. Juneau Av. The Police Aid was

denied entry at the door by security.

10. On 04/09/2017 officers were flagged down at Rogue's Gallery, 134 E. Juneau Av, for a fight inside the business. Security was escorting a group of individuals out. One of the subjects was fighting with security and resisted officers when they intervened. The subject was arrested and cited for Disorderly Conduct.

- 11. On 11/29/2018 officers conducted underage tavern enforcement in District 1 at Rogues, 134 E. Juneau Av. The bar passed the check.
- 12. On 01/08/2019 at 1:00am officers were dispatched to a fight at Rogues, 134 E. Juneau Av. The fight was over but officers watched the video which showed a patron putting her middle finger up in the face of a security guard. The patron then strikes the guard in the face. The guard escorts the female out and she fell to the ground. The female's boyfriend then grapples with the guard and he was also escorted out. The two patrons were issued citations for Disorderly Conduct, Misrepresentation of ID, and Consuming Alcohol/Underage.
- 13. On 02/24/2019 at 2:20am officers responded to Rogues Gallery for a fight. The officer spoke with the bouncer who stated a female went up to the DJ and requested a song. When the DJ stated he was playing the last song the female became upset. The bouncer was escorting the female out when she turned around and hit him to the face several times. He pushed her out the door and she fell in a puddle outside. The bouncer did not want to prosecute and the female was released from the station.

14. On 11/08/2019 at 11:56pm officers were flagged down by Rogues Gallery, 134 E. Juneau Av for a property damage complaint. The officer entered and found security had a subject detained for destroying the female bathroom. The subject was arrested and conveyed to the station. The officer was advised the subject still had a tab open at the bar and the applicant asked if the subject was willing to pay for the damage on his credit card. The subject agreed and was issued a vandalism citation.
