Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. 

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/24/07 at 1:00 am, Milwaukee Police received a tip from a citizen (who wanted to remain anonymous) that there was drug dealing going on inside the tavern Club 99. Investigation revealed a patron that was inside of the tavern was in possession of suspected cocaine. Officers interview this subject who stated he uses the cocaine for personal use and hangs out at the club because his father tends bar there. This suspect also stated that several other patrons in the bar sell cocaine. He was arrested and charged with POCS – Cocaine.

2. On 06/02/2009 at 1:15PM, a Milwaukee Police Department squad was sent to 409 E Burleigh St, regarding a battery complaint. The victim stated she was at "Club 99" tavern on 05/31/2009 between 10:00PM and 10:30PM when she got into an argument with a known suspect. The victim then went into the bathroom and upon returning to bar area was struck in the face causing her to fall to the ground. The victim went to St Mary's hospital and received several stitches to her lip. The licensee and his son were cooperative with the police during the investigation and provided a copy of the video footage.

8. On 02/16/2019 at 2:20am officers were dispatched to a fight at Club 99, 2579 N. Pierce St. The officers spoke with the bartender who stated just before 2:00am 4 patrons began yelling. She stated these were not regular patrons and she decided to call last call. The applicant came down from upstairs to help kick out the subjects yelling with the assistance of regular

- patron. The applicant stated when the subjects got outside they wanted to fight him and the regular patrons. The subjects then left on foot. The officers found no tavern violations.
- 9. On 12/08/2019 officers conducted a licensed premise check at Club 99, 2579 N. Pierce St. The officer spoke with Wilfredo ORTIZ, who stated they would be open New Year's Eve and have numerous employees working. ORTIZ was advised to call the district tavern car if there were problems they could not handle.

10. On 04/11/2020 at 11:11pm officers were dispatched to a possible COVID violation at Club 99, 2579 N. Pierce St. When the officers arrived they observed people inside drinking, smoking and playing pool. The officers entered and the applicant stated he had friends over helping to renovate the building. The officers checked the building and located people hiding in the basement. The applicant then stated he has been struggling financially since the COVID outbreak. Some patrons offered to pay him to have a private party and he took the offer. He was advised to not have any more private parties.

This Report is written by PO Russell MACRAE assigned to District 5 - LATE POWER SHIFT.

On 04/11/2020 at approximately 11:11pm, PO Mark DILLMAN and PO Nicholas ROMEO (SQ#5467) were dispatched to a possible COVID-19 violation at Club 99 tavern located at 2579 N Pierce Street. Upon arrival, PO DILLMAN and PO ROMEO observed numerous subjects inside the tavern through the covered-up windows. They observed the subjects inside the tavern playing pool, smoking, and being served alcohol at the bar by a bartender. PO DILLMAN recorded these events on his body-camera.

PO David LETTEER and I (SQ#5460) responded to assist PO DILLMAN and ROMEO. Upon arrival at approximately 11:41pm, PO LETTEER and I observed numerous patrons inside the tavern. We were met by the LICENSEE's son identified as Wilfredo J. ORTIZ (W/M 02/12/79). ORTIZ stated that he had several people in the tavern. I observed ORTIZ and (3) other persons inside his bar. ORTIZ stated that he had friends over at the bar to assist in the reconstruction of the physical bar itself.

I began to conduct a tavern check of the property. I checked the bathrooms, rear storage room, and finally the basement. As I walked into the basement, I located (5) patrons who were hiding in the corners and other areas. I told them all to go back upstairs.

When ORTIZ observed the patrons coming back upstairs, ORTIZ then told us the truth for the incident. After all the patrons left the bar (8 Total), ORTIZ stated that due to the COVID-19 outbreak times have been tough financially. ORTIZ stated that he was offered money by friends to host them in the bar and he took the opportunity. ORTIZ stated that he has been struggling to pay for basics for himself and his 11 you daughter.

ORTIZ was advised not to host any more "parties" or patrons inside his bar.



The hearing before the Licenses Committee will take place virtually on 1/26/2021 at 10:15 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
