On February 9, 2010, the Common Council of the City of Milwaukee passed Resolution No. 091275, granting permanent historic designation of the Schlitz Tavern/Coventry Inn, 2501 W. Greenfield Ave. in the 8th Aldermanic District.

As an owner of a historic property, it will now be necessary for you to obtain a Certificate of Appropriateness (COA) from the Milwaukee Historic Preservation Commission before beginning any work that will affect the exterior of your property. Building permits for work affecting the exterior of your property will not be issued until a COA is issued.

Enclosed is informational literature that explains, in detail, the procedure for obtaining a COA and the preservation guidelines the Commission will review. Also enclosed, is a copy of our publication, Good For Business, a guide to rehabilitating the exterior of older commercial buildings. Additional information is available from the Commission Staff.

Whereas, The Milwaukee Historic Preservation Ordinance, s. 320-21 of the Code of Ordinances, provides that historic sites, structures and districts may be designated by the Common Council upon the recommendation of the Historic Preservation Commission; and

Whereas, The Historic Preservation Commission recommends that the Schlitz Tavern/Coventry Inn at 2501 W. Greenfield Avenue be designated as an historic site; and

Whereas, This site possesses integrity of location, design, setting, materials, workmanship and association and fulfills the following criterion set forth in s. 320-21-2-e:

e-1. Its exemplification of the development of the cultural, economic, social, or historic heritage of the city, state of Wisconsin or of the United States.

e-5. Its embodiment of the distinguishing characteristics of an architectural type or specimen.
