Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary and Legislation with the below recommendation.

The basis of this lawsuit is the non-selection for hire of Mr. Peterson for the position of Investigator/Auditor with Fire & Police Commission in February 2019. Mr. Peterson applied to the position and received a conditional offer of employment which was ultimately withdrawn. Mr. Peterson alleged a violation of the Wisconsin Fair Employment Act against him on the basis of arrest record discrimination for the withdrawal. The City denies this allegation.

After an Initial Determination of probable cause from the Equal Rights Division, the parties engaged in mediation and have agreed to settle the matter for a total of \$15,000, inclusive of all fees and costs, subject to approval by Common Council and the Mayor.

Because of the unpredictability of a trial, and the City's risk for exposure to compensatory damages, as well as additional attorney fees and costs, we recommend that this matter be settled for the amount negotiated. Consistent with our recommendation, we request authorization to execute a settlement agreement
