

Good Afternoon,

I wanted to follow up and let you know our inspector did speak with the owner of the establishment - Craig Berry — and the planned event at his nightclub. He told the inspector he feels he is being singled out. The inspector made him aware of the complaints that MHD has been receiving (over capacity, social distancing, staff and customer not wearing masks). The inspector reviewed the 4.3 plan Moving Milwaukee Forward with him and reminded him that no dancing is allowed, all guest must be seated, social distancing must be enforced, and mask must be worn. He emailed him a copy of the current order. He also let him know that while the current order expires after today he must still maintain operations with appropriate physical distancing and protective measures as outlined in his plan and that dance floors were still prohibited and patrons should remain seated.

We do not currently have staff working late night inspections however if MPD is able to make a stop at this location to check for compliance- we can cite after the fact for any violations that you witness.



3. On 04/25/2015 Milwaukee police, along with a representative from the Department of Neighborhood Services, and agents from the Wisconsin Department of Revenue, conducted a licensed premise check at 7330 North 76th Street. During this check, it was discovered that the person working behind the bar, Shakira Loggin, does not have a valid Class D operator's license. 2 bottles of alcohol, 5 containers of tobacco and 4 cash register receipts were confiscated by state agents. The applicant was cited for Responsible Person on Premises Required.

Charge: Responsible Person on Premises Required

Finding: Guilty

Sentence: \$398.00 fine ***in warrant status for unpaid balance of \$178.00***

- 4. On 07/26/2015 Milwaukee police responded to an accident at 7330 North 76th Street. Investigation revealed that a subject employed as security for the business (The Kiss Ultra Lounge) was helping to break up a fight when he was struck by a vehicle.
- 5. On 09/06/2015 at 2:15am Milwaukee police were monitoring Kiss Ultra Lounge (7330 North 76th Street) when they observed a male patron punch a female patron in the face. The male patron was arrested and issued a citation for assault and battery.

Item #3 previously reported, disposition added 11/11/2016.

- 6. On 11/07/2015 Milwaukee police, who were assigned at Kiss Ultra Lounge, overheard patrons talking about a fight inside the tavern. One of the involved parties was cited for disorderly conduct.
- 7. On 11/29/2015 Milwaukee police were dispatched to a tavern check at 7330 North 76th Street (Kiss Ultra Lounge). While in route, officers were advised to hasten their response as several patrons had become unruly and disorderly. Moments later, squads began broadcasting that several gunshots had been fired in the area of North 76th Street and West Clinton Avenue. Employees of the business told officers that security had broken up a fight inside the bar and escorted the involved patrons out. The fight continued in the parking lot until security intervened. Moments after the involved subjects dispersed, several shots were heard. No additional evidence, complainants or witnesses were discovered.
- 8. On 12/06/2015 Milwaukee police were monitoring Kiss Ultra Lounge (7330 North 76th Street) when security notified them that several patrons were involved in a fight inside the business. Three subjects were cited for disorderly conduct. 8 Milwaukee police squads, in addition to the squad that had been monitoring, along with 2 Milwaukee police supervisors responded to assist in controlling the situation.
- On 12/12/2015 Milwaukee police met with the applicant to address incidents that had occurred at Kiss Ultra Lounge recently. The applicant stated the following actions would be taken:
 - Both exits at the front of the business will be utilized.
 - The patio door will also be used as an exit for patrons.
 - Security gates will be set up in the parking lot.
 - An armed roaming security guard will be added.

Additionally, cameras have been installed at the entrance and inside the venue and two members of the security staff that had been doing a substandard job had been terminated and replaced.

- 10. On 01/08/2016 Milwaukee police met with the applicant regarding recent incidents at Kiss Ultra Lounge. The applicant stated that she had been hiring two off duty officers for Friday and Saturday evenings, but these officers had recently stopped coming. She asked that officers be notified and trained on how to sign up for this work detail. She further stated she had fired two security guards and she was willing to work with Milwaukee police in keeping her establishment safe.
- 11. On 01/10/2016 Milwaukee police were flagged down regarding a trouble with a subject complaint at 7330 North 76th Street (Kiss Ultra Lounge). Officers were told there had been a dispute inside the business and the involved parties were removed from the premises by security. These parties continued to argue in the parking lot of the business until security intervened along with Milwaukee police. The involved parties later cooperated with security and left the area. The officer reports that business staff was very cooperative and helpful.
- 12. On 02/07/2016 Milwaukee police were flagged down regarding a fight inside Kiss Ultra Lounge (7330 North 76th Street). Investigation revealed a patron of the business had been involved in a fight. Security for the business intervened and detained the subject until police arrived. This subject lied about his identity and threatened to "air the club out". This subject was arrested. During this encounter, Milwaukee police became aware there was a pending battery complaint that occurred at 76th and Mill Road. The officer responded to St. Joseph's hospital to investigate. The officer spoke to Brittany Morton who stated she had been a patron of Kiss Ultra Lounge (7330 North 76th Street) when she and a former friend got into a fight. One of the involved parties was struck in the head with a glass sustaining an injury to her head. Milwaukee police incident report #160380036 was filed.
- 13. On 02/13/2016 Milwaukee police were dispatched to St. Mary's hospital for a battery that occurred at 7330 North 76th Street (Kiss Ultra Lounge). The victim states she had been involved in a fight while in the main room of the bar. She sustained an abrasion to her forehead. Milwaukee police incident report #160440026 filed.
- 14. On 04/10/2016 Milwaukee police, who were working a special assignment at 7330 North 76th Street (Kiss Ultra Lounge), were asked by security personnel to assist with removal of a group of individuals from the business's parking lot. Officers discovered a group of approximately ten subjects in a circle fighting in the rear parking lot. These subjects scattered as officers approached which revealed a male lying on the ground bleeding from the head. This subject received medical attention from Milwaukee Fire Department Engine #39. The subject refused to speak to officers and walked away. Milwaukee police incident report #161010016 filed.

15. On 11/20/2016 officers responded to Kiss Ultra Lounge, 7330 N. 76th St for a Trouble with Subject complaint. The officers observed a subject holding open the door arguing with security. The subject was intoxicated and refused to pay the cover charge because he stated he paid for a VIP area. The subject did leave without incident. Security was cooperative and no violations were observed.

- 16. On 12/04/2016 at 2:05am officers were observing closing time at Kiss Ultra Lounge, 7330 N. 76th St. Patrons advised the officers that there were several people who were about to fight. The officers observed a subject yelling in another patrons face and that he was preparing to strike the patron. The subject was causing a disturbance and was cited for Disorderly Conduct.
- 17. On 04/02/2017 at 2:20am officers were monitoring traffic at Kiss Ultra Lounge, 7330 N. 76th St. The officer observed a group of 30 subjects surrounding a car. The car had a broken windshield and fled when the officer approached. The officer observed a subject carrying a large wooden table leg. The subject was arrested after a short foot chase. The manager, Craig BERRY, was cooperative and would press charges on the subject.
- 18. On 10/01/2017 officers received a call from Kiss Ultra Lounge that they were needed for trouble with subject. Upon arrival security was pointing at a subject in the parking lot stating that the subject had a gun. The officers stopped the two subjects by the car security was pointing at and recovered two firearms from the ground by the subjects. The manager, Craig BERRY, stated that he observed one of the subjects walking back and forth outside with a gun in his hand. Video surveillance was recovered which depicted the incident. Both subjects were arrested and no other violations were observed in the tavern.
- 19. The applicant has the following past due owed to the Milwaukee Police Department:

 Off Duty Police Officer Employment \$3,699.94 owed as of 11/21/2017

20. On 08/26/2018 officers were dispatched to Kiss Ultra Lounge, 7330 N. 76th St, for a traffic hazard. The officer observed several cars stopped on N. 76th St waiting to get in the lot. The officer was advised the lots were full, because there was live music that would end at 2:30am. The traffic was cleared and the officer monitored the scene. At 2:00am the show let out, and two females began fighting in the lot. Security broke up the fight and the manager stated he was closing for the night. The officer did not observe any violations inside the business and the management was cooperative.

21. On 11/01/2018 officers were dispatched to 7330 N. 76th St to investigate a battery complaint. The officers spoke with the victim, Marissa MARTIN, who stated she worked at the tavern and was walked out of the business by the manager, Otis MOORE. MARTIN stated MOORE got into a verbal argument with her and called her profanity. She stated he pushed her against her car. She stated she then asked for her last pay check because she was not going to work there anymore. MOORE stated he did walk her to her car because they walk all female employees to their cars. He stated he did not push her against her car and stated that there were words exchanged because MARTIN saw him with another woman. MARTIN did not want to prosecute.

- 22. On 12/21/2018 officers conducted a licensed premise check at Kiss Ultra Lounge, 7330 N. 76th St. regarding their plans for New Years Eve. The officers spoke with a security guard who stated the business would be open all night and would have 22 security officers working.
- 23. On 12/24/2019 a subject notified police that on 12/23/2018 he was in his car at Kiss Ultra lounge when he observed his friend in an altercation with security. The subject stepped in,

separated his friend from security and drove him home. While doing this his pistol fell out of his pocket and was left behind at the bar. The subject went back on 12/24/2018 to speak with security about the missing firearm. Security stated they turned a gun over to the owner of the bar. The officer went to the bar, recovered the gun and placed it on inventory.

- 24. On 05/11/2019 at 9:13pm officers were dispatched to a subject with gun complaint at Kiss Ultra Lounge. The officers were advised by dispatch there was approximately 200 juveniles fighting as well as shots being fired. Upon arrival officers spoke with security, who stated there was a Sweet 16 party going on that ended at 8:30pm. Security stated as they were shutting the party down when 2-3 females began fighting in the parking lot. During this time a vehicle drove by on N. 76th St, with a male sitting out the window holding a gun. This subject then discharged the gun 6-7 times. The co-owner of Kiss, Marc BROWN, was on scene and cooperative with the officers.
- 25. On 05/20/2019 at 2:10am officers were dispatched to a shots fired call at 7330 N. 76th St. The officers located 13 casings in the roadway in front of Kiss Ultra Lounge. The officers spoke with security who stated at 2:00am he observed an argument in the parking lot between two individuals. The subjects stopped arguing and walked to a vehicle. The security guard went inside when the subjects separated and got into cars. After entering the building and the security guard heard gun shots outside and west of the location. The guard did not see who fired the shots. The officers checked the security cameras but they did not cover the roadway where the shots were fired.
- 26. On 07/07/2019 at 11:00pm officers were assigned to monitor a special event at Kiss Ultra Lounge, 7330 N. 76th St. The officers observed autos attempting to get in the parking lot blocking traffic on N. 76th St. The attendant assigned the lot entrance appeared unable to keep up with the amount of traffic entering the lot and the officers stepped in to get traffic flowing again. At 1:06am the officers were advised of possible shots fired inside and they observed a large amount of subjects exiting in an unorganized manor, running over each other. When the officers were able to safely enter they did not find any victims or any evidence of shots being fired. They spoke to the DJ who stated he observed a firework being lit in the crowd and heard a single pop, he did not see any firearms. The club closed early as a result of the incident.
- 27. On 09/10/2020 at 1:35am officers were dispatched to a Shooting at 7330 N. 76th St. The investigation revealed there was a fight inside the bar that progressed out into the parking lot. While in the parking lot a female involved in the fight, produced a pistol and was pointing it at other patrons and a security guard. The security guard gave several commands to drop the gun. When the female continued to point the gun at people the security guard discharged his gun striking her several times. The female was pronounced dead on the scene. The officers interviewed the business manager, who was cooperative in providing video surveillance.

28.On 12/20/2020 officers conducted an investigation at Kiss Ultra Lounge, 7330 N. 76th St. They spoke to security, who provided video of a subject breaking into cars in the area. The video contained a picture of an auto used in the offense. A photo of the auto was placed on the roll call board for all officers in the area.

29. On 01/15/2021at 10:58pm officers conducted a license premise check at Kiss Ultra Lounge, 7330 N. 76th St. The officer observed security monitoring the exterior of the business and checking ID cards at the door. The tavern had signs posted advising masks were required, there was a plastic shield separating the bartenders from patrons and announcements reminding patrons to wear masks. The dance floor was taken out of service with tables and the pool table and dart board were not in use. The officers monitored the tavern until close and only observed one patron being kicked out for unruly behavior.

This report is written by P.O. Michael BUDZISZEWSKI, assigned to District 4, Late Power Shift. On Thursday, September 10th, 2020 at approximately 1:35 a.m. P.O. Brent TURNCH and I, (Squad 4420) responded to the address of 7330 N. 76th St. for a shooting. Witnesses on scene stated that a fight occurred inside of the bar between two groups of females, during the altercation the fight progressed out in to the parking lot where the shooting took place.

Upon arrival I met with and spoke to the security officer who was involved in the shooting, Eddie C SILAS (B/M 04/30/84). SILAS stated that he was trying to break up a fight that was occurring inside of the bar that spilled outside into the parking lot. SILAS stated that once outside a black female produced a firearm and was pointing it at several people. SILAS stated that he told the female several times to put the gun down but refused. SILAS stated that the female continued to raise the firearm and point it at other patrons and him as well. SILAS stated that he feared for his safety and others and fired his weapon, striking the female, who was later pronounced deceased by MFD. SILAS stated that he fired his gun approximately 4 times. While speaking with SILAS, I did recover and secure his firearm with his holster. In addition to recovering the security officer's firearm, the suspect's firearm was recovered on scene along with 7 casings, and video surveillance which corroborated the security officer's statement.

While on scene I performed a licensed premise report. I spoke to Marc A BROWN (B/M 04/05/70) who was the manager on duty who provided me with the class b tavern license and the food dealer license which both expire on 02/21. Kiss lounge was in compliance and had a valid license to serve alcohol and food. BROWN was cooperative with providing me the proper license, and was also cooperative providing detectives the surveillance footage of the incident. No citations were issued to the bar or bar manager.

Their were approximately 10 patrons inside of the bar along with bar staff while I was on scene. Everyone inside of the bar was cooperative and provided information regarding the incident. Due to the large unruly crowd outside of the bar Sergeant NUNEZ (Squad 4410) had to call for additional squads to the scene for crowd control.

The video does not show a clear image of the unknown male actually breaking into the vehicles. The vehicle fled the parking lot and the location at approximately 2:20am southbound on N. 76th St.

I downloaded a copy of this video camera surveillance and it will be put on the roll call board to be distributed to officers. Kiss Ultra Lounge staff encourages police presence and is current in licensing. BERRY stated he plans on distributing this vehicle info and video to other businesses throughout the city so their establishments can be on the look out for it.

This report is written by PO O'Neal STAMPS III, assigned to District Four, Late Power Shift. On Friday, January 15, 2021 I was assigned to Squad 4467 and operating a fully marked MPD squad car 543. I was dressed in full Milwaukee Police Department issued uniforms, with my nameplate and badge affixed to our outermost garments. I was wearing my Milwaukee Police Department issued Body Worn Camera (BWC) at the time of this investigation.

NATURE OF CALL/JUSTIFICATION

On the mentioned date at approximately 10:58 pm, I conducted a Tavern Check at KISS ULTRA LOUNGE located at 7330 N 76th St. This address is in the City and County of Milwaukee, WI. This establishment held an event, All Black Party, which was advertised and hosted by DJ Reggie Brown of IHeart Radio.

INITIAL OBSERVATION

Upon arrival, I observed the exterior lights in the parking lot were on and approximately 75 vehicles were parked in the parking lot along with vehicles parked on W Clinton Ave. I observed a security guards standing outside of the main entrance to the business who was monitoring the exterior of the business. I also observed a security guard walking through the parking lot monitoring the vehicles. The main door of the building was closed shut but was unlocked to allow access in and out of the building.

INVESTIGATION

I approached the main entrance door and observed the security guards checking identification cards of patrons prior to them entering the business. The business had signs posted on the entrance door that face masks were required inside of the location. The security staff were also equipped with hand held metal detectors. I observed 3 female security guards at the entrance door who were responsible for checking the female customers.

I entered the business through the main entrance where I observed the kitchen area inside of the business was open for business and serving customers. The main bar section was occupied by customers and the bar was staffed with two bartenders. The patrons in the main bar area possessed face coverings but had them removed while drinking or eating at the bar.

I entered the "Club" section of the location and where the business was acting in a club setting. I observed approximately 125 to 150 individuals inside of the club section which included staff. I observed that a majority of the occupants inside of the premise were wearing face coverings with some having the face coverings lowered on their face. I observed patrons seated in the seating areas and also walking to and from the bar to order and obtain drinks.

The bar had a plastic shield type barrier installed completely around the counter top which separated the clients from the bartender. The dart machine and pool table was placed out of service in accordance with the Covid-19 restrictions. The dance floor was taken out of service by placing tables and chairs on top of the floor. I observed a cleaning station near the entrance of the bar which contained hand sanitizer and cleaning agents for customers to use while inside of the business.

While inside of the business, I heard several announcements made over the loud speaker reminding patrons to keep their face masks on while inside of the business.

FOLLOW UP

PO Majeed and I remained on scene for the duration of the event. While on scene we observed one incident in which a female was escorted out of the business due to unruly behavior by the security staff. After the female was escorted out of the building, she caused a minor disturbance in the main parking lot by yelling and slamming her hands on top of a vehicle. I approached the female and once she noticed that I was a police officer she entered her vehicle and departed from the scene without further incident.

At approximately 1:45 am on Saturday, January 17, 2021, the security staff made and announcement that the event was over and everyone needed to exit the building. PO Majeed and I remained on scene until all the patrons departed from the scene. During the close of business we did not observe any incidents which required police action.
