To whom it may concern (City Of Milwaukee),

I am writing to request payment for damages that happened to our family property at 8001 W. Norwich St. Milwaukee, WI 53220 on August 2, 2020. This is the second time in the last three years that we have had significant flooding in our basement due to the city improperly handling the city sewer overflow. Restoration specialists working the neighborhood told us that the city of Milwaukee again choose not to open the sewer gates to Lake Michigan to alleviate the heavy rain and that resulted in every house on the block flooding and this time the damages were far worse than the previous time, requiring hours of labor and expenses. This happened just days after the entire basement was remodeled so the house could be sold. Carpet, pad, framing, drywall, paint, etc. was up for less than ten days and all needed to be torn out and started over. We worked rapidly to cure the situation in order to move forward with the sale of the home.

I am requesting we be paid by the city of Milwaukee an amount equal to the cleanup recommended by A&J Restoration. The bid is included with this letter. I am not asking for any reimbursement for damaged furniture, equipment or belongings that were stored in the basement, service to the furnace, reimbursement for new framing, hanging new drywall, painting a second time, new carpet and pad, new paneling, etc.

I realize the city has a tough job managing the sewer gates and hopefully the request for payment on cleanup only is a fair request. However if the city ignores this request we will file a civil claim for the full amount. We've been contacted by an attorney who seems to specialize in flood claims against the city of Milwaukee. Thank you in advance for your attention to this matter.
