I'm and I'm filing a formal complaint against Apys Cars/Brew City Towing. My car was towed under false pretenses. Brew City Towing patrols the lot for 3901 N Humboldt Blvd which is owned by Map East LLC and managed by Bieck Management. I live next door at which is owned and self-managed by HJ Zolper and Sons (who use All City Towing for parking infractions). On Wednesday, April 15th I parked my car on the edge of the back parking lot of

i. At 1:03 pm I came outside and my car was gone. No notice was given whatsoever. On the other side of the alley (3901). I saw a sign that read Apys Cars. I called their number and asked about my car. I was informed that I didn't have a permit to park there.

Upon arriving at the business' address, I asked to speak with someone in authority. The receptionist called who I believed to be the manager and put her phone on speaker, he said his name was "Pete." I told him that he had no legal right to tow my car because it wasn't on the property they claimed I needed a permit for. He was elusive and oddly combative. After researching the zoning and calling Bieck Management I found out it was the City of Milwaukee's property. I informed "Pete" who disregarded the information and continued his diatribe. I began to record how hostile he was being and after the receptionist notified him he hung up the phone.

For recourse, I believe that Brew City Towing should be stripped of their license to operate in Milwaukee. One might view this as extreme but I believe the precedent needs to be set. For a company— and I use the word loosely— to tow a car from a location of which they have no jurisdiction, under false pretenses and to be able to profit from it is an absurdity, especially during a pandemic when people aren't working.

3. The applicant has three valid open warrants with the St. Francis Police Department for a Traffic Offense.

- 4. On 07/10/19 Milwaukee Police conducted a License Premise Check at Brew City Towing, located at 4030 W. Douglas Ave. The agent was cooperative, however, several violations were observed and advised including: non-consent towed vehicle on the yard with no tow reference; an over-charge of customers of \$10.00 for storage: unregistered tow truck, and non-display of tow fees.
- 5. On 08/07/19 Milwaukee Police conducted follow up at Brew City Towing located at 4030 W. Douglas Ave., regarding an Accident Causing Injury (CAD#192190105). The listed violations were addressed during the investigation: private property/tow signs were not posted at each entrance of the contractual tow lot; photos were not taken of all four sides of the vehicle; towed vehicle was not towed to brew City tow lot and rather towed to a private residence; tow truck driver did not obtain a tow reference number (Cit#J9811BQ6X8); tow truck used for business was not registered with the City of Milwaukee (Cit#J9811BQ6XB); no service order. The agent was on scene and cooperative.

- 6. On 12/15/20 Milwaukee Police received information regarding an over charge of a non-consensual tow for a citizen at Brew City Towing, located at 4030 W. Douglas Av. Investigation revealed the tow was illegal as there was no signed contract with the apartment complex, nor proper posting of tow signs, as well as the overcharge for the vehicle owner being uninsured. The agent was cooperative and agreed to refund the citizens money.
- 7. On 12/24/20 Milwaukee Police were dispatched to Brew City Towing, located at 4030 W. Douglas Av., for a threat complaint. Investigation revealed a citizen complained that an employee on scene made verbal and bodily threats toward a citizen, causing the citizen to fear for their safety. Police requested to view the security cameras; however, employees denied having access or the ability to retrieve video. The agent was notified via telephone and was cooperative.
- 8. On 01/16/20 Milwaukee Police received information from a citizen, who's vehicle was towed from Save-a-lot parking lot, located at 6201 N. Teutonia, by a Tow Truck with the name "Apys" on the side. The tow was for illegally parking in a handicap parking spot. The citizen came out as the vehicle was being loaded on the truck bed and was yelling for the driver to put her car down, however, admitted the driver may not have heard her due to the noise of the truck. Milwaukee Police had prior knowledge that "Apys" is now "Brew City Towing", therefore, the officer contacted the agent of Brew City Towing and advised the agent of the drop fee and the improper name on the tow truck. The agent denied the name was improperly affixed, however, agreed to waive tow fees for the citizen.

On 12/16/20, I received a call/complaint from Kendra C Jackson (05/09/91-#414-793-7910) that her vehicle was illegally towed (#2013500) on 12/15/20, by Brew City Towing, from 2338 W Linwall Ln, which is New Hampton Gardens.

Jackson told me the vehicle, a 2009 Dodge van, was parked in the parking lot they reside at. Jackson told me there was no "No Parking" signs posted at the entrances of the lots. Jackson sent me a copy of the invoice Brew City gave her when she paid for the tow and picked up the van on 12/15/20.

The invoice showed an illegal overcharge of \$50.00, which is a violation of Wisconsin Department of Transportation Chapter Trans 319.03(1) and City of Milwaukee Ordinance Chapter 93-4-f. I attached a copy of the invoice to this report, upper left corner under "Attach".

On 12/16,20, I contacted Brew City Towing manager Jaime Blas. I asked about the overcharge and Blas said the charge was because Jackson and/or the vehicle was not insured. Brew City charged Jackson to tow the vehicle to the street, from their storage yard, because the vehicle did not have insurance. Blas said there is a lawsuit with the City of Milwaukee, which allowed him to charge any amount he wanted for a "tow out" fee.

I then asked Blas to email me the required information regarding this non consent tow. Information would include a contract with the authorized agent or owner, to include adequate identification, or all the adequate identification of who called for this tow.

Blas told me "Amber", who is a site manager on Linwall had not signed and returned the contract. Blas told me they have had a verbal contract with Amber since 11/01/20. Blas told me Amber called Brew City, "about midnight" to request the tow of this vehicle. Blas gave me Amber's phone number. I called Amber. Amber told me she was not involved with the contract to to contact "Anita" (#312-644-1055) at their corporate office. I asked Amber what her position was at Hampton Gardens and if she was authorized for the non consent tows. Amber told me she already told me she was not getting involved and to contact corporate. Amber was not cooperative.

On 12/21/20, Blas sent me an email that stated he was still unable to contact Amber and if I had anymore questions, I was to contact their legal counsel. Blas was unable for provide Amber's last name and date of birth until 12/22/20. Blas still did not provide me with "Adequate Identification", as of

I then asked Blas for a copy of the pictures taken the signs posted at all entrances to the parking lot at New Hampton Gardens. Blas told me he gave the signs to Amber, but the company has not posted the signs, so he was unable to provide me with photographs. This is a violation of violation of 93-47-d-2.

On 12/21/20, I called the agent for Brew City, Nietzche Camareno, who was cooperative. I told Camareno about the above listed violations. Camareno told me he heard about the situation. Camereno told me he would refund Jackson for the illegal tow.

On 12/22/20, Blas emailed me a copy of the contract for Hampton Gardens. The contract had a not legible signature and no "Adequate Identification". I replied to Blas email regarding this.

I gave Camareno verbal warnings based on the fact that he would refund Jackson. If the refund does not occur, I will issue Camareno citations.

It should be noted, I have met with Camareno and Blas, several times over the last couple years regarding Chapter 93.

On 01/16/2020, at about 300pm, I received a call from Chastity D Johnson (b/f-08/04/99), 6049 N 41st St, Milwaukee, WI 53209, #414-364-7179. Johnson told me her vehicle was just towed from Save-A-Lot located at 6201 N Teutonia Av. (tow reference #1734023.

Johnson told me she parked in a handicap spot, without a handicap tag. Johnson's cousin was sitting in the car while Johnson went into the store. A short time later the cousin came into the store to buy something else, leaving the vehicle vacant. Johnson came out and saw her vehicle was being hooked up by a tow truck. Johnson ran up to the drivers door of the tow truck. Johnson described the driver as: Hispanic Male with glasses. Johnson stated the tow truck was still loading the vehicle, Johnson described the action as: the lift was going under my car and lifting my car up. Johnson told me she did not see the tow driver put any straps on the vehicle (Trans. violation).

Camareno told me he would call the employee at the office and tell them to waive the tow fees. I also asked Camareno about the Apys truck. Camareno insisted the tow truck said Brew City. Violation 93-45-1-c-3.

Johnson called me. I told Johnson Brew City was going to waive the tow fees. Johnson told me, while she was on the phone, at Brew City that the employee was walking out of the office, locked the door and was holding a can of Mace, towards Johnsons face. While on the phone, the employee left the premises.

I called Nietzche back and told him the employee just left. Nietzche said he would call the employee back
