Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

3534 S Chase Ave is a duplex directly north of the Dollar Tree. I have called Neighborhood Services and even complained to the Police, but yet nothing gets done. These people do not know when to put their garbage carts out. Sometimes they miss the pick up by an hour, sometimes by a whole day. Over Christmas, they missed it by a day and we had to look at those carts until they were picked up after New Year's. Perhaps you could send them a schedule. I am not sure they can read, but at least they would have one.

They park their cars on the front lawn. They used to park their cars blocking the sidewalk until I put a note on one of them. There is traffic stopping there all the time. But, they have gotten bolder – details to follow...

3530 S Chase Ave is a vacant house. This house was purchased in 2007 and no one ever lived in it since. It is right next door to the duplex. We have not seen the owner since 2014. No one cuts the grass at this house, nor is the snow shoveled. A storm blew down a tree in the backyard about 6 or 7 years ago. A chain reaction pulled the electrical wires (which are dead) and that broken the post on the house that holds the wires. The wires are now laying in the backyard, but there is a large whole in the roof. Squirrels, and now raccoons make a home in the roof. This house and property is an eye sore to this street.

...Now, back to 3534 S Chase. They have essentially moved onto the property of 3530. They now park their cars in the driveway of 3530, even though they were asked not to do so. They park their cars on the front lawn of 3530 creating muddy ruts in the front yard. So, now it is not mowed, and a muddy mess. They use the garbage cart and recycle cart for 3530, which is fine if they need it, but they don't always move them back. Their garbage was out on Tuesday, May 26. The pick up was Thursday the 28th. Today is Saturday the 30th and the cart for 3530 is still out there.

Also, on Tuesday, May 26, when I came home from work, I was shocked to see that they had put up a blow up pool in the driveway of 3530, just about between the houses with garbage and recycle carts around it and cars parked on the driveway and lawn to block the view. It was a regular party. There had to be a half dozen or so people out there. Now, I don't mind them having a party, but have it on your property, not someone else's.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 3/9/2021 at 2:30 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
