ADDITIONAL COMMENTS/RECOMMENDATIONS:

On March 8, 2021 I conducted a CPTED at 1034 N Vel Phillips, Turner Hall.

DeTorre is applying for a license to cover the Hall located on the first floor. This space is used for fund raisers and similar events. Capacity for this area is 250 people. All events are preplanned and security is contracted if needed. When the Hall is to capacity and there is a line of people waiting outside the agent will have staff engage the crowd. Staffing is plan for 10 to 1


ratio. There is a plan to sale carry out cases from the office that should be covered by the license. The parking lot to the north of the building is owned by Turner Hall, but has an independent agent company operating the lot. There is lighting and cameras two cameras for the lot. The cameras in the bar area are not functioning at this time. There are two cameras covering the first floor Hall and are functioning. DeTorre stated he may use cordless cameras that can be placed in any area of the building and are accessible on a smart devise. All events should end no later than 11PM. I advised him on the benifitts and safety of using eletronic payment vs cash. The bar area adjacent to the hall will not have the same agent and when open will be operated by an independent agent. There is a gym in the lower level open to the public and operated by Turner Hall. On the top floor the Hall is operated by an agent affiliated with the Past Theater. This was the end of the CPTED and report.
