This is in response to a request from a local resident to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found west bound motorists on East Linnwood Avenue have a difficult time seeing traffic traveling north bound on North Maryland Avenue when vehicles park close to the corner. Therefore, in the interest of public safety, we recommend installing this restriction to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
