On behalf of our customer, HYRULE, LLC Mared Mechanical Contractors Corp was engaged to install a new boiler at 2300 S. 51st St. in Milwaukee in late 2019. Mared was responsible for obtaining proper permits for this work and for having final city inspection done on the work.

The project manager assigned by Mared Mechanical to perform this work did not obtain the proper permitting prior to installation. This same Mared employee left Mared employment during the installation process. The project was completed by another Mared project manager who was not aware that an installation permit had not been obtained and that final inspection had not occurred as part of his completing of the project.

Our customer, Hyrule LLC, received the attached notice to correct these conditions. ORD-21-02058.

The work necessary is Mared Mechanical's responsibility and Mared will be responsible to pay any fees, fines and penalties associated.

I spoke to Kimberly Madison and Linda at the City of Milwaukee and they advised me to make this appeal related to the current nature of the fees and penalties.

Mared Mechanical has been doing business with and in the City of Milwaukee for over 45 years. We have always met our responsibilities relative to obtaining and clearing permits. We believe we have a strong relationship with the City of Milwaukee. What occurred here was an isolated incident related to a Mared employee who left Mared mid project and some items that slipped between the cracks relative to Mared's normal processes and procedures.

We are prepared to pay for all permitting fees and extra costs related to this situation. We would ask that the quadruple nature of the fee be reviewed and that a reasonable accommodation be made for Mared's honest mistake. We are prepared to immediately pay, on behalf of Hyrule LLC, whatever amount is determined appropriate after review.

FAILURE TO COMPLY

RIGHT TO APPEAL

OFFICIAL NOTICE OF VIOLATION

The City of Milwaukee - Department of Neighborhood Services

You may file an appeal within 20 days. The Milwaukee Code of Ordinances requires that a written appeal of this order be received within 20 days of service of this order. If service of this order is made by mail, the appeal shall be received within 30 days or by the compliance date plus 5 days not to exceed 30 days. There is a fee for filing this appeal.

Violations (excluding zoning violations - Chapter 295) must be appealed to the Code Appeals Secretary, Municipal Building, 1st Floor, 841 N. Broadway, Milwaukee, Wisconsin 53202, phone 414 286-2543.

Violations of Chapter 295 of the Milwaukee Code of Ordinances must be appealed to the Board of Zoning Appeals, 809 N. Broadway, 1st floor, Milwaukee, Wisconsin 53202, phone 414-286-2501. All appeal applications must include the required information outlined in sec. 295-311-6.

If an appeal is pursued, it is your responsibility, as the recipient of this order, to file with the appropriate department. Please contact the inspector that issued this order if you are unclear on this issue. Filling an appeal with the incorrect department may render your appeal null and void.

TENANT RENT WITHHOLDING

Uncorrected violations on properties may allow tenants to deposit their rent in an escrow account in the Department of Neighborhood Services under Section 200-22. The Commissioner may withdraw monies from such escrow accounts to make repairs to protect the health, safety and welfare of tenants.

REINSPECTION FEES

In accordance with Section 200-33-48, a fee may be charged for any reinspection, except no fee shall be charged for the final reinspection when compliance is recorded. The fee is \$177.80 for the first reinspection, \$355.60 for the second and all subsequent reinspections. These fees include a 1.6% training and technology surcharge. Reinspection fees shall be a lien upon the real estate where the reinspections were made and shall be assessed and collected as a special tax. If you wish to contest the assessment of a reinspection fee, contact the inspector, and, if necessary, the inspector's supervisor. If no agreement is reached, an appeal form will be mailed to you, which you can complete and send to the City's Administrative Review Appeals Board. Any question regarding the actual appeal process, please contact the Administrative Review Appeals Board at (414) 286-2221. Please be aware that there is a fee required when filing an appeal.
