We have received your claim in the amount of \$3,879.91 from a loss on August 2, 2020 at 7618 West Howard Avenue.

The Infrastructure Services division indicates that Sewer Maintenance had no records regarding a backwater at this address on August 2, 2020. They received a call on August 6, 2020 from Denise Bartlett regarding cleaning the sewer inlets at this address. This is not related to a sewer backup. This was done on August 8, 2020. After receipt of this claim, the sewer was checked and found to be working properly. Their records indicate that the sewer is on a regular 3 year cleaning schedule and was last cleaned, prior to the loss date, on February 27, 2020. Past cleaning records do not indicate any unusual problems.

The Division also indicates that from August 2 through August 3, 2020, that area received an average of 3.4 inches of rain. Due to the heavy rainfall, some City sewers were overwhelmed.
