This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/18/20 at 6:35pm, Milwaukee Police were dispatched to 11313 W. Silver Spring Drive for a subject with weapon complaint. Investigation revealed that a female ordered a "happy meal" for child and the child dropped the meal on the floor. The female became enraged and started waving a metal bat around when the employees were not replacing the "happy meal" fast enough. The subject left before police arrival and all employees were cooperative.
- 2. On 11/10/20 at 5:03pm, Milwaukee Police were dispatched to 11313 W. Silver Spring Drive for a battery complaint. Investigation revealed that a customer ordered from the drive through and waited approximately five minutes to obtain his order. The manager brought out his order and the customer later exited his vehicle and went inside the restaurant. The customer then exited the restaurant turned around and grabbed a food bag, out of the managers hand, causing it to rip and food fall to the ground. The customer took off his jacket and one of the male employees charged at him, swung a fist, and fell to the ground. 4 other employees exited the store and chased the customer around his vehicle and one of the male employees tried to pry the passenger door open once he entered his vehicle.

INITIAL INVESTIGATION

This report was written by P.O. Seth HORST, assigned to District 4, Early Shift.

On Friday, September 18th, 2020, Squad 4231 (P.O. HORST and P.O. Jesse SAENPHONPHAKDEE) were dispatched to McDonalds located at 11313 W Silver Spring Dr, located in the City and County of Milwaukee, Wisconsin, for a Subject with a Weapon Complaint.

Upon arrival, the suspect had previously fled the scene in an unknown vehicle.

We spoke to the team lead, Lakeisha M DAVIS-JONES (f/b 12-12-98) who had called 911 regarding an unhappy customer. DAVIS-JONES reported that a female customer had ordered a happy meal for her child and the child had dropped the happy meal on the floor. DAVIS-JONES stated that the female customer became angry that the staff was not replacing the happy meal fast enough and began yelling and screaming and making threats to hurt employees. DAVIS-JONES stated that the female subject had a metal bat during the incident. DAVIS-JONES called because she wanted the subject to leave the business.

We spoke to an employee, who was cooking in the back, Raquel R DANIELS (f/b 11-20-03) and stated that the subject was a black female, around 20 years old, with messy long hair, 250 lbs, 5'9" tall, wearing a yellow jacket with red on it. DANIELS stated that the female did have a young child with her, as well as 3 other black females that were with her. DANIELS stated that the unknown black female threatened her and was waving a metal bat in the air. DANIELS stated she did not fear for her safety and engaged in making fun of the subject's unkept hair.

We spoke to a second employee, Irie D GILL (m/b 09-01-03) who stated that he was working the registers and witnessed the unknown black female causing a disturbance. GILL stated that he saw her waving a metal bat in the air and making threats. GILL stated that the female then fled the scene after she was given a replacement happy meal. GILL stated that he did not fear for his safety.

All employees were cooperative with this investigation and provided the owners name and contact number: Chay MARSHALL (414) 614-2262. I attempted to call MARSHALL to get more identifying information but was unable to and no B of I is currently on record for MARSHALL.

No prosecution desired.

INITIAL INVESTIGATION

This report is written by PO Justin RAVELY, assigned to District 4, Early Power Shift, Squad 4235.

On Tuesday, 11-10-20 at approximately 5:17 P.M., my partner, PO Ryan KRAMSCHUSTER and I were dispatched to a Battery compliant located at McDonald's, 11313 W. Silver Spring Dr., in the City and County of Milwaukee.

Via phone, I spoke to the caller, Thomas J. KREUZPAINTNER, (M/W, 12-20-84), who stated that while in the drive-thru of McDonald's, he was given the wrong order of food and after waiting approximately 5 minutes, the manager, came outside and handed Thomas his food, at which time, KREUZPAINTNER exited his vehicle and went inside McDonald's and stated that his order was still wrong.

KREUZPAINTNER stated when he went back inside and the manager and staff were yelling obscenities at him.

KREUZPAINTNER stated that the manager came back outside to hand him his new order, at which time, KREUZPAINTNER admitted to snatching the bag of food out of the manager's hand which caused the bag of food to rip open and spill outside.

KREUZPAINTNER stated that all of the employees came out from behind the counter and began to approach KREUZPAINTNER near his vehicle, which was parked just outside of the entry door.

KREUZPAINTNER stated that one of the male employees raised his hands like he wanted to fight, at which time, KREUZPAINTNER began taking off his (KREUZPAINTNER's) jacket. Upon removing his own jacket, one of the male employees charged at him, swung a fist, and then slipped on the pavement and fell down.

KREUZPAINTNER stated that the male employee stated "knock him out and take his money".

KREUZPAINTNER stated that the other employees were chasing him around his vehicle. KREUZPAINTNER then entered the vehicle on the passenger side and told his girlfriend to drive away because he feared for his girlfriend's 7 year old daughter who was in the back seat. KREUZPAINTNER stated the other male employee tried to open the door and pull him out before driving away.

END VICTIM STATEMENT

Upon arrival at the MCDONALDS, we spoke with the shift manager, Samoan L. CRAIGHEAD (F/B, 12-22-95), who stated that KREUZPAINTNER ripped the bag of food out of her hands as she was handing him the bag. CRAIGHEAD stated that KREUZPAINTNER then put his hand in his pocket in a threatening manner, at which time, her employees came from behind the counter to protect her from The first transfer of the second control of the second sec

KREUZPAINTNER, whom she indicated was acting aggressively and making mannerisms in which she believed were indications that he had a concealed weapon.

CRAIGHEAD provided us the security footage of the incident, the following is a summary of the video:

The video showed that at approximately 5:00 P.M. KREUZPAINTNER was in the drive thru of McDonald's, pulled forward and waited approximately 5 minutes for his new order of food. The manager approached KREUZPAINTNER's vehicle and handed him his order, at which time, KREUZPAINTNER exited his vehicle and entered McDonald's slamming the door against the building. KREUZPAINTNER exited McDonald's turned around, snatched the bag of food out of the managers hand, at which time, the bag ripped open and food spilled on the ground. Employees started to gather near the exit. KREUZPAINTNER took off his jacket, one of the male employees charged him, swung a fist, missed and fell down. KREUZPAINTNER ran around his vehicle while being chased by 2 female and 2 male employees. KREUZPAINTNER entered his vehicle on the passenger side, at which time, one of the male employees tried to pry the passenger door open before KREUZPAINTNER's vehicle drove off.

My partner and I interviewed the two male employees:

Irie D. GILLON (M/B, 09-01-03) - Who attempted to open the vehicle door

Khamoni N. WOOD (M/B, 7-17-03) - Who threw the punch

Both employees admitted to acting in a defensive manner towards KREUZPAINTNER and stated that KREUZPAINTNER made threatening gestures by placing his hands inside his jacket.

Neither party wished to press charges against the other.

No injuries reported or observed.

McDonald's employees were cooperative.

The hearing before the Licenses Committee will take place virtually on 4/20/2021 at 9:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
