The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 10/16/18 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Grape Swisher Sweet Cigars at 8334 W. Appleton Avenue, The sales clerk admitted to selling the item and the station was mailed a MARTS enrollment packet.

- 2. On 06/09/20 at 1:49 am Milwaukee Police were dispatched to 8334 W. Appleton Ave, for a shooting complaint. Officers located the victim outside the location on the ground. All employees of the gas station were cooperative with investigation. Employees assisted with access to the video footage regarding the incident.
- 3. On 10/15/20 at 2:10 am Milwaukee Police were dispatched to 8334 W. Appleton Ave, for a shooting complaint. The incident took place outside the location of the gas station. The agent arrived after the incident and assisted investigators with access to the surveillance cameras.
- 4. On 10/17/20 at 2:20am Milwaukee Police were dispatched to a shooting complaint at 5000 W. Chambers St. (St. Joseph Hospital) Investigation revealed that the incident took place at 8334 W. Appleton Ave. Investigators reviewed video surveillance at the location and learned the incident occurred at approximately 12:52am on 10/17/20.

5. On 01/28/21 at 4:19pm Milwaukee Police conducted a license premise check at 8334 W. Appleton Ave, accompanied with an investigator of the Department of Revenue and an associate from Supplement Nutrition Assistance. Officers could not immediately look over the city issued licenses, because the location of the licenses was not accessible to them. Investigation determined that the agent was purchasing cigars from Illinois and bringing them back to Wisconsin. The agent then was selling those cigars in his stores. The investigator seized 20 boxes of cigars from the gas station. The agent admitted to the associate from Supplement Nutrition Assistance, that the store has bought Quest Cards at a discounted price and was using them at the store for a profit. All the workers were cooperative during the premise check. The agent was issued a citation by officers for not having the business license accessible for inspection.

On Tuesday, June 09, 2020, Squad 7468 (Police Officer David MICHAELS and I) responded to 8334 W. Appleton Ave. for a shooting complaint.

Upon arrival, I observed the victim lying on the ground just outside the front door of the gas station entrance. I proceeded inside the gas station to review the surveillance video.

I observed the video and broadcasted a brief synopsis of the suspect description, which is as follows:

Suspect #1 (Shooter) - B/M, shoulder length braids, wearing a black Jordan brand t-shirt with a purple, blue, red, and pink design on the front, black pants with colored stripes on both legs, and black, gray, and white Nike shoes. Suspect #1 appeared to be holding a white iPhone.

Suspect #2 (Driver of suspect vehicle) — B/M, wearing a white long sleeved shirt, light colored blue jeans with rips/tears, gray underwear, black belt, white shoes, a red baseball hat with unknown logo on the front, and sunglasses.

Suspect vehicle was a newer model gray Honda Civic with black rims and with a front and rear license plate, which was unreadable.

The victim, who was identified as Grey RODRIGUEZ (B/M, 2/22/95), arrives at the gas station and parks in front of the front door of the gas station. The video shows that RODRIGUEZ, who is a vaild CCW permit holder, possessing a handgun on the right side of his body inside his waistband in plain view.

The suspect vehicle is seen arriving approximately 2 minutes after RODRIGUEZ and parks directly to the north of RODRIGUEZ'S vehicle. Suspect #2 and Suspect #1 exit their vehicle as RODRIGUEZ exited the store and walked back to his vehicle. All 3 subjects walk into the store when it appears that Suspect #1 observed RODRIGUEZ'S firearm and quickly alerts Suspect #2.

Suspect #1 exits the store and stands next to his vehicle on the passenger side with the door open, which is next to the driver's door of RODRIGUEZ's vehicle. RODRIGUEZ was the driver of his vehicle. Suspect #2 is seen exiting the gas station and holds the door open for RODRIGUEZ who walks to his vehicle and is confronted by Suspect #1, who appears to have a firearm in his right hand. As Suspect #1 points his

firearm at RODRIGUEZ, Suspect #1 takes RODRIGUEZ'S firearm and almost simultaneously shoots RODRIGUEZ one time. Suspect #1 and Suspect #2 then flee in their vehicle eastbound on W. Hampton Ave.

All employees of the gas station were cooperative. The owner, Saeed M. SHEIKH (U/M, 11/11/67), was notified of the incident. The hard drives that store the surveillance video are located in a locked office and SHEIKH stated that he could provide access to the video system by 7:00 A.M.

On Saturday, October 17, 2020 Squad 7332 P.O. Morris BENNETT III and I (while in full duty uniform and operating a marked Milwaukee Police Department squad with Axon body camera affixed to our most outer garment) was dispatched at 2:20 AM to a Shooting complaint with the victim located at 5000 W. Chambers Street (St Joseph's Hospital) located in the City and County of Milwaukee WI.

After investigating this incident, it was later determined that the shooting occurred at 8334 W. Appleton Ave. (Discount Gas Station), located in the City and County of Milwaukee, at approximately 12:58AM. Video Surveillance was obtained by PO Eric Robillard assigned to the Criminal Investigation Bureau (CIB), Violent Crimes Division, Late Shift as Squad 9350 regarding this incident.

I was instructed by Capt. Jeffrey SUNN to file a License Premises Report regarding.

An original copy was inventoried under MPD Inventory #20038682.

- 12:52 AM Blue veh enters Gas Station parking lot and does a U-Turn in the lot and parks at pump #4 facing North/East.
- 12:53 AM 2) unknown males in all black exit the blue veh and walk towards front of gas station. Suspect #1 of the passengers (B/M, skinny build, black dreads in a ponytail, black t-shirt, jeans, black shoes) walks west toward a large tan van and converses with a group of males outside the van. Suspect#2 (B/M, wearing all black) walks towards front of gas station near the front entrance.
- 12:54 AM -Suspect# 1 walks east toward a black Buick SUV that is parked in the middle of the parking lot and reaches into the front passenger window and then back towards his waist. Suspect #1 then runs towards the front of the gas station entrance out of view.
- 12:55.02 AM Suspect#3 the driver (B/M, wearing all black, black jacket with white stripes on arms, large white reflective symbol on back, and a black baseball style cap) of the Alfa Romeo exits the vehicle and walks towards the front of the gas station out of view.
- 12:55.49 AM Suspect #2 and #3 return and enter to the blue veh while suspect#1 approached the black Buick again and removes a white object.
- 12:56.49 AM Suspect#1 returns to the blue veh still parked at pump #4.
- 12:57.43 AM Blue veh pulls forward and at an angle in the middle of the parking lot at a South/East angle. The blue veh seems to be talking with unknown B/Ms that are standing my vehicles parked in front of the gas station entrance.
- 12:58.13 AM Suspect#4 an unknown black male in a black hooded sweatshirt and tan pants approaches the blue veh and seems to be arguing with passengers in the blue veh. The unknown subject walks backwards toward the others in front of the gas station and ducks down towards the ground.
- 12:58.43 AM A muzzle flash can be seen from the driver rear passenger window of the blue veh and then a cloud of smoke as all the male subjects outside the gas station duck down to the ground. The blue veh drives off and out of camera view South/West.
- 12:58.49 AM Suspect #5 Unknown black male in light colored hoodie returns gun fire from the passenger door area of a four door vehicle (possibly a Chrysler 200, grey sedan) that is parked in front of the gas station entrance doors. Suspect #4 rans around the sedan and returns fire at the blue veh and appears to have a jam in his fire arm and clears it by racking the slide a few times.
- 12:59,08 AM Suspect# 4 and Suspect #5 leave the parking lot and drive South/west out of camera view in the grey sedan.

This report is written by P.O. Douglas PAVLIK, assigned to District 7, Early Power Shift.

On 1/28/2021 at approximately 4:19PM, P.O. Tyler WALTER (Squad 7261), Sgt. Eileen ROSS (Squad 7215), and I (Squad 7269) conducted a Business Check at the address of 8334 W. Appleton Ave. (Discount Quick Mart) which is in the City and County of Milwaukee. Upon arrival we assisted the Department of Revenue on an investigation regarding illegal purchases of tobacco. I then attempted to check the licenses and were unable to locate them hanging up for inspection. Shortly after looking for the license I located them behind a door on a counter in the front check out area which was not accessible for inspection.

The Department of Revenue conducted their investigation into the owner and agent of the license Saeed M. SKEIKH (W/M 11/11/1967) and concluded that SKEIKH was going down to Illinois and purchasing cigars and bringing it back up to Wisconsin to be sold in his two stores he owns. SKEIKH admitted to the agents of the Department of Revenue that he was purchasing the cigars from Illinois and bringing them to Wisconsin to be sold at his stores. The Department of Revenue seized 20 boxes of cigars from Discount Quick Mart.

During the investigation SKEIKH was cooperative with the Milwaukee Police and the agents of the Department of Revenue.

All workers during the investigation were cooperative.

Additional illegally purchased cigars were located by the Department of Revenue at the Economy Inn (7284 W. Appleton Ave.). The Department of Revenue seized four boxes of cigars out of a storage closet only accessible to the Economy Inn and SKEIKH. The Department of Revenue seized 15 additional boxes of cigars from the 7609 W. Capitol Dr. (Stop and Go).

Also assisting with the Business Check was an associate from the Supplemental Nutrition Assistance Program (Wisconsin). SKEIKH admitted to the associate that the store has been buying Quest Cards for a discounted price and using them at the store to make a profit from the State of Wisconsin.


