There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/12/20 at 3:09am, Milwaukee Police observed, while on a Code R.E.D. deployment, the food dealer at 1150 N. Water Street was not abiding by the City of Milwaukee COVID Policy. The violations included; the restaurant was over the 50% capacity set by the city, people were sitting at tables which were closed to customers, customers were standing in line in close proximity to each other, Garbage from orders were sitting on tables and the floor with no employees cleaning or sanitizing the tables, and no staff members were keeping track of how many customers they were allowing in the store.

This report is written by PO Molly PLUMLEY, assigned to District One, Late Power Shift. On Saturday, July 11, 2020 while assigned to squad #1442 with PO Eric NORTHWOOD, we were assigned to the Code RED deployment, which is an initiative that is aimed at maintaining a sense of order in Milwaukee's nighttime entertainment districts. This initiative incorporates law enforcement, city agencies, local business

owners, and community members in a collaborative crime prevention task force. On Saturday we were assigned to the area of N. Water St. and E. Juneau Av.

At approximately 3:10 AM I observed large groups of customers going in and out of the QDOBA restaurant located at 1150 N. Water St. I observed people sitting at tables eating with signs on them stating not to sit there. I also observed customers standing in close proximity to each other while in line to place their order for food. I went inside of the business and asked the cashier if she knew what their capacity for the store was. The Cashier looked up at the posted Department of Neighborhood Services sign with the Capacity of 68 people listed on it. I observed approximately 40 customers and 4 employees working.

The City of Milwaukee Health Department has a plan for the safety of residents due to the COVID-19 outbreak, which businesses are ordered to follow. The safety plan states that business should only have take out and pick up orders allowed, and should limit their capacity to 50%. These rules are to help stop the spread of COVID-19.

I also observed garbage from orders sitting on tables unattended, garbage on the floor, and no staff members cleaning or sanitizing the tables that were being used. It should also be noted that there were no staff members keeping count of how many customers they were allowing in the store at one time.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 4/20/2021 at 10:10 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
