## **NOTICE OF PUBLIC HEARING**

PLEASE NOTE: This zoning change is only for the property that is within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because you are a property owner within 200 feet of the boundary, as required by State Statute.

## DEAR PROPERTY OWNER:

The Common Council has referred file number 201560 to the City Plan Commission (CPC) for recommendation. This file relates to the Tenth Amendment to the General Planned Development (GPD) known as Milwaukee Metro Center to allow a second freestanding sign on the Phase 5 site located at 11301 West Metro Auto Mall, on the south side of West Metro Auto Mall, east of U.S. Highway 41 and 45, in the 5th Aldermanic District.

A General Planned Development (GPD) was established in 1985 for the land generally located on the north and south sides of West Metro Auto Mall between U.S. Highway 41/45 West Fond du Lac Avenue, and serves as a master zoning document for the automobile dealerships located within the boundary, regulating items such as allowable uses and signage. The GPD limits the number of freestanding signs per site to one. Consistent with other automobile dealerships over the years, Heiser Toyota is requesting an amendment to the GPD zoning to allow a second freestanding monument sign on its site. The sign will be placed near the entrance along West Metro Auto Mall and will not exceed 18 feet in height. The existing monument sign on the west side of the site will remain. A companion zoning file (File No. 201561) approving the freestanding sign details and the allowance for two additional wall signs on the west façade of the building will also be considered at this meeting. **Please refer to the reverse side of this notice for map details.**
