PLEASE NOTE: This zoning change is only for the property that is within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because you are a property owner within 200 feet of the boundary, as required by State Statute.

DEAR PROPERTY OWNER:

The Common Council has referred file number 201567 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Two-Family Residential (RT4) to Detailed Planned Development (DPD) for a portion of the property located at 1255 North 20th Street and the 1st Amendment to the Detailed Planned Development known as McKinley School for 2001 West Vliet Street and the southern portion of 1255 North 20th Street, located on the south side of West Vliet Street, west of North 20th Street, in the 4th Aldermanic District.

A DPD was established in 2018 to allow for the redevelopment of the former McKinley School site into housing. As plans for the redevelopment have continued to be refined, the applicant, Gorman & Company, has identified the need for some changes to be made to the originally approved plans. The applicant is requesting an amendment to the DPD zoning to add a portion of 1255 North 20th Street to the DPD zoning as well change the previously approved townhouses on the north end of the site to single-family residences, and add additional parking to the south end of the school, among other changes. **Please refer to the reverse side of this notice for map details.**
