- \$25,000 budget for 2021
- Purchase of Narcan and Fentanyl strips
- Partner with St. Francis Hospital, St. Josephs Hospital (ED) and Milwaukee Jails

Fentanyl Strips Distributed: 1100 Additional Narcan acquisition ongoing, currently with MHD legal.

# MARQUETTE AND MCW COLLABORATION

- Project with John Mantsch of MCW and two Marquette students: Cassie Laibly and Jonathon Mendyk
- **Abstract**: Through a number of sources, Naloxone is now available without a prescription but these policies have not had an impact in lowering Opioid Overdose Deaths in Black and Hispanic Communities. We want to examine factors that decrease accessibility to Narcan through active community engagement and hopefully find solutions at individual and community levels that will increase accessibility to available resources.
- **Ideas**: Develop app for Narcan distribution, Narcan delivery
