PROCUREMENT REVIEW

PROCURING SECTION: Modernization & Development Services

Travaux issued a competitive, formal, advertised invitation for sealed bids for Carpentry (HT-4.1) for Remodeling at Holton Terrace. Purchase Order HOL12963 was awarded to Dodge and Sons Builders LLC, the lowest responsive and responsible bidder. The original award of \$211,000.00 was under the threshold of \$250,000.00 above which approval by the Travaux Board of Directors is required; therefore, award was not presented for board approval at the time.

During the course of the carpentry construction, additional work beyond the original scope was required, resulting in several change order items totaling \$59,000.00 not-to-exceed (see summary below). Two work items required to accommodate new kitchen countertops have already been authorized. Due to savings realized in the course of Travaux's overall Construction Manager as Constructor contract, funds were identified to expand the scope of carpentry work. As a result, work can be added in common areas, including new acoustical tile ceilings and cabinets. Bidding out the common areas work separately would delay start of work by three to four weeks and jeopardize meeting the placed-in-service requirement that all work be completed no later than the end of July 2021. Consequently, it is proposed to add the common areas work to Dodge and Sons Builders LLC's purchase order, as such work falls under the same work category. An allowance for future change order items, if any are necessary, is also proposed.

The new purchase order amount of \$270,0000.00 not-to-exceed now exceeds the aforementioned \$250,000 threshold; therefore, approval by the Travaux Inc. Board of Directors is required.

The Modernization & Development Services Section recommends executing the change order as described.
