There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/13/2020 at 1:52pm officers conducted a license premise check at Himalayan Oil, 3515 S 13th St. The officer was investigating a complaint from the Milwaukee Health Department that the business had gambling machines and people were gathered around them not social distancing. When the officer arrived she observed 6 entertainment machines that were unplugged and labeled with an out of order sign. The clerk stated they were advised by the health department to turn off the machines and they complied. The officer advised the clerk to obtain a PEP license for the machines before turning them back on.
- 2. On 12/20/2020 officers were dispatched to a Theft at Himalayan Oil, 3515 S 13th St. The officers interviewed the clerk who stated at 1:56am unknown subjects pulled a car up to a pallet of sidewalk salt, which was outside the front door. The subject loaded up about 30 bags and drove off. The subjects returned at 2:48am and took the remaining bags and drove off. The business was closed during this incident. The clerk was unable to provide a copy of the video at the time but stated he would make a copy and call the officers when it was ready.
- 3. On 03/04/2021 at 11:55am officers were dispatched to licensed premise check at Himalayan Oil, 3515 S 13th St. The officers observed 5 entertainment machines plugged in and operating. The officer checked the licenses and found that they did not have a PEP license. The officer advised the applicant to unplug and not operate them until the PEP license was obtained.

INITIAL INVESTIGATION

This report is written by PO Penny Monreal assigned to the License Investigation Unit. On Monday, April 13, 2020, at approximately 1:52pm, I conducted a license premise check at Himalayan Oil, located at 3515 S. 13th St. This was in regards to a complaint from the City of Milwaukee Health Department, regarding operating gambling machines inside the business, with people gathered around them, not complying with social distancing contrary to Governor EVERS Safer At Home Order, during COVID-19.

On arrival I found 6 "entertainment" machines in the rear of the stores, all of which were unplugged and a sign posted "out of order". I interviewed the employee on scene, Thulasi R. RAO A/F 09/29/87 regarding the same. RAO stated an employee from the City of Milwaukee Health Department was there earlier and advised them to unplug the machines due to social distancing, and that she complied. I further advised RAO that despite the social distancing issue, they also would require a Public Entertainment License for the machines. RAO stated she would advise her boss and they would not turn them back on until the Safer At Home order was lifted and the proper license was acquired.

This report is written by PO John NEUBURG, assigned to District 6, Early Shift.

On Tuesday, December 22nd, 2020 at 4:10PM, I (Squad 6290) was dispatched to a Theft at 3515 S 13th St (Himalayan Oil Gas Station), in the city and county of Milwaukee.

Upon arrival, I interviewed Sanil PANNACHAN, (w/m, 3-16-96) who works as a clerk at Himalayan Oil. PANNACHAN stated that on December 20th, 2020 at 1:56AM, a silver Chrysler 4dr with a Wisconsin Temp plate of B81-574, pulled into the parking lot and backed up towards the front door. Next to the door there was a pallet containing approximately sixty bags of rock salt (valued at \$8.99 each). The subject sitting behind the driver got out, followed by the driver and front passenger. The subjects opened the trunk and began loading thirty bags of rock salt into the trunk and back seat. After loading the thirty bags, the subjects got back into the vehicle and fled s/b on S 13th St. The pallet was located outside the store and no entry was made. The gas station was closed at this time as well.

The vehicle returned in a similar manner less than an hour later at 2:48AM. The subjects exited the vehicle and loaded the remaining bags of rock salt into the vehicle and then fled the location. PANNACHAN stated that there was originally one hundred bags of salt on the pallet, but during the time of the theft, there were only approximately sixty bags remaining. PANNACHAN estimated that thirty bags were taken during each incident. PANNACHAN described the subjects from the video as B/M, 20 - 30 years of age, dark clothing.

PANNACHAN was unable to get a copy of the video for me at this time. He stated that he would work on it tonight (PANNACHAN was the only employee in the store and was using his time to help me as well as the customers at the front counter). PANNACHAN stated that he would be able to have a copy by tomorrow and would call when it was ready.

This case is pending.

This report is being submitted by PO Xavier BENITEZ assigned to the License Investigation Unit. On Thursday March 4th, 2021 at 11:55 am PO Penny Monreal and I conducted a license premise check at 3515 S. 13th St. (Marathon gas station)

Upon arrival officers walked through the store, I observed 5 entrainment gambling machines plugged in and in operation at the rear of the store. Officers then spoke with the employee, Surakchha NMN Lalchan (m-w 06-10-81) who directed officers to the area where the business licenses were kept. The license board of the business was obscured behind merchandise. I observed that the business did not have a Public Entertainment License, for the 5 entrainment gambling machines on premise, and verified that a license was not obtained by the agent. Mr. Lalchan was able to contact the agent, Tilak B. Kc (m/u 12-21-67) via cell phone and PO Monreal spoke with the agent. PO Monreal advised the agent that the machines should be unplugged and not operated till the business has a Public Entertainment License granted from the city, also that the licenses of the business should be placed at a better location. PO Monreal further stated to the agent if the machines are found in operation before the license is granted the business could be cited regarding.



The hearing before the Licenses Committee will take place virtually on 5/11/2021 at 10:35 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
