Role of Consultant

- Support project plans and implementation efforts
- Provide technical assistance
- Conduct data analyses
- Submit required reports



Consultant Activities

- Support project plans and implementation efforts
 - Working with MPD's compliance team
 - Liaising with MPD Command Staff
 - Working with FPC Compliance and Auditing Staff
 - Liaising with FPC Executive Director
- Provide Technical Assistance
 - MPD
 - FPC
 - CAO



Data Processing

Quarterly Files from MPD

- 34 data files delivered 45 days after each calendar quarter
- Represents information from four separate databases

Merged Data for Analysis

- Unit of analysis is a person per police encounter
- We note and communicate to the City any difficulties in the merging process that we experience

Regular Reporting

- Six-month missing data analysis for compliance reports (March and September)
- Semiannual (IOARS) report (April and October)
- Annual data report (September)




Submit Required Reports

- September Annual report and data report publicly released (data from prior calendar year)
- October Semi-annual data report covering January-June prior year
- March Six-month report on non-compliant items from prior annual report
- April Semi-annual data report covering July-December prior year

Six-month Follow Up of Annual Report

Released March 23 annually

- Provides updated status and progress on items deemed non-compliant in annual report
- Outlines overall progress and challenges in six month period following latest annual report

Activities



- There is ongoing, proactive work at the City level and with CJI.
- City parties are collaborating with one another. The MPD, the FPC, and the CAO.
- The CAO and Plaintiffs' Counsel are in regular contact.

CJI Work Ahead

- Ongoing assessment of compliance with items deemed in-process or non-compliant
- Providing ongoing TA for Fire and Police Commission and MPD
 - Helping them understand, manage from, and communicate findings from the data
- Navigating staff turnover
- Delivering additional reports in accordance with the Settlement Agreement



City Work Ahead

- Continued assessment and review of training seeking opportunities to strengthen
- Utilize cursory reviews and audits at MPD to inform training and instruction/coaching to officers and supervisors
- Coach, counsel, and discipline as necessary to ensure officers and supervisors are living the conceit of the Settlement Agreement
- Establish robust system of audits at FPC
